## Notes to Financial Statements

December 31, 2024

### 1. DESCRIPTION OF PLAN

The following description of The Living Planet Inc., 401(k) Profit Sharing Plan, sponsored by The Living Planet, Inc. dba Loveland Living Planet Aquarium (the “Plan Sponsor”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan’s original effective date was January 1, 2010. The plan is a defined contribution 401(k) salary reduction and profit-sharing plan covering all employees who have completed three months of service and have attained twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Trustees determine the appropriateness of the Plan’s investment offerings and monitor’s investment performance.

#### Contributions

Each year, participants may contribute, through salary reduction, the maximum allowable under the law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of funds held in trust by Ascensus Trust Company.

For the year ended December 31, 2024, the Plan Sponsor contributed a safe harbor matching contribution equal to 100% of employee contributions up to a maximum of 3% of the employee’s eligible compensation plus 50% of employee contributions over 3% and up to a maximum of 5% of the employee’s eligible compensation. The Plan Sponsor’s discretionary non-safe harbor match as a percentage of the employee contribution is determined on an annual basis by the employer. Each year, the Plan Sponsor’s Board of Directors determines the amount, if any, of the discretionary profit-sharing contribution to the Plan. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Plan Sponsor’s contribution, and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting and Forfeitures

Participants are immediately vested in their voluntary and employer safe harbor match contributions plus actual earnings thereon. Participants are vested in their employer non-safe harbor matching contributions and employer profit sharing contributions over a four-year graded vesting schedule. During the year ended December 31, 2024, no forfeiture monies were used to offset employer contributions. At December 31, 2024, the balance of forfeited account monies not used by the Plan Sponsor was \$1,511.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The only partial withdrawals or installments permitted are for required minimum distributions under Code Section 401(a)(9).

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Date of Management's Review

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued. From their review, management has determined that there were no significant recognizable or unrecognizable subsequent events that were not properly disclosed.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and trust company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are also included in net appreciation or depreciation of fair value of investments.

Reclassifications

Certain items from December 31, 2023 have been reclassified to conform to the December 31, 2024 presentation.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> <li>• quoted prices for similar assets or liabilities in active markets;</li> <li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• inputs other than quoted prices that are observable for the asset or liability;</li> <li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means</li> </ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Level 1

*Registered investment companies:* Registered investment company funds represent mutual funds and ETFs, the fair value of which is based on observable inputs that reflect quoted market prices for identical assets in active markets.

**4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**5. TAX STATUS**

The Plan has adopted a volume submitter type plan which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the volume submitter plan was acceptable under section 401 of the Internal Revenue Code. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

If the Plan has uncertain tax positions, they are evaluated by management and a loss contingency is recognized when it is probable that a liability has been incurred and the amount of the loss can be reasonably estimated. The amount recognized is subject to estimate and management judgment and the amount ultimately sustained for an uncertain tax position could differ from the amount recognized. As of October 6, 2025, management did not identify any uncertain tax positions. The tax years previous to 2021 are closed to examination by the Internal Revenue Service.

**6. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Ascensus Trust Company at December 31, 2024 and December 31, 2023.

**7. EMPLOYER CONTRIBUTIONS**

Cash contributions of \$180,672 were required and made by the employer for the year ended December 31, 2024. The employer was current on contributions as of December 31, 2024.

**8. ADMINISTRATIVE COSTS**

The Plan and the Plan Sponsor pay the administrative costs. Certain administrative functions are performed by employees of the Plan Sponsor. Such employees receive no compensation from the Plan. Administrative costs paid by the Plan for the year ended December 31, 2024 were \$585. In addition, \$37,085 of administrative costs were paid by the Plan Sponsor for the year ended December 31, 2024.

**9. RELATED PARTY TRANSACTIONS**

Certain Plan investments were held in trust with Ascensus Trust Company while Ascensus Trust Company provided management and record keeping services for this contract. Ascensus Trust Company was the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for Ascensus Trust Company management and recordkeeping services totaled \$585 for the year ended December 31, 2024. Fees incurred by the plan for investment management services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor pays directly any other fees related to the plan's operations.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
