### Report on the Audit of the Financial Statements

AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

**1. DESCRIPTION OF THE PLAN**

The following description of the Floyd Healthcare Management, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan Sponsor is Floyd Healthcare Management, Inc.

The Plan is a defined contribution plan covering all employees who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 85% of their annual eligible compensation as pre-tax and/or Roth contributions, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). In addition, the Plan allows participants to make voluntary after-tax contributions up to 100% of compensation.

The Plan provides a safe harbor match to participants who have completed one year of service equal to 100% of each participant's deferrals up to 3% and 50% of deferrals between 4% and 5% of a participant's annual eligible compensation. The Sponsor may also make discretionary contributions to participants who meet certain eligibility requirements. The Sponsor may also make non-elective contributions to participants who meet certain eligibility requirements up to 1% of compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, as well as allocations of the Sponsor's contributions, if any, and investment results. Allocation of contributions is based on participant compensation. Allocation of investment results is based on the participant's account balance in the investment options selected by the participant. Self-directed brokerage accounts are adjusted for their actual earnings. A participant's account may also be charged for the participant's share of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is equal to the balance in the participant's account.

**Investment Options**

Participants direct the investment of the account balances into various investment options offered by the Plan. The Plan offers various mutual fund options to participants. Participants have the opportunity to invest their contributions in participant-selected investments through a self-directed brokerage account. Participant-selected investments are limited to securities and property authorized under rules established by the Plan.

## **Vesting**

Participants are vested immediately in their contributions and Sponsor contributions plus actual earnings thereon.

## **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% which is commensurate with local prevailing rates as determined periodically by the Plan Administrator. Principal and interest are paid by participants in equal payments no less frequently than quarterly.

## **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments over a period of years. In-service distributions may be made to a participant, who has not separated from service, provided the participant has attained age 59½. Participants may also make withdrawals under certain "hardship" conditions as defined by Plan provisions and subject to the 10% early withdrawal penalty required by the IRS.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes and supplemental schedule. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 3 for discussion of valuation methodology.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain other expenses are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Subsequent Events**

For the year ended December 31, 2024, the Sponsor has evaluated subsequent events for potential recognition and disclosure through October 1, 2025, the date the financial statements were available to be issued.

## **3. FAIR VALUE**

The Plan's investments are reported at fair value and the assets are categorized based upon whether the inputs used to determine fair values are observable or unobservable. Observable inputs are inputs that are based on market data obtained from sources independent of the reporting entity. Unobservable inputs are inputs that reflect the reporting entity's own assumption about pricing the asset or liability, based on the best information available under the circumstances.

The fair value of all assets and liabilities recognized or disclosed at fair value is classified based on the lowest level of significant inputs. Assets and liabilities that are measured at fair value are disclosed and classified in one of three categories. Category inputs are defined as follows:

*Level 1* - Quoted prices (unadjusted) in active markets for identical assets on the reporting date.

*Level 2* - Inputs other than quoted market prices included in Level 1 that are observable for the asset, either directly or indirectly. If the asset has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset.

*Level 3* - Inputs that are unobservable for the asset for which there is little or no market data.

The following section describes the valuation methodologies the Plan uses to measure financial assets and liabilities at fair value:

**Self-directed investment:** Investments primarily consist of mutual funds which are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net

asset value (NAV) and to transact at that price. Investments also include common stock and money market funds. Money market funds are valued at NAV based on observable activity.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that does not indicate net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Life Insurance Company (TLIC). TLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$3,797,773 and \$4,120,749, respectively. The crediting interest rate is based on the formula agreed upon with the issuer but may not be less than the minimum guaranteed interest rate of 0.00%. Such interest rates are reviewed on a periodic basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation or (d) a material amendment to the agreement without the consent of the issuer.

## 5. INFORMATION CERTIFIED BY THE TRUSTEES

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustees, State Street Bank and Trust Company ("State Street") and TLIC, as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## 6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan did not enter into any non-exempt transactions with parties known to be related or parties-in-interest.

## 7. TAX STATUS

The IRS has determined and informed the Plan's trustee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated and amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by taxing authorities. It is the opinion of the Company that the Plan has no uncertain tax positions that would be subject to change upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax filings are generally subject to examination for three years after they are filed.

## 8. PLAN TERMINATION

Although it has not expressed any such intent, the Sponsor has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 9. RISKS AND UNCERTAINTIES

The Plan invests in various investments that are exposed to several risks, such as interest rate, market risks and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term. The changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
