INDEPENDENT AUDITOR'S REPORT

Mullen & Filippi 401(k) Profit Sharing Plan Sacramento, California

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Mullen & Filippi 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Mullen & Filippi 401(k) Profit Sharing Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 of the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Mullen & Filippi 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan was established by Mullen & Filippi, LLP (the “Employer”) on January 1, 1989, and is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Eligible employees of the Employer became eligible to make salary deferrals in the Plan on the first day of the month coincident with or next following the completion of two months of service. Eligible employees become eligible to receive employer match contributions and employer profit-sharing in the Plan on the first payroll coincident or next following the completion of one year of service.

Contributions – The Plan provides salary deferrals for eligible employees for amounts not to exceed the limit set by law. The Employer provides a 100% matching contribution for each eligible participant's salary deferrals, limited to 3% of the participant's eligible compensation, if they are employed on the last day of the year. In addition, the Employer may provide a discretionary profit sharing contribution to the Plan. No profit sharing contribution was provided during the year ended December 31, 2024.

Vesting – Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants hired before January 1, 2023 are immediately vested in their employer matching contributions plus earnings thereon. Vesting in the discretionary profit sharing contributions, and employer matching contributions for employees hired on or after January 1, 2023, is progressive, based upon length of service. A participant is 100% vested after six years of credited service or upon reaching normal retirement age. Forfeitures of contributions by participants may be used to reduce subsequent employer contributions or pay Plan administrative expenses. There were no forfeitures as of December 31, 2024 and 2023.

Payment of benefits – Distributions from the Plan are available to participants or their beneficiaries at retirement, upon termination of employment, or as a result of total and permanent disability, or death.

Participant accounts – Each participant's account is credited with the participant's contributions and an allocation of the Plan's earnings. Allocations are based on participant's account balances. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Notes receivable from participants – The Plan provides a provision that allows participants to borrow 50% of their vested account balance, up to a maximum of \$50,000. The loans are secured by the participants' vested account balances and bear interest at the prevailing interest rates. The principal balance plus interest is repaid through employee payroll deductions or deducted from partners' draws within 20 years for loans used for the purchase of primary residence and five years for other loans.

Administrative expenses – Under terms of the Plan agreement, administrative expenses are paid by the Plan unless paid by the Employer.

Party-in-Interest Transactions – Certain Plan investments are managed by John Hancock Trust Company LLC, the Trustee, and therefore, transactions with such investments qualify as parties-in-interest. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of parties-in-interest transactions under ERISA.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions – Employee contributions are recorded in the period payroll deductions are made. Employer matching contributions are calculated and recorded as of December 31.

Payment of benefits – Benefits are recorded when paid.

Notes receivable from participants – Notes receivable from participants are valued at the outstanding loan balance, plus accrued unpaid interest, which approximates fair market value. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Interest on notes receivable from participants – Interest on participant loans is recognized in the period it is assessed.

Income taxes – The Plan obtained its latest determination letter on September 8, 2015, in which the Internal Revenue Service stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Use of estimates – The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated for recognition and disclosure through September 24, 2025, the date the financial statements were available to be issued. Management concluded that no material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

3. BENEFIT RESPONSIVE INVESTMENT CONTRACT

The New York Life Anchor Account III and the New York Life Anchor Account IV are pooled separate group annuity products issued by the Trustee that guarantees principal and accumulated interest. The minimum crediting rate is zero. Each participant's account accrues interest daily, based on the investment experience of the underlying separate account minus prorated fees. Each participant's accrued interest is determined by the participant's account balance throughout the month, and is credited to participant accounts at the end of each month.

Participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is effected directly between the plan sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, this contract is considered benefit responsive.

The New York Life Anchor Account III and the New York Life Anchor Account IV contract value reported in the statements of net assets available for benefits was \$1,195,103 and \$1,166,286 at December 31, 2024 and 2023, respectively.

4. INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual funds are traded.

Collective Trust funds: Valued based on the plan's interest in the trust's underlying investments. The trustee trades these investments in active markets, and they are valued daily.

6. PLAN TERMINATION

Although it has not expressed the intent to do so, the Employer has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and benefit obligations.
