**Note 1 - Description of Plan**

The following brief description of First Interstate BancSystem, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of First Interstate BancSystem, Inc. (Plan Sponsor), and its member banks and affiliates (collectively, the Company) as follows:

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Benefits Committee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Eligibility**

All employees are eligible to participate in the Plan.

**Entry Date**

Employees may immediately enter the Plan on the first day they satisfy the Plan's eligibility requirements.

**Contributions**

Each year, participants may contribute up to 100% of their pre-tax annual compensation as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also make voluntary, non-deductible, after-tax contributions up to 20% of compensation. In addition, participants may contribute amounts representing distributions from other qualified plans (rollover). The Company will make a matching contribution of 100% of the first 6% of annual compensation that a participant contributes to the Plan. The Company may make additional matching contributions; however, none were made for the year ended December 31, 2024.

The Plan allows an annual profit-sharing contribution as determined by the Company's board of directors by appropriate resolution. A participant must work 1,000 hours of service and be employed at the end of the year, unless these requirements aren't met due to death, disability, or retirement, in order to share in the allocation of the profit-sharing contribution. There was no profit-sharing contribution for the year ended December 31, 2024.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees and active participants without a deferral election on file are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation with an automatic escalation feature to annually increase the deferral by 1% to 3%, as elected by the participant. Auto escalation will default to 1% annually if there is no election made. Automatically enrolled participants have their contributions invested in a designated qualified default investment fund until changed by the participant.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution, administrative expenses incurred, and allocations of the Company's profit-sharing contributions and Plan earnings. Allocations are based on participant's compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions and any rollover contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portions of their account is based on the participant's date of hire. Employees hired in fiscal year 2001 or later are subject to a vesting schedule based on years of service. These participants are 100% vested in the Company's matching and profit-sharing contributions after two years of credited service.

Participants in terminated plans of banks acquired by the Plan Sponsor for which the assets of the prior plans were transferred into the Plan and the participants were active employees at the time of the acquisition are generally 100% vested in their transferred account balances. Participants in terminated plans of banks acquired by the Plan Sponsor for which the assets of the prior plans were transferred into the Plan and the participants were not active employees at the time of the acquisition generally retained the vesting schedule from their prior plan.

**Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$803,143 and \$430,810, respectively. These accounts will be used to reduce future Company contributions and/or offset Plan expenses. Forfeitures totaling approximately \$401,139 were used to reduce Company during the year ended December 31, 2024.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance, or \$50,000, reduced by the excess, if any, of the participant's highest outstanding loan balance during the previous year, over the participant's outstanding loan balance on the date the loan is made. The loans are secured by the balance in the participant's account and bear interest at prime plus 1% at the time funds are borrowed. Principal and interest is paid ratably through bi-weekly payroll deductions for active employees over a period not to exceed 5 years, unless the proceeds of the loan were used to acquire the participant's principal residence, in which case the loan terms can range up to 15 years. However, loans transferred into the Plan as a result of the merger of the Great Western Bancorp, Inc. 401(k) Contribution Plan into the Plan (see Note 10) can have loan terms up to 30 years for loans used to acquire a participant's principal residence. A participant may have no more than two outstanding loans at any one time.

**Payments of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or installments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. During 2024, the SECURE Act 2.0 raised the \$5,000 deferral limit to \$7,000.

Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document. An in-service withdrawal may also be made at any time from a participant's rollover contribution account. Additionally, an in-service withdrawal may be made from a participant's vested employer contribution account if the employer contributions have been maintained in the participant's account for at least 24 months or the participant has at least 60 months of participation.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on the Form 5500.

### **Contributions**

Participant contributions and the related Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivables are reclassified as distributions based upon the terms of the Plan document.

### **Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, that are paid by the Plan, are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

## Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds – Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

First Interstate BancSystem, Inc. common stock – Valued at the closing price on the active market on which the individual security is traded.

**Note 4 - Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (trustee of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by FMR LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments consist of common stock of First Interstate BancSystem, Inc., historically by participant direction. Effective March 24, 2010, participants were no longer permitted to purchase this common stock, although they may continue to hold this investment in their accounts. In addition, certain Plan investments consist of mutual funds managed by Fidelity Management Trust Company, the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Reconciliation of Financial Statements to Form 5500**

**Note 10 - Subsequent Events**

Portions of the SECURE Act 2.0 (the Act) were required to be implemented for the Plan years ending on or after January 1, 2025. The most significant change resulting from the Act affecting the Plan was as follows:

- The Act increases the catch-up limits to the greater of \$10,000 or 50 percent more than the regular catch-up amount in 2025 for individuals who have attained age 60 to 63. The increased amounts are indexed for inflation after 2025.

The Plan Sponsor has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.
