### **Opinion**

Group Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Basis for Opinion**

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### Note 1 – Description of the Plan

Chandler (U.S.A.), Inc. and subsidiaries (the Company) sponsors the Chandler (U.S.A.), Inc. Group Benefits Plan (the Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan provides health and other benefits covering substantially all employees of the Company and covered dependents. The Chandler (U.S.A.), Inc. Group Medical Plan Trust (the Trust) is the funding vehicle of the Plan. The Plan and Trust are designed to be a voluntary employees' beneficiary association as described in Section 501(c)(9) of the Internal Revenue Code (the Code). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Eligibility

Full-time employees of the Company are generally eligible for coverage under the Plan after 30 days. Participants may enroll in the Plan on the first day of the month after 30 days of employment, or during the open enrollment period beginning on the 15<sup>th</sup> of November and continuing through the 15<sup>th</sup> of December each calendar year. Full-time employees who are under age 70 and have three months of continuous service are eligible for long-term disability.

##### Cash

The Plan maintains its cash in a bank deposit account which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such account. Plan management believes it is not exposed to any significant credit risk on cash.

##### Contributions

The Company and participating employees contribute amounts to the Trust to pay certain benefits provided by the Plan. The participant is required to make contributions to participate in the health benefit offered by the Plan. The Company also contributes to the health portion of the Plan, as well as pays the short- and long-term disability, life, and accidental death and dismemberment portions of the Plan.

Employees participating in the health portion of the Plan make contributions on a semi-monthly basis. These participant contributions are made through payroll deductions of predetermined amounts, which are based on estimated costs calculated by a claims administrator. The Company has agreed to supplement participant contributions to the Plan to provide assets from which to pay insurance premiums and health benefits up to the stop-loss coverage amount.

##### Benefits

The Plan provides health benefits (medical and prescription drugs), life insurance, short- and long-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation

of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

*Insured Benefits.* The Plan offers one preferred provider organization that participants can choose. The Plan fully insures the life insurance benefits (basic and dependent), accidental death and dismemberment benefits (basic and dependent), and long-term disability benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company by the Company. Premiums for all other insured benefits are paid from the assets of the Trust.

Eligible participants receive life insurance and accidental death and dismemberment coverage ranging from \$10,000 to \$50,000 based upon their position within the Company, as defined by the respective insurance policy. Eligible participants who become totally disabled can receive monthly payments in the amount of 60% of the participant's monthly rate of basic earnings, up to a maximum monthly benefit of \$7,500. This monthly benefit is payable by the Plan for up to five and one-half months. At this point, the long-term disability coverage provided by an outside carrier becomes effective and pays the monthly benefits as long as the participant is disabled, subject to limitations defined by the respective insurance policy.

*Stop-Loss Coverage.* The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). All expenses incurred by a participant or dependent in excess of \$200,000 are covered by the stop-loss insurance except in certain instances where individual coverage risks result in a higher stop-loss limit established by the insurance carrier.

*Self-Insured Benefits.* Medical, prescription, and short-term disability benefits are self-insured. The claims for self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of accounting

The accompanying financial statements have been prepared on the accrual cash basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of estimates

The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Payment of benefits

Premiums paid by either the Company or the Trust are recorded as insurance premiums paid for welfare benefits in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor and funded by the Company. Short-term disability payments are processed through the Company's payroll system and paid from the general assets of the Company. These payments are recorded as welfare benefits paid in the accompanying statement of changes in net assets available for benefits.

#### Stop-loss

Premiums for stop-loss insurance are included in insurance premiums paid for welfare benefits in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2024, there are no stop-loss refunds that have been netted with welfare benefits paid in the accompanying statement of changes in net assets available for benefits

#### Refunds

Refunds due from the Plan's PBM are recorded as receivable when earned. Rebates due as of December 31, 2024 and 2023, have been reported as a receivable of \$1,409 and \$1,652, respectively, with the offset being netted against welfare benefits paid. Pharmacy rebates totaling \$5,156 were netted with welfare benefits paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### Subsequent events

The Plan administrator has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

### **Note 3 – Plan Administration**

Under the terms of the Trust agreement, the trustees manage the Plan assets on behalf of the Plan and have been granted discretionary authority concerning Plan assets. All Plan assets are maintained in custodial bank accounts.

### **Note 4 – Benefit Obligations**

Plan benefit obligations as of December 31, 2024 and 2023, include claims incurred by participants, but not reported at that date which are estimated by Plan management. Claims incurred but not yet reported are estimated based on historical payment levels and lag periods between the time a claim is incurred and payment is made.

The changes in the Plan's benefit obligations for the year ended December 31, 2024, are summarized in the following table:

## **Note 5 – Related Party and Party-in-Interest Transactions**

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Certain administrative expenses, totaling approximately \$15,750, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. As described in Note 1, the Plan has several arrangements with service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported in the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

## **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and the contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the participants.

## **Note 7 – Tax Status**

The Trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated July 29, 1991, stating that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Code. However, as a result of the Plan's funding policy, from time to time the Trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. Although the Plan has been amended since receiving the exemption letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8 – Risks and Uncertainties**

Plan benefit obligations are reported based on certain assumptions pertaining to claims experience and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
