Note 1 Description of Plan

The following description of the Martin's Bulk Milk Service, Inc. Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective April 1, 1995 sponsored by Martin's Bulk Milk Service, Inc and Martin's Warehousing, LLC. The Plan has been amended throughout the years to comply with tax legislation and most recently restated effective August 26, 2021. The Plan excludes nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Administrators are responsible for the oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of Martin's Bulk Milk Service, Inc. (the Company) who have completed at least 90 days of service, as defined in the Plan, are eligible to begin participating on the first day of each month coinciding with or next following date requirements are met. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution equal to 100% of employee contributions up to 4% of participants' compensation. For the years ended December 31, 2024 and 2023, the Company matching contribution was \$373,673 and \$366,830, respectively. The Company may, at its discretion, elect to make additional contributions to the Plan. No discretionary contributions were made for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Account

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes have been adopted in accordance with applicable law and IRS guidance.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the Plan document. There were forfeitures in the amount of \$624 and \$615 for the years ended December 31, 2024 and 2023, respectively.

Note 2 Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Also, the Plan has a fixed annuity related to a key guaranteed portfolio fund, which is measured at contract value.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 3.25%-8.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants had a balance of \$322,280 and \$268,485 at December 31, 2024 and 2023, respectively.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 Fair Value Measurement

Accounting standards provide the framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels are defined as follows:

- Level 1 – Quoted prices in active markets for identical assets.
- Level 2 – Observable inputs other than Level 1 quoted prices, including quoted prices for similar assets, and inputs that are directly or indirectly observable.
- Level 3 – Unobservable inputs significant to the fair value measurement.

Valuation Methodologies

- Mutual Funds – Valued at daily quoted market prices. Classified as Level 1.
- Collective Investment Trusts (CITs) – Valued at net asset value (NAV) as provided by the trustee. Investments measured at NAV are not categorized in the fair value hierarchy but are presented separately to reconcile to total investments.
- Fixed Annuity Contract – Key Guaranteed Portfolio Fund (“KGPF”), a general account product issued by Empower Annuity Insurance Company of America (EAICA). Reported at contract value, which approximates fair value. Classified as Level 2.

Crediting Rate: Interest is credited daily and may reset quarterly. The annualized net rate was 1.45% at December 2024 and 1.30% at December 2023.

Liquidity: Participant withdrawals and transfers are permitted at contract value with no penalties. However, EAICA prohibits the simultaneous offering of competing investment options (e.g., money market or stable value funds) without approval.

Employer-Initiated Events: Plan-level events such as termination, layoffs, or mergers may trigger restrictions, including deferral of up to 12 months or a market value adjustment on withdrawals.

Underlying Investments: EAICA's general account supporting KGPF holds a diversified fixed-income portfolio with maturities of 3–7 years, primarily investment-grade bonds.

Risks: Risks include the creditworthiness of EAICA and interest rate risk in the underlying portfolio.

At both December 31, 2024 and 2023, contract value equaled fair value, and no adjustments were required.

Note 4 Information Prepared and Certified by Trustee

Certain information related to the investments in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained and derived from the information furnished to the plan administrator and certified as complete by Empower Trust Company, LLC, the custodian of the Plan.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 6 Tax Status

The Company adopted a nonstandard prototype document with an IRS opinion letter dated November 14, 2022, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan remains open to examination through the applicable statutory periods.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 Parties in Interest Transactions

Certain Plan investments for the years ended December 31, 2024 and 2023 were managed by Empower Trust Company LLC. Empower Trust Company LLC is the trustee as defined by the Plan. These investment transactions qualify as exempt party-in-interest transactions.

Note 9 Reconciliation of Financial Statements to Form 5500

For the years ended December 31, 2024 and 2023, there were no differences between the audited financial statements and the Form 5500.
