## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of  
Hunter Buildings 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Hunter Buildings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

The Plan, adopted effective January 1, 2008, with its latest amendment and restatement effective January 1, 2024, is a defined contribution and profit sharing plan covering all employees of Hunter Buildings, LLC and affiliates (the "Company") except union employees whose employment is governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Voya Retirement Insurance and Annuity Company (the "Custodian") is the custodian and recordkeeper for the Plan.

##### **Eligibility**

Substantially all employees who are at least 18 years old and have completed 90 days of service are eligible to participate in the Plan on the first day of the month coinciding with or following their satisfaction of the eligibility requirements.

##### **Contributions**

The Plan is a defined contribution plan to which participants may make pre-tax and after-tax contributions to the Plan up to 90% of their compensation. Effective January 1, 2024, upon meeting the eligibility requirements, new participants are automatically enrolled in the Plan at 3% of the employee's eligible compensation, as defined. Employees may elect a different percentage or elect to not participate in the Plan by notifying the Company or Trustee. The contributions are not to exceed the limits set by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as defined by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution and/or a discretionary profit sharing contribution. For the 2024 Plan year, the Company did not make any such contributions.

In order to maintain "safe harbor" status, the Company makes safe harbor matching contributions representing 100% of salary deferrals up to 3% of a participant's eligible compensation, plus 50% of salary deferrals greater than 3% but not to exceed 5% of the participant's eligible compensation under the Plan.

##### **Participant Accounts**

Each participant's account is credited with or adjusted by the participant's contributions, an allocation of the Company's contribution, Plan earnings/losses, and administrative fees. Allocations are based on participant compensation and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the participant's highest outstanding note balance during the prior twelve-month period. Additionally, a participant may not have more than one note receivable outstanding at any time. Note terms are not to exceed five years, unless the note is used to acquire a principal residence, in which case, the Plan administrator may permit a longer repayment term. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest.

#### **Payment of Benefits**

Participants are eligible for distributions of their vested account balances upon the event of death, disability, termination of employment, upon the attainment of age 59½, or for financial hardship, as allowed by the IRC for certain circumstances. Upon termination or retirement, withdrawals may be made in the form of a lump-sum distribution or installments, and equal to their vested account balance as of the valuation date on or following their termination of employment or normal retirement date. Upon termination of service, if the participant's account balance is less than \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. Any taxable distribution paid directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

#### **Vesting**

Participants are 100% vested at all times in their voluntary contributions and employer safe harbor non-elective contributions. Participants vest based on a five-year graded vesting schedule for discretionary employer matching and discretionary profit sharing contributions. Participants or their beneficiaries shall be immediately vested in their accounts upon death, retirement, or disability.

#### **Forfeitures**

Upon termination of service, a participant's vested account balance will be distributed to the participant or directly rolled into other qualified plans depending on the status of the original contribution and participant direction. The unvested amount is forfeited and maintained in an account by the Custodian. Available forfeitures are used to offset employer contributions or to pay administrative expenses.

#### **Administrative Expenses**

All administrative expenses incurred by the Plan are paid by the Company except for certain transactions-related fees and commissions.

## **2. SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments in pooled separate accounts are reported at fair value while the fixed account is a fully benefit-responsive insurance contract with an insurance company which is reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Upon the sale of an investment, the current year unrealized appreciation or depreciation is adjusted for unrealized gains and losses recognized in prior years. Unrealized appreciation or depreciation and realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statements of changes in net assets available for benefits.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions upon liquidation of their account balance. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Distributions to Participants**

Distributions to participants are recorded when paid.

#### **Subsequent Events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

### **3. CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by the Custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **4. FAIR VALUE MEASUREMENTS**

The Plan uses a three-level hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

*Level 1* - quoted prices in active markets for identical assets or liabilities;

*Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or

*Level 3* - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments in pooled separate accounts are valued daily at the net asset value of the units held by the Plan based on the quoted market value of the underlying funds. Fair value of shares of the underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund. All investments can be redeemed daily and have no unfunded commitments. Distributions from the underlying funds are reinvested in additional shares on that date. The pooled separate accounts are measured at net asset value per share (or its equivalent) as a practical expedient and have not been classified in the fair value hierarchy.

**5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a fully benefit-responsive investment contract (the "Contract") with the Custodian. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

The Contract can be redeemed daily unless the amounts transferred from the Contract are being transferred to a competing contract for a period of 90 calendar days beginning on the date such an amount is transferred from the account or if a partial transfer has occurred within the last 90 calendar days. Participants may be subject to a surrender charge or market value adjustment upon early liquidation of their investment in the Contract.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the specified minimum and is guaranteed for the life of the Contract. The declared interest rate credited during a contract year shall not be less than the guaranteed rate for such contract year.

Certain events might limit the ability of the Plan to transact at contract value with the Custodian. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the Custodian.

**6. TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and was tax-exempt as of December 31, 2024 and 2023.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

**8. PLAN TERMINATION**

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their accounts and no further contributions will be made to the Plan.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
