## **Report of Independent Auditors**

To the Participants and Trustees of  
Stagehands Local Two Health and Welfare Plan

### ***Opinion***

We have audited the financial statements of Stagehands Local Two Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Stagehands Local Two Health and Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of financial statements; and
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Notes to Financial Statements

December 31, 2024 and 2023

#### **Note 1. Description of the Plan**

Stagehands Local Two Health and Welfare Plan (the Plan) was established pursuant to collective bargaining between the union and various employers. The Plan is a multiemployer welfare plan and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan provides health benefits (hospital, surgical, major medical, dental and prescription drug) for eligible participants, on a self-funded basis except for life insurance and Medicare eligible retirees, which are provided under an insurance program.

Benefits are provided on a six-month basis. If contributions for the six months ended June 30 are sufficient to qualify a participant for coverage, coverage commences on the following October 1 and continues until the following March 31. Contributions for the six months ended December 31 determine coverage for the following April 1 through September 30. If an eligible participant has more than the required amount contributed on their behalf during any preceding six-month period, the amount contributed in excess is credited toward the amounts needed to maintain coverage, if any, only during the following six-month coverage period.

If a Plan participant becomes disabled, which causes employer contributions to be insufficient to cover required minimums, the Plan will, at its discretion, provide health benefits at no charge to the disabled participant until such participant reaches age 65 or is entitled to Medicare, whichever comes first. Retired participants are able to continue eligibility through monthly payments to the Plan.

The Plan's eligibility rules may cease coverage for any withdrawing employer's participants if the employer continues operations after the withdrawal date. A participant is also able to self-pay to maintain coverage.

Participants should refer to the summary plan description for more complete information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investments** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Contributions Receivable** - Employer contributions due but not received at year end are recorded as contributions receivable. Employer contribution owed as a result of a payroll compliance audit are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

**Contributions Paid in Advance** - Certain participants make contributions to receive benefits under the Plan. Contributions received in advance of the corresponding eligibility period are recognized as deferred revenue.

**Benefit Obligations** - Benefit obligations are estimated by the Plan's consulting actuary in accordance with accepted actuarial principles and are based on claims experience, Plan benefits and other data as considered necessary.

The obligation for accumulated eligibility credits represents an estimate of claims which will be due the following year for participants who had earned eligibility prior to December 31 to maintain coverage after year end.

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits (net of self-contribution amounts) that are attributed to participant service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated participants and their beneficiaries and dependents, and active participants and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

**Stop-Loss Insurance** - The Plan maintains a stop-loss arrangement in an effort to limit its exposure for self-insured benefits. Under the terms of the contract, individual participant claims incurred within the contract year in excess of \$225,000 and \$215,000, for the years ended December 31, 2024 and 2023, respectively, are reimbursed to the Plan.

## **Note 2. Summary of Significant Accounting Policies (continued)**

**Prescription Drug Rebates** - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. Health claims paid are shown net of rebates of \$205,872 and \$212,174 for the years ended December 31, 2024 and 2023, respectively.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on wages earned in covered employment and the contribution rates set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose describe in Note 1 within a jurisdiction primarily located in the Chicagoland area.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Subsequent Events** - Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Concentration of Cash**

The Plan maintains its cash balances with financial institutions deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000 per financial institution. Although balances may at times exceed insured limits, the Plan believes its credit risk to be minimal.

## **Note 4. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following describes the three levels of the fair value hierarchy.

#### **Note 4. Fair Value Measurements (continued)**

##### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

All of the Plan's investments are classified within Level 1 of the fair value hierarchy.

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value per share on the last business day of each period presented.

The short-term investment fund represents shares held in a mutual fund.

#### **Note 5. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan.

#### **Note 6. Related Party Transactions**

The Plan shares facilities, equipment and staff with Theatrical Stage Employees Union Local Two (the Union), and the related retirement plan, annuity plan and apprentice training fund. All salaries, related employee expenses and occupancy costs are initially paid by the Union. The Plan's share of these expenses was \$108,090 and \$93,489 for the years ended December 31, 2024 and 2023, respectively. The Union also pays for certain direct expenses of the Plan and allocates a portion of its computer network maintenance costs to the Plan. The Plan reimbursed the Union \$4,780 in 2024 and \$3,721 in 2023 for its share of these expenses. At December 31, 2024 and 2023, the Plan owed the Union \$112,870 and \$97,210 respectively, related to these expenses.

**Note 7. Tax Status**

The Internal Revenue Service has advised that the trust established under the Plan is exempt under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Funding Policy**

Participating employers contribute such amounts as required by collective bargaining agreements. During the years ended December 31, 2024 and 2023, contributions were paid at rates equal to a percentage of gross wages ranging from 4% to 17%, with the predominate rate being 13%.

Participant contributions are allowed for participants who work less than the required number of hours to maintain eligibility, and to provide COBRA benefits. COBRA contribution rates are determined annually based on claims experience. COBRA monthly rates for the years ended December 31, 2024 and 2023 ranged from \$809 to \$2,239 depending on the participant's coverage option.

Eligible retired participants are allowed to self-pay monthly contributions for benefit coverage. Retiree self-payment monthly rates for the years ended December 31, 2024 and 2023 ranged from \$172 to \$895 depending on the retiree's coverage option.

**Note 9. Postretirement Benefits**

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest), contributions remitted by retirees, and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The healthcare cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rate increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$3,946,000 and \$3,463,000 respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Changes in actuarial assumptions for the year ended December 31, 2024 decreased overall obligations by \$2,183,000 as a result of changes in the covered population, claims cost being less than expected, self-payment trend rates, and increasing the discount rate from 4.65% to 5.40%

Changes in actuarial assumptions for the year ended December 31, 2023 decreased overall obligations by \$6,982,000 as a result of updating the medical, drug and self-payment trend rates, offset by decreasing the discount rate from 4.70% to 4.65%.

The cost of the postretirement benefit obligations is shared by the Plan's participating employers and retirees. The cost of the postretirement benefits is estimated the Plan's consulting actuary. The Plan's Trustees will periodically adjust the portion to be paid by the participants. Projected retiree contributions are 52% and 54% of the estimated cost of providing their postretirement benefits at December 31, 2024 and 2023, respectively.

**Note 9. Postretirement Benefits (continued)**

The Plan's excess of benefit obligation over net assets relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current bargaining agreement. It is expected that the deficiency will be funded through plan modifications and future increases in the collectively bargained contribution rates. The Plan also empowers the Board of Trustees to increase or decrease the amount of self-payments by eligible retired participants, and to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the annual cost of the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

**Note 10. Major Employers**

Contributions from two employers accounted for approximately 21% of total employer contributions for each of the years ended December 31, 2024 and 2023. In the event these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as outlined in the Plan document. The Plan would retain the risk of meeting fixed administrative expenses until the appropriate adjustments were made.

**Note 11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

One mutual fund represented approximately 27% and 32% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. It is reasonably possible that changes in the fair value of this investment could materially affect the amounts reported in the statements of net assets available for benefits. If a significant decline in the fair value of this investment occurred during the next year, a change in the assumed rates of return used to calculate the present value of postretirement benefit obligations may be needed.

The actuarial present value of benefit obligations is reported based upon certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
