### 1. PLAN DESCRIPTION:

The following description of the Food for the Hungry, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan which covers all eligible employees of Food for the Hungry, Inc. (the Sponsor). Other than temporary, all employees are immediately eligible to participate in the Plan. The Plan became effective March 1, 1986, and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for Plan oversight.

#### CONTRIBUTIONS

Each year, participants may contribute amounts on a pre-tax basis, post-tax basis, or combination of the two options up to the annual limits established by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Upon hire, employees are automatically enrolled, unless choosing to opt out, in the Plan at a 6% deferral rate of eligible compensation. The Sponsor makes safe-harbor matching contributions up to 6% of an employee's compensation. The Sponsor may make discretionary contributions in an amount to be determined annually, which is then allocated to each active participant's account based on the ratio of such participant's annual pay, as defined in the Plan document, to the total annual pay of all active participants. No discretionary contributions were made during the year ended December 31, 2024.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocation of: (a) the Sponsor's contribution and (b) the Plan earnings and charged with an allocation of expenses. Allocations are based on participant employment status. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. PLAN DESCRIPTION, continued:

### VESTING

Participant's contributions and related earnings are fully vested at all times. The safe-harbor matching contributions to each participant's account plus related earnings are also fully vested at all times. Discretionary contributions made by the Sponsor vest according to the following schedule:

### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate ranging from 5.25% to 10.5%, which is determined quarterly by the Plan administrator, and is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

### PAYMENTS OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, apply the lump-sum amount towards the purchase of an annuity from the trustee, or maintain the balance in the Plan. If the account balance is \$5,000 or less, the Plan Sponsor may opt to distribute the entire balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also receive an in-service distribution upon reaching age 59 1/2. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

### FORFEITED ACCOUNTS

For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,810 and \$9,782, respectively. These accounts are used to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$16,660 from forfeited nonvested accounts.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

##### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

##### ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

##### PAYMENT OF BENEFITS

Benefits are recorded when paid.

##### ADMINISTRATIVE EXPENSES

The Plan paid administrative fees of \$49,177 during the year ended December 31, 2024. All other administrative expenses, such as accounting fees, were paid by the Sponsor.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Collective investment trusts (CITs) are measured at fair value using the net asset value per share practical expedient and have not been categorized within the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The CITs have no unfunded commitments, are able to be redeemed daily, and have a five day redemption notice period.

5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Sponsor contribution portion of their account.

6. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by Fidelity. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated June 30, 2020, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. PARTY-IN-INTEREST:

As of December 31, 2024 and 2023, certain investments for the Plan are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company performs recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$8,287 for the year ended December 31, 2024. In addition, investment advisory fees of \$40,890 were paid to other parties-in-interest for the year ended December 31, 2024.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 10, 2025 which represents the date the financial statements were available to be issued.
