- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SoutheastHEALTH 401(a) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in *Note 1* to the financial statements, the governing body of SoutheastHEALTH 401(a) Plan approved a plan of liquidation on December 17, 2023, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SoutheastHEALTH 401(a) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of SoutheastHEALTH 401(a) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about SoutheastHEALTH 401(a) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Note 1. Description of the Plan

General

The following description of SoutheastHEALTH 401(a) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Southeast Hospital (Hospital) for the benefit of its employees. To participate in hospital contributions, a participant must be age 21 or older, completed one year of service and be employed on the last day of the plan year. Effective December 31, 2015, the Plan was amended and became frozen as of December 31, 2015. Therefore, no further employees shall be eligible to become participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). American United Life Insurance Company (AUL) serves as plan custodian.

Plan Termination

The Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any beneficiary under the Plan of any vested right. Effective December 17, 2023, the Board of Directors of the plan sponsor, SoutheastHEALTH, voted to terminate the SoutheastHEALTH 401(a) Plan. This was due to the plan sponsor, SoutheastHEALTH, entering into a purchase agreement to be acquired by Mercy Health, effective December 20, 2023. The closing date of the purchase agreement was December 18, 2023. As a result, all participants became 100 percent vested in their accounts. The Plan made distributions to all participants pursuant to the applicable provisions of ERISA, and effective December 16, 2024, the Plan fully liquidated.

Contributions

Prior to December 31, 2015, participants could make voluntary nondeductible contributions as defined by the Plan if it did not exceed the limitations set by law. Participants who had attained age 50 before the end of the year were eligible to make catch-up contributions. The Hospital made nonelective contributions on behalf of all participants. Nonelective contributions were equal to 5% (6% if the participant was fully vested or had reached 55 years of age) of the participants' compensation. The employer also made a past service contribution for each active participant who had past accrual service and was an employee of the Hospital before January 1, 1979. Contributions were subject to certain limitations.

Effective December 31, 2015, the Plan was amended and became frozen as of December 31, 2015. Therefore, no further participant or employer contributions will be made to the Plan after December 31, 2015.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Hospital's contribution and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Hospital's contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants are vested based on years of service, and are fully vested after six years of continuous service. The nonvested balance was forfeited upon termination of service. Forfeitures are used to pay administrative expenses and then to reduce hospital contributions.

Effective December 31, 2015, the Plan was amended and became frozen as of December 31, 2015. Therefore, each participant's individual participant account became 100% vested.

Payment of Benefits

Upon normal retirement, employees are eligible to receive the full amount of their contribution accounts through a lump-sum distribution, single life annuities to the participant, survivorship life annuities to the participant and their contingent annuitant, or fixed period annuities to the participant. Participants retired from the employer due to total and permanent disability are eligible to receive the full amount of their employer and employee contribution accounts.

Upon termination of service, other than normal retirement or disability, unless the participant elects a direct distribution or other eligible direct rollover, participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Participants with account balances exceeding \$1,000 but less than \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator. Participants with account balances exceeding \$5,000 may elect to either receive a lump-sum distribution equal to the vested value of his account, installment payments, or any annuity option available per plan provisions.

In addition, a participant who has attained age 62 and who has not separated from service may elect to receive a distribution of all or a portion of their vested individual participant account.

As of December 17, 2023, the Plan was terminated and all benefits became eligible for payment.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts can be used to pay administrative expenses or reduce future employer contributions. In 2024 and 2023, the Hospital used \$0 to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements for 2024 and 2023 are prepared on the liquidation basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by AUL.

The AUL Fixed Account Fund and AUL Stable Value Fund, fully benefit-responsive investments contract, are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Hospital or the Plan, at the Hospital's discretion.

Note 3. Certification of Insurance Company

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 16, 2024 and December 31, 2023
- Investment income (loss) as shown in the statement of changes in net assets available for benefits for the period January 1, 2024 through December 16, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The plan investments are shares of pooled separate accounts managed by AUL, which is the insurance company to the Plan. The Plan paid \$64,199 and \$66,591 of administrative fees to AUL during 2024 and 2023, respectively.

Certain legal and accounting fees and certain other administrative expenses relating to the maintenance of employee eligibility records are paid by the Hospital.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

In accordance with Subtopic 820-10, investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

(A) This category includes investments in pooled separate accounts that invest primarily in domestic equity, international equity, and bond mutual funds. The pooled separate account's investments in mutual funds are based on the net asset value or price per share of the underlying mutual fund beginning with a price determined by AUL and the number of units issued is calculated to match the current fair value of the underlying mutual fund. There is no restriction on the redemption of these funds.

Note 6. Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract (fixed account fund) with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The AUL Fixed Account Fund is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Effective August 17, 2022, the contract for the AUL Fixed Asset Account was amended to remove the AUL Fixed Asset Account and add the AUL Stable Value Fund. Funds from the AUL Fixed Asset Account were transferred directly to the AUL Stable Value Fund on this date.

Contract value of the AUL Stable Value Fund at December 16, 2024 and December 31, 2023, was \$0 and \$7,400,613, respectively.

Note 7. Tax Status

The Plan obtained its latest determination letter on October 20, 2015, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
