Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SoutheastHEALTH Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 16, 2024 (in Liquidation) and December 31, 2023 (in Liquidation), and the related statement of changes in net assets available for benefits for the period January 1, 2024 through December 16, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SoutheastHEALTH Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 16, 2024 (in Liquidation) and December 31, 2023 (in Liquidation), and for the period January 1, 2024 through December 16, 2024, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SoutheastHEALTH Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 1 to the financial statements, the governing body of SoutheastHEALTH Retirement Plan approved a plan of liquidation on December 17, 2023, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan's financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SoutheastHEALTH Retirement Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1. Description of the Plan

General

The following description of SoutheastHEALTH Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Southeast Hospital (Hospital) for the benefit of its employees. An employee can make a contribution on their first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). American United Life Insurance Company (AUL) serves as plan custodian.

Plan Termination

The Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any beneficiary under the Plan of any vested right. Effective December 17, 2023, the Board of Directors of the plan sponsor, SoutheastHEALTH, voted to terminate the SoutheastHEALTH Retirement Plan. This was due to the plan sponsor, SoutheastHEALTH, entering into a purchase agreement to be acquired by Mercy Health, effective December 20, 2023. The closing date of the purchase agreement was December 18, 2023. As a result, all participants became 100 percent vested in their accounts and the Plan became frozen and no longer accepted contributions. The Plan made distributions to all participants pursuant to the applicable provisions of ERISA, and effective December 16, 2024, the Plan was fully liquidated.

Contributions

Prior to December 17, 2023, the Plan permitted employees through a salary deferral election to have the Hospital make annual contributions up to the maximum allowed by the Internal Revenue Code as a pre-tax deferral or a Roth deferral. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Prior to May 16, 2020, the Plan was a safe harbor 403(b) Plan and the Hospital made safe harbor matching contributions. Effective June 1, 2021, the Plan was amended to add a discretionary nonelective employer contribution. The Board of Directors approved a 2% nonelective employer contribution to start at that date for all eligible employees over the age of 18. Effective December 17, 2023, the plan became frozen and no longer accepted contributions.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Hospital's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Hospital's safe harbor matching contributions plus earnings thereon.

Prior to December 17, 2023, vesting in the Hospital's nonelective employer contribution portion of their accounts plus earnings thereon was based on years of continuous service. Participants are vested based on years of service and are fully vested after one year of continuous service. For employer contributions merged from the SoutheastHEALTH Regional 403(b) Plan, participants are fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to pay administrative expenses and to reduce hospital contributions.

Payment of Benefits

Upon normal retirement, employees are eligible to receive the full amount of their contribution accounts through a lump-sum distribution, single life annuities to the participant, survivorship life annuities to the participant and their contingent annuitant, or fixed period annuities to the participant. Participants retired from the employer due to total and permanent disability are eligible to receive the full amount of their contribution accounts.

Upon termination of service, other than normal retirement or disability, unless the participant elects a direct distribution or other eligible direct rollover, participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Participants with account balances exceeding \$1,000 but less than \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator. Participants with account balances exceeding \$5,000 may elect to either receive a lump-sum distribution equal to the vested value of his account or installment payments.

As of December 17, 2023, the Plan was terminated and all benefits became eligible for payment.

Forfeited Accounts

At December 16, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0. These accounts can be used to pay administrative expenses or reduce future employer contributions. In 2024 and 2023, the Hospital used \$1,226 and \$0 to pay administrative expenses and \$0 and \$350,046 to reduce employer contributions, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements for 2024 and 2023 are prepared on the liquidation basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by AUL.

The AUL Fixed Account Fund, AUL Stable Value Fund, and Alternate Fixed Account Fund, fully benefit-responsive investment contracts, are valued at contract value. Contract value represents contributions made under the contracts, plus interest at the contract rates, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Hospital or the Plan, at the Hospital's discretion.

Note 3. Certification of Insurance Company

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 16, 2024 and December 31, 2023
- Investment income (loss) as shown in the statement of changes in net assets available for benefits for the period January 1, 2024 through December 16, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The plan investments are shares of pooled separate accounts managed by AUL, which is the Plan's insurance company. The Plan paid \$198,529 and \$163,264 of administrative fees to AUL during 2024 and 2023, respectively.

Certain legal and accounting fees and certain other administrative expenses relating to the maintenance of employee eligibility records are paid by the Hospital.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities.

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

In accordance with Subtopic 820-10, investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

(A) This category includes investments in pooled separate accounts that invest primarily in domestic equity, international equity, and bond mutual funds. The pooled separate account's investments in mutual funds are based on the net asset value or price per share of the underlying mutual fund beginning with a price determined by AUL and the number of units issued is calculated to match the current fair value of the underlying mutual fund. There is no restriction on the redemption of these funds.

Note 6. Investment Contracts with Insurance Company

The Plan has entered into two fully benefit-responsive investment contracts (fixed account fund and alternate fixed account fund) with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The AUL Fixed Account Fund and Alternate Fixed Account Fund are fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Effective August 17, 2022, the contract for the AUL Fixed Asset Account was amended to remove the AUL Fixed Asset Account and add the AUL Stable Value Fund. Funds from the AUL Fixed Asset Account were transferred directly to the AUL Stable Value Fund on this date.

Contract value of the AUL Alternate Fixed Account Fund at December 16, 2024 and December 31, 2023, was \$0 and \$635,607, respectively.

Contract value of the AUL Stable Value Fund at December 16, 2024 and December 31, 2023, was \$0 and \$6,277,668, respectively.

Note 7. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. During 2018 the Plan adopted a volume submitter plan document sponsored by One America Financial Partners, Inc. This document has been filed with the appropriate agency and has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan has not requested or obtained a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer.

The Hospital did not remit employee contributions to the Plan in the amount of \$0 and \$311 in 2024 and 2023, respectively. Of the employee contributions remitted to the Plan, contributions of \$14 and \$842 were not remitted within the required time period for the years ended December 31, 2023 and 2022, respectively. These items were fully corrected with the required missed earnings during 2024.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.
