ADDENDUM TO FORM 5500

The foregoing Form 5500 for the 2024 plan year is for BOTM, Inc. as a participating employer in the Pension Transfer Trust Plan, (plan sponsor's: EIN 45-3113208; plan number: 001), which was designed and intended to be, and has been operated as, a "multiple employer plan." For years prior to 2011, a single Form 5500 was filed for the Pension Transfer Trust Plan as a "multiple employer plan" covering all of its participating employers.

In light of the Department of Labor's Advisory Opinion 2012-04A, BOTM, Inc. will now treat for certain purposes of ERISA, the portion of the Pension Transfer Trust Plan providing benefits for eligible employees of BOTM, Inc., as a separate plan maintained by BOTM, Inc. for the benefit of those employees.
