Effective for the Plan Year ended December 31, 2024 there has been a change in the valuation software for the actuarial firm providing services to the Plan. In accordance with Revenue Procedure 2017-56, the following conditions have been met:

1. The enrolled actuary for the plan is the same as the enrolled actuary for the plan for the prior plan year and the business organization providing actuarial services to the plan is the same as the business organization that provided actuarial services to the plan for the prior plan year.
2. The new method is substantially the same as the method used for the prior plan year and is consistent with the information contained in the prior actuarial valuation reports or prior Schedule SBs or Form 5500s.
3. The new valuation software generally will be used by the enrolled actuary for the single-employer plans to which the enrolled actuary provides actuarial services.
4. The method used by the same actuary has been applied to the prior year (without regard to any adjustments for employee contributions and plan-related expenses) and the absolute value of each resulting difference in target normal cost, funding target, and actuarial value of assets that is attributable to the change in cost method does not exceed 1% of the respective amounts calculated by the prior valuation software for that year (all other factors being held constant)
5. The change in cost due to the change in method is treated in the same manner as an experience gain or loss.
6. The Plan Administrator agrees with this change and has been made aware of this change prior to the filing of the Schedule SB.
