- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kaye-Smith Enterprises 401(k) Retirement Savings Plan & Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Kaye-Smith Enterprises 401(k) Retirement Savings Plan & Trust approved a plan of liquidation on December 31, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kaye-Smith Enterprises 401(k) Retirement Savings Plan & Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements
December 31, 2024 and 2023

NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN

The provisions of the Kaye-Smith Enterprises 401(k) Retirement Savings Plan & Trust (the Plan) were effective July 1, 1990. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective December 31, 2024, the Kaye-Smith Enterprises (the Company) authorized a Plan termination (see Note 2).

General

Prior to Plan termination, the Plan was a defined contribution plan covering all employees of Kaye-Smith Enterprises Inc. (the Company) who were 21 years of age or older and had completed three months of service, as defined in the Plan document. Employees were allowed to begin participation in the Plan on a quarterly basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Prior to December 31, 2024, participants could elect to contribute up to 100% of their annual pre-tax or after-tax compensation to the Plan, as defined in the Plan document, within statutory limits. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Contributions were paid to the Plan bi-weekly. Participants could also contribute amounts representing distributions from other qualified plans.

The Company could make discretionary contributions to the Plan each year. Company contributions, if any, were funded in the following Plan year. No discretionary contributions were made in 2024.

During 2024, the Company contributed \$100 per calendar month through June 30, 2024, and \$125 per calendar month beginning July 1, 2024, to the Plan for each employee covered by the Local 747M Labor Agreement who received pay from the Company for eighty hours or more of service during the calendar month. These Company contributions were funded monthly. Contributions during 2024 totaled \$55,800.

NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Individual participant accounts are maintained by the Plan's record keeper. Each account is credited or charged with the participant's contributions, the Company's contributions, if any, and allocations of investment income and losses on the individual account balances. Distribution and loan administration fees are deducted from the respective participants' accounts. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of employee and employer contributions among various mutual funds and a guaranteed investment contract.

Vesting

Participants are 100% vested in their accounts, including any employer contributions, and actual earnings thereon.

Notes Receivable from Participants

Prior to December 31, 2024, participants were allowed to borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance, with terms ranging from one to five years. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time of loan issuance as determined by the Plan Administrator. Interest rates ranged from 4.25% to 9.5% on notes receivable outstanding as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits may be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the value of the participant's vested account may be paid in a lump sum. Under certain hardship circumstances or attainment of age 59 ½, participants may request a lump-sum distribution of their vested account balances prior to retirement.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting policies used by the Plan:

Plan Termination and Basis of Accounting

The Company had the right under the Plan to terminate the Plan subject to the provisions of ERISA. During 2024, the governing body of the Plan authorized the termination of the Plan effective December 31, 2024, and directed the trustee to liquidate Plan assets. All of the Plan's assets will be distributed to participant in 2025. In accordance with generally accepted accounting principles in the United States of America (GAAP), the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. The liquidation basis of accounting requires assets be valued at their net realizable values, which approximate fair value and contract value of investments, as applicable. The Plan had no liabilities and there were no liquidation expenses other than distribution processing charges.

The Plan previously presented its statement of net assets available for benefits at December 31, 2023, using the accrual basis of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at net realizable value at December 31, 2024, which approximates fair value and contract value, as applicable. The Plan's mutual fund investments are reported at fair value at December 31, 2023. The Plan's fully benefit-responsive investment contract is reported at contract value at December 31, 2023 (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest, if any. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for individual transactions such as distributions and loans are deducted from the respective participant's account. Investment related expenses, and revenue sharing fees or credits, are included in net appreciation or depreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

GAAP (ongoing and liquidation basis of accounting) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

At December 31, 2023, the Plan's investments reported at fair value consist solely of mutual funds, which are valued using level 1 measurement. At December 31, 2024, the Plan's mutual fund investments in liquidation are valued at net realizable value, which approximates fair value, using level 1 measurement.

NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract (traditional contract) with John Hancock Trust Company LLC (Hancock). This investment was reported at contract value at December 31, 2023. Contract value is the relevant measure for insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the insurance company traditional general account investment contract was \$364,958 at December 31, 2023.

NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (continued)

The guaranteed investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is established by the contract issuer and has a guaranteed minimum rate of 1%. The crediting rate is generally set on a semi-annual basis (generally January 1 and July 1 of each year). The contract permits the insurance company to terminate the contract with three months' written notice. The Plan Sponsor can terminate the contract at any time (1) if Hancock makes proposed changes that are implemented without the Plan Sponsor's consent as described in the contract, or (2) by providing 60-day written notice to Hancock. The guaranteed investment contract will continue in force until the contract is terminated by the insurance company or certain events or circumstances arise as described in the contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may include, but not limited to total or partial plan termination, mergers, spin-offs, lay-offs, early retirement incentive programs, sales or closings of all or part of the Plan's operations, bankruptcy or receivership, or withdrawals resulting from withdrawal communication. Such payments will be paid at book value only to the extent the total amount of such non-benefit responsive withdrawals over the preceding twelve-month period does not exceed 5% of the Plan's balance in the guaranteed investment contract as of the start of such period.

During 2024, the Company authorized the termination of the Plan (Note 2). The Plan gave adequate notice to the contract issuer, and there was no contract termination charge. The net realizable value of the insurance company traditional general account investment contract, which approximates contract value, is \$590,808 at December 31, 2024.

NOTE 5 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants that are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC (Hancock), the custodian of the Plan.

NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are units of participation in a guaranteed interest account or other investments managed by Hancock, the custodian. Therefore, transactions with Hancock and their affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services. Additionally, these affiliates collect revenue sharing from the Plan's investments to pay for administrative services.

NOTE 7 – TAX STATUS

The Plan operated under provisions of a Pre-Approved Plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust was tax-exempt.

GAAP (ongoing and liquidation basis of accounting) requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan allowed participants to invest in investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.
