## INDEPENDENT AUDITORS' REPORT

To the Plan Trustee of  
Simulations Plus, Inc. 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Simulations Plus, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Simulations Plus, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Simulations Plus, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Note 1 – Description of Plan and Contributions**

The following description of the Simulations Plus, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Simulations Plus, Inc. (the "Company") is the Plan Sponsor. The Plan became effective January 1, 2003, and was designed to encourage employees to save for retirement and stay with the Company until their retirement. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan established for the benefit of all employees of the Company and its subsidiaries. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. John Hancock Trust Company LLC serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

**Eligibility:** Employees may participate in the Plan the first day of the following month after completing three months of eligible service and attaining age 21.

**Participant Contributions:** Participants may voluntarily contribute to the Plan an amount from 1% to 100% of eligible earnings, subject to limitations of the Internal Revenue Code, as defined by the Plan agreement.

**Employer Contributions:** The Company may make a discretionary matching contribution equal to a uniform percentage of the salary deferral. For 2024, the sponsor made a contribution equal to 100% on the first 4% of the participant's compensation which is deferred as an elective deferral. For the year ended December 31, 2024, the Company made contributions totaling \$824,508.

**Investment Direction:** Each participant directs the investment of all assets attributable to their respective account.

**Vesting:** The participants are 100% vested with respect to their own contributions upon entering the Plan. The vesting percentages for the employer matching contributions based on years of service are as follows:

2	66%
3	100%

Participants also become 100% vested if they become disabled, or upon death while employed.

**Note 1 – Description of Plan and Contributions (Continued)**

**Notes Receivable from Participants:** The Plan allows loans to participants up to 50% of their vested account balance, up to a maximum of \$50,000. The minimum loan amount is \$1,000. Loan repayments are made through payroll deductions and must generally be repaid within five years. Loans to acquire a principal residence may be repaid in excess of five years but no more than fifteen years. Loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates (prime plus 1%).

**Forfeitures:** Participants' accounts are forfeited if the employer contribution portion has not fully vested at the date of termination. These amounts will be utilized to pay administrative expenses of the Plan and to reduce employer contributions. For the year ended December 31, 2024, \$21,150 of forfeitures were utilized to reduce employer contributions. For the year ended December 31, 2024, there was no forfeited amount utilized to reduce administrative expenses. The forfeiture balance was \$11,325 at December 31, 2024.

**Note 2 – Summary of Significant Accounting Policies**

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of Benefits:** Benefit payments to participants are recorded upon distribution.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value (except for common collective trust, which is reported at net asset value). Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan are either deducted from income earned on a daily basis or presented as administrative expenses in the statement of changes in net assets available for benefits.

**Note 2 – Summary of Significant Accounting Policies (Continued)**

**Common Collective Trust:** The Plan, through the John Hancock Stable Value Fund, holds investments in common collective trust funds (the "Trust Funds"). The Trust Funds are valued based upon significant observable inputs, not based upon quoted market prices in an active market. The value is based upon the units of the Trust Funds held by the Plan at year end multiplied by the respective unit value. The unit value is based on the fair value of the underlying investments. The John Hancock Stable Value Fund shares' investment objective is to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The John Hancock Stable Value Fund primarily invests in diversified fixed income funds and separately managed bond accounts selected by John Hancock as the fund manager.

Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events could limit the Trust's ability to transact at contract value with plan unitholders. The plan administrator does not believe that any of the events which could limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 3 – Income Tax Status**

The IRS has determined and the Plan trustee has been informed by a letter dated May 18, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**Note 4 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, further contributions to the Plan shall cease and all amounts credited to the participants' accounts will become 100% vested. All participants who are affected by such termination would receive distributions of their account balances.

**Note 5 – Information Certified by the Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment gain (loss) from common collective trust and registered investment companies, interest on notes receivable from participants, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, and, accordingly, was unaudited as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations.

**Note 6 – Fair Value Measurements**

FASB Accounting Standards Codification Topic No. 820, Fair Value Measurements and Disclosures ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 6 – Fair Value Measurements (Continued)**

Following are descriptions of the valuation methodologies used for assets measured at fair value:

*Shares of registered investment companies:* Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The fair value of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on the active market on which the individual funds are traded. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* This investment is measured using the net asset value per share practical expedient as of December 31, 2024. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**Note 7 – Exempt Party-In-Interest and Related Party Transactions**

Certain plan investment options are shares of mutual funds managed by John Hancock Trust Company LLC. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan issues loans to participants, which are secured by the balance in the participant's account. Such transactions are also considered related party transactions. For the year ended December 31, 2024, total principal amounts of \$99,913 of loans were issued to participants.

**Note 8 – Notes Receivable from Participants**

Notes receivable from participants bear interest at a range of 4.25% - 9.50% and are receivable in monthly installments over a period of one to five years. Loan balances range from \$1,845 to \$19,532 at December 31, 2024.

**Note 9 – Excess Contributions Refundable**

During a Plan year, various participants may over-contribute to the Plan. The participants' excess contributions are returned to the participants. There were no excess contributions in 2024.

**Note 10 – Risks and Uncertainties**

The Plan provides for various investment options in funds which participants can invest in. Investments are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**Note 11 – Subsequent Events**

The Plan has evaluated events occurring after the date of the accompanying statements of net assets available for benefits through October 7, 2025, the date the financial statements are available for issuance. The Plan did not identify any material subsequent events requiring adjustment to or disclosure in the accompanying financial statements.
