My name is Jeanette Wood, I am the wife of Joseph Wood who passed away on Nov. 22, 2023.

Joseph Was the sole owner of Covenant Ranch Trucking LLC. Which closed down in 2019. Joseph had used a company for the payroll and 401K, Paychex, who filed the forms for him.

It took me a while to figure out what this mail was in regards to. I had mailed you a letter letting you know that the business was closed and the owner was deceased but was told that I still had to submit the form. This was very challenging as I had no idea what I was doing or how to resolve the matter. I had no login or company information. With assistance from my accountant and from Patty there at your office I was able to figure out what I needed to do and get the necessary form from Paychex so that I could submit the 5500-SF final form.

When I asked the representative at Paychex why they didn't file he said they never send the final form and would have emailed it to us in 2022. However, the business was closed in 2019 so that email wouldn't have ever reached us. There is no way that my husband knew this was to be completed and I absolutely had no idea about it.

Please consider the circumstances and forgive the delinquent fees normally associated with this late filing.
