

**NOTE 1 – PLAN DESCRIPTION**

The following description of the Employee Stock Ownership Plan and Trust of Standard Motor Products, Inc. (the Plan or ESOP) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is established to provide for the participation of eligible employees in the growth of Standard Motor Products, Inc. (the Company) by enabling them to acquire stock ownership interests in the Company. The Plan is intended as a stock bonus plan qualified under Section 401(a) of the Internal Revenue Code (IRC) and as an employee stock ownership plan under Section 4975(e)(7) of the IRC and Section 407(d)(6) of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Employees not covered by collective bargaining agreements between the Company and employee representatives, who are not hired as a member of a substitute workforce, based solely on the availability of work, for one or more specified projects or assignments, who are not non-resident aliens who have not earned income within the United States, are eligible for benefits under the Plan. Full-time employees who have completed 30 days of service with the Company and part-time employees that have completed 1,000 hours of service with the Company in a Plan year will become a participant on the first day of the following calendar quarter.

The Plan uses Fidelity Management Trust Company (Fidelity) to provide administrative, recordkeeping, and accounting services for the Plan.

Contributions: The Company may contribute to the Plan at its own discretion. During 2024, the Company made a voluntary contribution to the Plan by transferring 68,700 shares of its common stock to the Plan and subsequently allocated the shares to eligible employees. Effective January 1, 2000, contributions are allocated among eligible employees as follows:

- 1) Seventy percent of the contributions for a Plan year shall be allocated to the accounts of those participants who (a) are employees or on maternity or paternity leave as of January 1st of the current Plan year, or (b) retire on or after their normal retirement date, die, or become disabled during the Plan year, in the ratio which the eligible compensation of each such participant for the Plan year bears to the total eligible compensation of all participants for such year.
- 2) Thirty percent of the contributions made for a Plan year shall be allocated to the accounts of those participants (a) who have completed at least five years of vesting service, as defined, by the last day of the Plan year, and (b) who are employees or on maternity or paternity leave as of January 1st of the current Plan year, or who retire on or after their normal retirement date, die, become disabled during the Plan year, in the ratio which the eligible compensation of each such participant for the Plan year bears to the total eligible compensation of all participants for such year.

Participant Accounts: Each participant's account is credited with an allocation of (a) the Company's contributions, (b) Plan earnings (losses), and (c) forfeitures, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on employer contributions, eligible compensation, and/or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: A participant's vested interest in his or her account will be 100% under any of the following conditions:

- (i) Death or disability of a member while employed by the Company;
- (ii) Termination of the Plan; or
- (iii) A participant reaching 65 years of age while employed by the Company.

Otherwise, participants vest over six years as follows:

6 or more years	100%

Benefits: The benefit to which a participant is entitled is that benefit which can be provided from the participant's vested portion of his or her accounts. Subject to certain restrictions in the Plan, on termination of service, a participant may elect to receive a lump-sum payment equal to the participant's vested account balance, either in cash or shares of common stock of the Company. A participant may also elect to roll over the value of his or her stock account into an individual retirement account. A Plan participant that has terminated service, including through retirement, or his/her surviving spouse beneficiary, whose vested account balance is more than \$7,000 may elect to keep his/her account balance in the Plan until the year in which the Plan participant reaches/would have reached age 70½, or 73 for participants born after July 1, 1949, at which point a minimum distribution is required. Participants that have terminated service, including through retirement, or his/her surviving spouse beneficiary, whose vested account balance is less than \$7,000 will be required to take a distribution.

Forfeitures: At December 31, 2024 and 2023, forfeited non-vested accounts totaled 2,388 shares and 2,365 shares, respectively. Forfeited non-vested shares are allocated to existing Plan participants.

Voting: Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account.

Diversification: Participants who are age 55 and older and who have a 100% non-forfeitable right to their account may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a period as defined in the Plan agreement, subject to certain percentage limitations.

Termination: Although it has not expressed any intent to do so, the Company has reserved a right to discontinue the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP) as applied to employee benefit plans, and in accordance with the Plan agreement.

Reclassifications: Some items in the prior year financial statements were reclassified to conform to the current presentation. Reclassifications had no effect on prior year net assets available for benefits or the prior year net increase in net assets available for benefits.

Use of Estimates: The preparation of the financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 3. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Administrative Expenses: Trustee and custodial expenses are paid by the Company on behalf of the employees. Recordkeeping and other administrative expenses are charged to the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 30, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

Company Common Stock: Funds in common stock are stated at fair value as determined by quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Fund: Consists of a money market mutual fund, which is stated at fair value as determined by quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Standard Motor Products, Inc. is the sponsor of the Plan, and, accordingly, investments in Standard Motor Products, Inc. common stock are considered party-in-interest transactions. The Plan holds a money market mutual fund that is managed by an affiliate of Fidelity, the trustee of the Plan. These transactions, as well as trustee fees, record keeping fees, investment management fees, and certain professional fees for the administration of the Plan that were paid either directly or indirectly by the Plan to Fidelity or its affiliates represent party-in-interest transactions. Additionally, during 2024, the Plan received \$1,342,094 in dividend income from its investment in common stock of the Company.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 6, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan's principal asset is the investment in the Company's common stock. Such investment, in general, is exposed to various risks, including overall market risk, including global events. Due to the level of risk associated with this type of investment and the related historical market volatility, it is reasonable to expect that changes in the value of the investment will occur in the near term and that such changes could materially affect participant account balances and amounts reported in the statements of net assets available for benefits.
