INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Boilermakers Local Lodge No. 5 Vacation Fund

Opinion

We have audited the financial statements of the Boilermakers Local Lodge No. 5 Vacation Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements presents fairly, in all material respects, the net assets available for benefits of the Boilermakers Local Lodge No. 5 Vacation Fund as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Boilermakers Local Lodge No. 5 Vacation Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENT DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description is provided for general information purposes only. Participants should refer to the Plan document and the Summary Plan Description for more complete information.

General: The Boilermakers Local Lodge No. 5 Vacation Fund (the “Plan”) is a multiemployer collectively bargained welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan operates as a trust to provide vacation benefits to active members, current contribution rate is 15% of pay. The plan covers participants who were covered employees of participating employers under collectively bargained agreements with Boilermakers Local Lodge No. 5 Union (the “Union”).

Plan Administration: The administration of the Plan is the responsibility of a Board of Trustees comprised of Union and Employer Trustees. The Union Trustees and Employer Trustees have equal voting rights.

Benefits: The Plan provides for the payment of vacation benefits for eligible participants. The benefits to which participants are entitled are the sum of contributions received on their behalf, less an administrative fee. The benefit year is January 1 to December 31 and benefits are paid in March of subsequent year for contributions received through December 31.

Funding: Employers make contributions for covered participants based upon hours worked. The contribution rate is determined by the collective bargaining agreement in effect at the time.

Other: Although they have not expressed any intention to do so, the Trustees have the right under the Plan to modify benefits provided to participants. The Plan may be terminated only by joint agreement between the contributing employers and the Union, subject to the provisions set forth in ERISA.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements were prepared on the accrual basis of accounting.

Use of Estimates: The preparation of the financial statement in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statement and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Employer Contributions: The amounts of employer contributions receivable and employer contribution income do not include any estimates of amounts due from employers where remittance reports were not received by the Plan office nor any amounts due but unpaid as a result of payroll audits.

Valuation of Investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest bearing cash is reported at cost, which approximates fair value and is in Level 1 of the fair value hierarchy.

Current Expected Credit Losses: The Plan has adopted Accounting Standards Update (ASU) No. 2016-13, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments. The core principles of ASU 2016-13 (the “ASU”) significantly change the way organizations recognize credit losses by replacing the incurred loss model with an expected loss model. The financials assets held by the Plan that are subject to the ASU are accounts receivables.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (continued)

Current Expected Credit Losses (continued)

The Plan assesses credit losses on accounts receivable on a regular basis to determine the allowance for doubtful accounts. Given the nature of the Plan's financial assets and historical loss experience, the adoption of the ASU did not have a significant impact on the financial statements.

NOTE 3 – PROCEDURES ON TERMINATION

In the event of termination of the Plan, the Trust Agreement requires that the trustees shall distribute to each participant the vacation contributions accumulated subject to any administrative adjustment at the time of termination in such a manner as will best effectuate the Plan's intent. No part of the funds shall ever revert to the employers or the Union.

NOTE 4 – OTHER INCOME

The Plan charges an annual fee of \$100 for each vacation check cashed by participants.

NOTE 5 – CONCENTRATION OF CREDIT RISK

Financial instruments that subject the Plan to concentration of credit risk include cash and short-term investments. While the Plan attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits.

NOTE 6 – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to be qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the trust's net income is exempt from income taxes. The Plan's management believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

NOTE 7 – EVALUATION OF SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statement was available to be issued.

NOTE 8 – TRANSACTIONS WITH PARTIES-IN-INTEREST AND RELATED PARTIES

All employer contributions are initially received by the Boilermakers Local Lodge No. 5 Welfare Plan (the "Welfare Plan") and then transferred to the Plan.

Boilermakers Welfare, Annuity, and Vacation Funds (the "Plans") share certain professional and administrative services. The Welfare Plan pays most of the expenses except those directly incurred by the respective Plans. The amounts are then allocated quarterly to the Plans, with third-party administration expenses allocated based on workload percentages and payroll audit and legal fees based on employer contributions.
