(1) Description of Plan

The following description of the Handcrafted Restaurants 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan effective January 1, 2016, and subsequently amended and restated, covering substantially all employees of Handcrafted Restaurants, LLC (the Company or Plan Sponsor) and its affiliated restaurant entities, all under common control. Employees who attain 21 years of age and have completed one year of service (as defined) are eligible to participate in the Plan. After meeting the age and service requirement, the participant may enter the Plan on the next January 1 or July 1.

The Plan was frozen effective December 1, 2020. At that time, no additional employees were eligible to participate in the Plan and salary deferrals and employer contributions were frozen. Effective January 1, 2022, the Plan was reinstated and employees were once again eligible to participate and contribute to the Plan.

The Plan Sponsor or members of its senior management team serve as the Plan's trustees and administrator. American United Life Insurance Company (AUL), a OneAmerica company, serves as the issuer and recordkeeper of the Plan. The Plan is subject to the provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may make pre-tax salary deferral and Roth 401(k) deferral contributions. Such contributions may be a specified percentage or dollar amount of their eligible compensation, as defined in the plan agreement, subject to certain annual IRC limitations. In addition, participants may also contribute amounts representing distributions from other qualified retirement savings plans (termed rollover contributions). Plan participants who are age 50 and who have reached certain maximum contribution levels may also make catch-up contributions.

The Company, in its sole discretion, could make matching contributions to the Plan equal to a percentage of the elective deferrals made by eligible participants during that plan year or flat dollar amount allocated on a uniform basis to all participants. The Company did not elect to make a discretionary employer matching contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of plan earnings or losses. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Any such borrowings are to be secured by a minimum of 50% of the vested balance in the participant's account and will bear a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. At December 31, 2024 and 2023, there were no loans outstanding. Loan repayments are repaid through payroll deductions over a period not to exceed five years, but may be up to 30 years for the purchase of a primary residence.

Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary matching contributions plus earnings thereon is based on years of continuous service in accordance with the following schedule:

Payment of Benefits

On termination of service due to death, disability, severance from employment, or retirement, a participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, under certain circumstances, a participant is allowed to withdraw funds from the Plan while still employed.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees related to distributions are charged directly to the respective participant's account and are included in administrative expenses. Participants are allocated a portion of contract administrator fees and third party administrator fees as stated in the plan agreement. Fees paid by the Plan for investment management services are netted against net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, the issuer, and third party administrators. See Note 4 for discussion of fair value measurements.

The guaranteed investment contract is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Refer to Note 5 for further information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Excess Contributions Payable

Excess contributions payable to participants amounted to \$8,234 at December 31, 2024. The amount represents contributions in excess of amounts allowed by the Internal Revenue Service (IRS) and are recorded as a liability with a corresponding reduction to contributions. The Plan distributed these excess participant contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

(3) Information Certified by the Issuer

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the issuer, AUL, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- All investments contained in the statements of net assets available for benefits.
- All investment-related information (e.g. investment income (loss)) contained in the statement of changes in net assets available for benefits.
- All information presented in the supplemental schedule of assets (held at end of year).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

(4) Fair Value Measurements

The accounting guidance for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Pooled separate account: Stated at fair value as determined by the issuer of the pooled separate account based on the net asset value (NAV) per share of the underlying investments. The NAV as provided by AUL, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant

transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the funds in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding measurement described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Investments in Guaranteed Investment Contracts

As of December 31, 2024 and 2023, the Plan participates in fully benefit-responsive investment contracts with AUL contained in AUL's group annuity contract. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan and is not less than 1%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk or the contract issue or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$27,714 and \$23,569, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan agreements (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

(6) Risks and Uncertainties

The Plan invests in various types of investment securities. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(7) Tax Status

The Plan is based on the non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Hicks Pension Group LLC. The Internal Revenue Services (IRS) informed Hicks Pension Group LLC by a letter dated December 17, 2021, that the non-standardized pre-approved profit sharing/money purchase/CODA plan upon which the Plan is based is designed in accordance with the provisions of the IRC. The Plan has not yet applied for its own determination letter and has subsequently been amended; however, in the opinion of the plan administrator and the Plan's tax counsel, believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan for tax exempt status.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions, if any.

(9) Related Party Transactions

Plan investments include a pooled separate account and an investment contract managed by AUL. Related transactions with AUL qualify as party-in-interest transactions. Any purchases and sales of these investments are performed on the open market at fair value. AUL receives revenue from certain investment service providers for services AUL provides to the fund. The revenue is used to offset certain contract administrator fees charged by AUL for services to the Plan. During the year ended December 31, 2024, the Plan applied \$3,521 to offset administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

(10) Late Remittances

During the year ended December 31, 2024, the Company failed to remit employee deferrals amounting to \$977, to the Plan on a timely basis, according to Department of Labor regulations. All late deferrals have been remitted to the Plan. The Company intends to calculate and remit lost earnings to the Plan in 2025.

(11) Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date at which the accompanying financial statements were available to be issued, and determined that there are no other items to disclose.
