Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lange Companies 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), (formerly Tom Lange Company 401(k) Retirement Plan) as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lange Companies 401(k) Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lange Companies 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lange Companies 401(k) Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance, and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the

financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A | DESCRIPTION OF THE PLAN

The following description of the Lange Companies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

Tom Lange Company 401(k) Retirement Plan was adopted effective January 1, 2009, as a defined contribution plan covering all United States employees of Tom Lange Company, Inc. (Company) who have worked one hour in six months of service and are age 18 or older, with the exception of interns and seasonal workers who work less than 1,000 hours a year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company, as defined, includes related companies that have adopted the Plan. These companies include Lange Logistics, Inc. and Tom Lange International, Inc. On September 1, 2024, the Company and its subsidiaries underwent a rebranding that included the formation of a new parent company and two name changes among its subsidiaries. Lange Companies, Inc. was established as the newly formed parent holding company. Tom Lange Company International, Inc. was renamed Lange Fresh Sales, Inc. Lange Companies International, Inc., was renamed Lange Fresh Farms, Inc., doing business as Lange Farms. The name of Lange Logistics, Inc. remains unchanged at this time. The restructuring has no financial impact on the financial statements. Along with the rebranding of the Company, the Plan was amended to update its name from Tom Lange Company 401(k) Retirement Plan to Lange Companies 4101(k) Retirement Plan, effective September 1, 2024.

2. Contributions

Each year, participants may contribute either pretax or post tax (Roth) compensation up to the maximum dollar amount as determined by the Federal government of pretax annual compensation, as defined in the Plan. The maximum deferral is the lesser of 100% of compensation or \$ 23,000 and \$ 22,500 for 2024 and 2023, respectively. For participants age 50 or older, an additional \$ 7,500 in contributions was permitted for 2024 and 2023. The Plan includes an automatic enrollment provision that unless a participant makes an affirmative election, the Company will withhold 3% of eligible compensation. The Plan is a safe harbor 401(k) plan whereby the Company contributes 3% of an employee's eligible compensation, without regard to whether the employee made any deferred compensation payments. The Company may make additional discretionary matching or qualified nonelective contributions. No such additional employer contributions were made during the years ended December 31, 2024 or 2023. The plan also allows for participant rollover contributions.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and the Plan's earnings. Allocations are based on participant compensation, contributions or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are 100% vested in their contributions plus actual earnings thereon. Participants are also 100% vested in safe harbor contributions made by the Company. Vesting in the Company's matching and nonelective contribution portion, if made, of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

5. Payment of Benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in periodic installments over specified number of years. Account balances of terminated participants are to be distributed as soon as administratively feasible for those with account balances less than \$ 5,000 or participants who request a distribution. For those terminated participants with balances greater than \$ 5,000, the amounts may remain with the Plan indefinitely. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon reaching the age of 59½.

6. Notes Receivable from Participants

A participant may borrow from their account a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50% of the total value of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator.

7. Forfeitures

Forfeitures will be used to reduce employer contributions. To date, there have been no contributions subject to forfeiture.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

1. *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

2. *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are stated at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note D for discussion of the Plan's investments in fully benefit-responsive investment contracts.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance. Payments are made at least monthly and any accrued interest is inconsequential.

5. *Payment of Benefits*

Benefits are recorded when paid.

6. *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Such contributions plus earnings attributable to those amounts are distributed during the next plan year.

7. *Expenses*

The administration costs and expenses of the Plan are paid by the Company. Loan and distribution fees are paid by participants. There is a contract asset charge that is assessed to participants that is included in the net appreciation in fair value of investments.

8. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 9, 2025, which is the date the financial statements were available to be issued. Through October 9, 2025, no subsequent events required recognition or disclosure in the financial statements.

NOTE C | FAIR VALUE MEASUREMENTS

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. This guidance defines fair value, establishes a framework for measuring fair value and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Financial standards established a three-level hierarchy for fair value measurements based upon the inputs to the valuation of an asset or liability. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. However, in accordance with Subtopic 820-10, certain investments that are measured at net asset value per share (or its equivalent) are not classified in a fair value hierarchy. All assets held by the Plan that are valued at fair value are measured at net asset value per share at December 31, 2024 and 2023.

NOTE C | FAIR VALUE MEASUREMENTS

The master separate account (MSA) consists of sub-accounts and each sub-account invests directly in shares of an underlying mutual fund, and earnings on amounts invested in sub-accounts will vary depending on the performance of its underlying fund. The value of a participant's interest in a sub-account is expressed as the number of accumulation units held multiplied by an accumulation unit value. The accumulation unit value varies daily in relation to the underlying fund's investment performance. The value also reflects deductions for fund fees and expenses and the administrative expense, if any.

Units held in the MSA are valued using the NAV practical expedient of the MSA as reported by the account managers of the underlying subaccounts. The NAV practical expedient is based on the fair value of the underlying assets owned by the MSA, minus its liabilities, and then divided by the number of units outstanding. The MSA can be redeemed daily, and there are no redemption restrictions or notice requirements. The MSA consists solely of investments in mutual funds registered with the Securities and Exchange Commission. The fair value of the MSA was \$ 26,488,018 and \$ 22,459,979 at December 31, 2024 and 2023, respectively. Additional information on the MSA, which is a direct filing entity, can be found by viewing the U.S. Department of Labor Form 5500.

NOTE D | GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan allows participants to invest in a fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company (Minnesota Life) totaling \$ 6,365,202 and \$ 6,657,573 at December 31, 2024 and 2023, respectively. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon by the issuer and may not be less than 1.5%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE D | GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events could potentially limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (such as complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without consent of the issuer.

NOTE E | PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F | TAX STATUS

The Plan is intended to be qualified under Section 401(a) and tax exempt under Section 501(a) of the Internal Revenue Code. The Plan is a non-standardized pre-approved profit sharing plan with CODA and obtained its last approval letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the letter. However, the administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G | INFORMATION PREPARED AND CERTIFIED BY INSURANCE CARRIER

The insurance carrier also certified the interest income of \$ 134,252 and \$ 145,452 in 2024 and 2023, respectively, the interest on participant loans of \$ 20,442 and \$ 14,252 in 2024 and 2023, respectively, and the net appreciation of assets of \$ 3,778,599 and \$ 3,970,138 in 2024 and 2023, respectively.

NOTE H | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I | PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Minnesota Life Insurance Company, an affiliate of Standard Insurance Company. Standard Insurance Company is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

NOTE J | CORRECTIVE DISTRIBUTIONS

In addition to the 401(k) plan, the Company sponsors Lange Companies, Inc. Employee Stock Ownership Plan which is also a defined contribution plan. In order to remain compliant under ERISA and IRS regulations, total combined annual Plan contributions for each participant are subject to certain limitations. For the years ended December 31, 2024 and 2023, this limitation was exceeded for 44 participants and 18 participants, respectively. As a result, for the years ended December 31, 2024 and 2023, \$ 633,321 and \$ 148,336, respectively, in participant deferrals are required to be returned.
