**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Boeing Employees' Credit Union 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Boeing Employees' Credit Union (Credit Union), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Credit Union is the Plan's sponsor and serves as Plan administrator.

Eligibility: Employees of the Credit Union are eligible to participate in the Plan upon reaching age 18.

Contributions: Each year, participants may contribute between 1% and 80% of pretax annual compensation as defined in the Plan. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Employees may make an irrevocable election to designate contributions as Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Credit Union matches 50% of employee contributions up to 6% of eligible compensation deferred to the Plan. The Credit Union may also make discretionary profit sharing contributions to the Plan as determined by its Board of Directors. No discretionary profit sharing contributions have been made since the Plan's inception. Contributions are subject to regulatory limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Credit Union's contribution and (b) Plan earnings (losses). Certain ordinary and necessary administrative fees are deducted from participant accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Credit Union's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within 10 years. Under the terms of the Plan agreement, Plan loans will carry a fixed rate of interest of one percent above the prime rate as supplied by Reuters. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through December 2034.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their vested account balance, or annual installments over a five-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals can be taken at age 59½.

Forfeitures: Forfeitures of employer contributions are used to offset future employer contributions or administrative expenses of the Plan. During the year ended December 31, 2024, forfeitures of \$538,500 were applied to offset employer contributions reflected in the financial statements. The remaining balance of forfeitures available to offset future matching contributions or administrative expenses as of December 31, 2024 was \$218,032.

Plan Termination: Although it has not expressed any intent to do so, the Credit Union has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Credit Union contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefit payments to participants are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Credit Union and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, global events and credit risks. Due to the level of risk associated with certain investments it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair values of participation units held in collective trusts are based on the net asset values (NAV) per unit as reported by the fund managers. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The collective trusts provide for daily redemptions by the Plan. The trustee for the Vanguard Target Retirement Trusts may restrict redemptions in the event of market closure or during other emergency circumstances as deemed by the Trustee.

The trustee for the Morley Stable Value collective trust provides for daily redemptions by the Plan provided that the withdrawal is made for the purposes of paying benefits to an owed individual and the withdrawal is made to an investment vehicle that does not compete with the collective trust as determined by the Trustee. In such cases, the transferred assets must be held in a noncompeting investment alternative for a minimum of 90 days before a subsequent transfer to a competing investment alternative may occur.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Credit Union, and certain others. Certain administrative functions are performed by officers or employees of the Credit Union. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Credit Union. Fidelity Management Trust Company is a service provider to the Plan during the year and, therefore, the Plan's payment of fees to Fidelity Management Trust Company qualify as party-in-interest transactions. The plan's record keeping agreement with Fidelity Management Trust Company provides for certain fees received from mutual fund providers, including 12b-1 fees, to be credited back to the plan on a pro-rata basis for participants that invest in eligible funds. Any remaining unallocated participant revenue credits are used to reduce administrative expenses of the plan. These transactions are parties-in-interest transactions. All other administrative fees paid qualify as parties-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Plan is a volume submitter Plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Boeing Employees' Credit Union 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Boeing Employees' Credit Union (Credit Union), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Credit Union is the Plan's sponsor and serves as Plan administrator.

Eligibility: Employees of the Credit Union are eligible to participate in the Plan upon reaching age 18.

Contributions: Each year, participants may contribute between 1% and 80% of pretax annual compensation as defined in the Plan. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Employees may make an irrevocable election to designate contributions as Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Credit Union matches 50% of employee contributions up to 6% of eligible compensation deferred to the Plan. The Credit Union may also make discretionary profit sharing contributions to the Plan as determined by its Board of Directors. No discretionary profit sharing contributions have been made since the Plan's inception. Contributions are subject to regulatory limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Credit Union's contribution and (b) Plan earnings (losses). Certain ordinary and necessary administrative fees are deducted from participant accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Credit Union's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within 10 years. Under the terms of the Plan agreement, Plan loans will carry a fixed rate of interest of one percent above the prime rate as supplied by Reuters. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50% with various maturities through December 2034.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their vested account balance, or annual installments over a five-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service withdrawals can be taken at age 59½.

Forfeitures: Forfeitures of employer contributions are used to offset future employer contributions or administrative expenses of the Plan. During the year ended December 31, 2024, forfeitures of \$538,500 were applied to offset employer contributions reflected in the financial statements. The remaining balance of forfeitures available to offset future matching contributions or administrative expenses as of December 31, 2024 was \$218,032.

Plan Termination: Although it has not expressed any intent to do so, the Credit Union has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Credit Union contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefit payments to participants are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Credit Union and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, global events and credit risks. Due to the level of risk associated with certain investments it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair values of participation units held in collective trusts are based on the net asset values (NAV) per unit as reported by the fund managers. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The collective trusts provide for daily redemptions by the Plan. The trustee for the Vanguard Target Retirement Trusts may restrict redemptions in the event of market closure or during other emergency circumstances as deemed by the Trustee.

The trustee for the Morley Stable Value collective trust provides for daily redemptions by the Plan provided that the withdrawal is made for the purposes of paying benefits to an owed individual and the withdrawal is made to an investment vehicle that does not compete with the collective trust as determined by the Trustee. In such cases, the transferred assets must be held in a noncompeting investment alternative for a minimum of 90 days before a subsequent transfer to a competing investment alternative may occur.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Credit Union, and certain others. Certain administrative functions are performed by officers or employees of the Credit Union. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Credit Union. Fidelity Management Trust Company is a service provider to the Plan during the year and, therefore, the Plan's payment of fees to Fidelity Management Trust Company qualify as party-in-interest transactions. The plan's record keeping agreement with Fidelity Management Trust Company provides for certain fees received from mutual fund providers, including 12b-1 fees, to be credited back to the plan on a pro-rata basis for participants that invest in eligible funds. Any remaining unallocated participant revenue credits are used to reduce administrative expenses of the plan. These transactions are parties-in-interest transactions. All other administrative fees paid qualify as parties-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Plan is a volume submitter Plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**NOTE 6 - TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
