# HOLTHOUSE CARLIN & VAN TRIGT LLP 401(K) PLAN AND TRUST II

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following is a brief description of the Holthouse Carlin & Van Trigt LLP 401(k) Plan and Trust II (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory 401(k) and profit-sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC), covering eligible employees, as defined, of Holthouse Carlin & Van Trigt LLP (the Company). The Plan is funded by employee and employer contributions. At December 31, 2024 and 2023, the assets of the Plan were maintained in investment funds held by Fidelity Management Trust Company. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

#### **Eligibility**

The Plan was established for employees of Holthouse Carlin & Van Trigt LLP who are in the following classification groups: business management staff (except for account coordinators), paraprofessionals, staff accountants, advanced accountants, senior accountants, supervising senior accountants, managers, senior managers, and principals ("eligible employees"). Partners, account coordinators and administrative employees of the Company are eligible to participate in the Holthouse Carlin & Van Trigt LLP 401(k) Plan and Trust (the "HCVT Plan"). Eligible employees are eligible to participate in the plan upon completion of three months of service. Participants are also eligible for a discretionary non-elective employer contribution on January 1 and July 1 following the completion of six months of service.

#### **Contributions**

Participants may authorize a pre-tax elective deferral contribution up to 75% of earnings or the maximum annual limitations as provided by the Internal Revenue Code. Roth elective deferrals are permitted under the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are automatically enrolled with a 6% elective deferral upon meeting the eligibility requirements unless a different affirmative election is made. Deferral percentages for participants automatically enrolled are auto increased by 1% each year up to 10%. During the years ended December 31, 2024 and 2023 discretionary non-elective employer contributions totaled \$1,981,853 and \$1,709,222, respectively.

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. Participants can access additional investments through self-directed brokerage accounts. Participants may change their investment allocation on a daily basis.

## 1. DESCRIPTION OF PLAN (Continued)

### **Plan Transfers**

During the year ended December 31, 2024, certain participants in the HCVT Plan changed their position from partner and became eligible to participate in the Plan and ineligible to participate in the HCVT Plan. As a result, an account balance totaling \$46,424 was transferred from the HCVT Plan during the year ended December 31, 2024.

During the year ended December 31, 2023, certain participants in the Plan were promoted to partner and became eligible to participate in HCVT Plan and ineligible to participate in the Plan. As a result, an account balance totaling \$2,113,079 was transferred from the Plan for the year ended December 31, 2023.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 from their funds up to a maximum amount, which is the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years but may exceed five years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

### **Withdrawals and Distributions**

Unless a participant elects otherwise, distributions are made as soon as practical after the participant's normal retirement date or actual retirement date occurs. Participants may also receive their accumulated vested benefits held by the Plan's trustee upon permanent disability or in the event of death prior to termination of employment. Participants may elect either a lump-sum amount, installment payments, or an annuity.

Participants may also receive in-service withdrawals at age 59 ½ and hardship distributions under certain circumstances, as defined in the Plan Document. In addition, participants may receive distributions of their vested portion of employer contributions if the employee has a minimum of 60 months of participation or the employer contributions have been in the participant's account for at least 24 months, as defined by the plan document.

### **Vesting**

Participants are immediately 100% vested in their elective deferral contributions, employer QNECs and rollover contributions. Vesting in the Company's non-elective contribution is based on years of continuous service. A participant is 100% vested after three years of credited service.

### **Forfeited Accounts**

Forfeitures of nonvested separated participants are available to be applied toward future employer non-elective contributions. Forfeitures of \$25,663 and \$30,570 were used to reduce non-elective contributions made to the Plan for the years ended December 31, 2024 and 2023, respectively. There were \$37,418 and \$23,980 of forfeited nonvested accounts at December 31, 2024 and 2023, respectively.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Valuation of Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold or held during the year.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Administrative Expenses**

Investment fees are paid by the Plan. Administrative expenses that are not paid by the Plan are paid by the Company.

### **Income Taxes**

The Plan has received a volume submitter profit sharing plan with CODA letter response from the Internal Revenue Service (the "IRS") dated June 30, 2020, stating that the IRS does not have a ruling or determination on whether the company's plan qualifies under Code Section 401(a) but an employer who adopts the Plan qualifies under Section 401(a) of the Internal Revenue Code (the "IRC"), and therefore, the related trust is exempt from taxation. Subsequent to this determination by the Internal Revenue Service, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Payment of Benefits

Benefits are recorded when paid.

## 3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years ended December 31, 2024 and 2023, has been derived from information provided by Fidelity Management Trust Company, the trustee of the Plan, and has been certified by them as complete and accurate.

## 4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Topic 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes to valuation methodologies in 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Values are determined based on quoted market prices in active markets.

*Self-directed brokerage account:* Self-directed brokerage account consists of mutual funds, common stocks, and money market accounts the values of which are determined based on quoted market prices in active markets.

*Common collective trusts:* Valued at the net asset value (NAV) of units of the collective trusts, using independent pricing services approved by the trustee. The net asset value is based on the fair value of the underlying investments held by the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no unfunded commitments or redemption restrictions.

*Stable value fund:* Valued at the NAV based on contractual terms of the underlying guaranteed investment contracts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant-directed exchanges to another investment option may be made on any business day, provided that the exchange is not directed into a competing fund, in which case there is a 90-day holding period.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The New York Life Anchor Account seeks to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates. The Fund seeks to provide participants with a low-risk, stable value option that offers competitive yields, and limited volatility by investing in a group annuity contract issued by New York Life Insurance Company. Principal and accumulated interest guarantees are provided by New York Life, subject to the terms of the group annuity contract. The Fund crediting rate is subject to change daily. The Contracts and securities purchased for the fund are backed solely by the financial resources of the issuers of such Contracts and securities. There are certain restrictions, for example, withdrawals prompted by certain events (e.g., layoffs, early retirement windows, spin-offs, sale of a division, facility closings, plan terminations, partial plan terminations, changes in laws or regulations) may be paid at the market value of the fund 's securities, which may be less than the book value balance. Certain investment options offered within the Plan (e.g., money market funds, short term bond funds, certain asset allocation/lifecycle funds and brokerage window) may be deemed by the Contract issuers to "compete" with this fund. The terms of the Contracts prohibit a direct exchange from this fund to such competing funds. Instead, exchanges must first occur to a non-competing fund for 90 days. While these requirements may seem restrictive, they are imposed by the Contract issuers as a condition for the issuer's promise to pay certain withdrawals and exchanges at book value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes receivable from participants of \$563,364 and \$516,071 as of December 31, 2024 and 2023, respectively, with interest rates ranging from 5.25% to 10.50% qualify as party-in-interest.

#### 6. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

#### 7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
