Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Jockey Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to the Financial Statements

1. Description of the Plan

The following description of the The Jockey Club 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and intended to qualify under Section 401(a) of the Internal Revenue Code. The Plan became effective January 1, 1998 and was restated effective April 19, 2022. Participating Employers are: Equibase Company, LLC, Axcis Information Network and Blood-Horse, LLC. The Jockey Club and all Participating Employers (collectively, the Employer, Plan Sponsor and Plan Administrator) are bound by the terms of the Plan and Trust Agreement.

Eligibility

Employees who are at least 21 years of age are eligible to participate in the Plan on their hire date. Eligible participants can enter the Plan on the first day of the quarter on or following their date of hire. Participants are eligible for safe harbor and discretionary matching contributions after one year and 1,000 hours of service. Participants are eligible for discretionary non-elective matching contributions after one year and 1,000 hours of service as long as they complete at least 1,000 hours of service during the plan year.

Contributions

Participants may contribute up to the maximum allowable contribution, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute Roth 401(k) elective deferrals on a post-tax basis, as well as amounts representing distributions from other qualified defined contribution plans. Employer safe harbor contributions are equal to 3% of eligible compensation, as defined in the Plan adoption agreement. The employer safe harbor contributions totaled \$950,214 for the year ended December 31, 2024. During the year ended December 31, 2024, the Plan Sponsor made a discretionary matching contribution equal to 50% of the participant's elective contributions, up to 6% of eligible compensation, as defined in the Plan adoption agreement. The discretionary matching employer contribution totaled \$546,636 for the year ended December 31, 2024. There was no discretionary nonelective contributions for the year ended December 31, 2024. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Plan Sponsor's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to the Financial Statements, continued

1. Description of the Plan, continued

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Participants are vested in the Plan Sponsor's discretionary nonelective and discretionary matching contributions according to the following schedule:

If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

Notes Receivable from Participants

Participants may borrow up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months, with a minimum of \$1,000. Loan terms can be up to 5 years for general purposes, or 20 years for the purchase of a residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$5,000 (excluding amounts attributable to rollover contributions) may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account, or roll it over into an Individual Retirement Account or other qualified retirement plan. On termination of service, a participant whose vested account balance is not greater than \$5,000 (excluding amounts attributable to rollovers) will receive his or her benefits as a single lump sum payment.

Notes to the Financial Statements, continued

1. Description of the Plan, continued

Forfeited Accounts

The Plan allows forfeitures to reduce Plan Sponsor contributions and administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,482 and \$11,679, respectively. During 2024, forfeitures totaling \$11,000 were used to reduce matching contributions.

Revenue Credit Program

The Plan provides for a revenue credit program in connection with revenue sharing with certain investment managers. The amounts may be used to pay Plan expenses or allocated to eligible participant accounts. During 2024, the Plan used \$1,835 from the revenue credit program to pay for qualified Plan expenses, which was placed in an ERISA account. Unused revenue credit program accounts totaled \$5,442 and \$7,277 at December 31, 2024 and 2023 respectively.

Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, continued

Contributions

Contributions from Plan participants and the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan adoption agreement.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions and notes receivables from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 1, 2025, the date that the financial statements were available to be issued.

3. Information Certified or Provided by Trustee

The Plan's asset information included in this note and throughout the Plan's financial statements and supplemental schedules was prepared by or derived from information provided by Fidelity Management Trust Company (Fidelity), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that asset information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor's not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

Fidelity also certified to the completeness and accuracy of \$3,377,075 of net realized and unrealized appreciation in the fair value of investments, \$1,327,855 of interest and dividends related to the investments, and \$32,121 of interest income on notes receivable from participants for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at cost which approximates fair value.

Collective trust: Valued based on the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

4. Fair Value Measurements, continued

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

The following table summarized investments measured at fair value based on NAV per share as of December 31:

5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity was the trustee throughout the year ended December 31, 2024 as defined by the Plan and therefore, these transactions qualify as party-in-interest. Administrative expenses of \$78,438 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Fidelity Investments Institutional Operations Company, LLC for recordkeeping services, TRG Advisors, Inc. for investment advisory services, and Dean Dorton Allen Ford, PLLC for audit services. These transactions qualify as party-in-interest.

Additionally, indirect fees are paid to the trustee based on investment account values; therefore, these transactions qualify as party-in-interest. For the year ended December 31, 2024, indirect fees paid to the trustee ranged from 0.01% and 0.78% of the investment account. The fees are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a volume submitter plan document sponsored by the Plan Sponsor. An opinion letter was received from the IRS, dated June 30, 2020, which states that the volume submitter plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

8. Prohibited Transaction

During the years ended December 31, 2024 and 2020, participant withholdings in the amount of \$8,610 and \$1,000, respectively, were not remitted within the appropriate time period by the Plan Sponsor. This transaction constitutes a prohibited transaction as defined by ERISA. The late contributions, including earnings, were corrected during the year ended December 31, 2024. The Plan Sponsor is aware of the occurrence and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period.
