### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the RNR Holiday RV, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### Note 1 – Description of the Plan

The following description of the RNR Holiday RV, Inc. 401(k) Retirement Plan (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- a. **General** – The Plan is a defined contribution plan qualifying as a salary reduction plan as defined in Section 401(k) of the Internal Revenue Code (IRC). To be eligible to make an employee or Roth deferral, employees must have attained age 18 and worked two months of service with RNR Holiday RV, Inc. (the Company). To be eligible for employer matching or profit-sharing, employees of the Company must have attained age 18 and worked one year of service in which they completed 1,000 hours. The entry date is the first day of the month following eligibility requirements for employee deferrals, match, or profit-sharing. The Plan also allows discretionary nonelective employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **Contributions** – Each year participants may contribute up to 100% of pre-tax annual compensation up to a maximum of \$23,000 and \$22,500 (participants ages 50 and over may contribute a maximum of \$30,500 and \$30,000 for the years ended December 31, 2024, and 2023, respectively, as defined in the Plan and by the IRC. The Plan was amended January 1, 2016, to have an automatic enrollment and qualified default investment alternative. The automatic enrollment allows the plan administrator to enroll certain employees in the Plan who have been hired after January 1, 2016, with an automatic deferral amount of 4% compensation to be withheld from each paycheck as a pre-tax elective deferral to the Plan in the American Funds Target Date Series. Participants may change their deferral percentage at any time. The Plan also allows participants to make rollover contributions from other qualified plans. Contributions received in excess of eligible amounts as determined by ADP testing are refunded back to the participants within 2½ months after year end.
- c. **Participant accounts** – Participants self-direct the investment of their account balance. Each participant's account is credited with the participant's deferral contributions and allocations of (a) the Company's matching contributions, (b) the Company's discretionary contributions, and (c) plan earnings or losses. Each account is also charged with an allocation of the administration expenses of selected funds. Employer contributions are allocated based on the employee's authorized deferral and the Plan's matching limit described above. Earnings allocations are based on participant investment selections and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### Note 1 – Description of the Plan (Continued)

- d. **Vesting** – Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in employer matching and discretionary contributions is based on years of service. A participant is 100% vested after six years of credited service according to the following schedule:

- e. **Payment of benefits** – Upon termination of service, a participant shall receive a lump-sum amount or equal installments. In-service withdrawals due to hardships are permitted.
- f. **Forfeited accounts** – Forfeitures occur when a participant separates from service before becoming 100% vested in matching or discretionary contributions. The Plan allows forfeitures to be used to reduce administrative fees or as a supplement to future employer contributions. For the years ended December 31, 2024 and 2023, forfeitures of \$14,940 and \$8,120, respectively, were used to reduce employer contributions.
- g. **Administrative expenses** – Fees charged for investment supervision, professional fees, management services, and participant distributions are paid directly by the Plan and recorded as deductions to net assets available for benefits. Loan administration fees are charged directly to the participant’s account and are included in administrative expenses. All other Plan administrative expenses are paid by the Company.
- h. **Notes receivable from participants** – Participants may borrow up to the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan to be repaid in level installments every payroll period via payroll deduction. The loans are secured by the participant’s account balance and bear interest at the rate of prime plus 1% interest rate in effect when the loan is made. Participants should refer to the Plan’s loan policy agreement for a more complete description of the Plan’s provisions. Loans go into default if payments are not received for four consecutive months, and the remaining balance is considered a deemed distribution.

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America as applied to employee benefit plans and in accordance with the plan agreement.

### Note 2 – Summary of Significant Accounting Policies (Continued)

- b. **Investment valuation** – The Plan’s investments are stated at fair value. Quoted market prices are used to value investments. Pooled separate accounts are valued at the net asset value of shares held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.
- c. **Income recognition** – Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Net appreciation in fair value of investments includes both realized and unrealized gains and losses on the Plan’s investments and is recognized as investment income or loss in the annual statements of changes in net assets available for benefits.
- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Excess contributions payable** – Amounts payable to participants for years ended December 31, 2024 and 2023, totaling \$66,260 and \$100,791, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as excess contributions payable with a corresponding reduction to 2024 and 2023 contributions. The Plan distributed the 2024 excess contributions on February 25, 2025.
- f. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.
- g. **Subsequent events** – Subsequent events have been evaluated through September 25, 2025, the date these financial statements were available to be issued.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Level 1* – The Plan has no investments that are classified as Level 1 for the years ended December 31, 2024 and 2023.

*Level 2* – The Plan has no investments that are classified as Level 2 for the years ended December 31, 2024 and 2023.

*Level 3* – The Plan has no investments that are classified as Level 3 for the years ended December 31, 2024 and 2023.

#### **Investments measured at net asset value (NAV):**

Pooled separate accounts are valued at NAV provided by the investment manager. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The fair value of units in pooled separate accounts is determined by dividing the market value of the fund by the total number of units in the fund.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Changes in Fair Value Levels

### Note 4 – Information Reported and Certified by the Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by John Hancock Life Insurance Company, the custodian of the Plan, for the year ended December 31, 2024, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- (a) Investments as indicated on the statements of net assets available for benefits;
- (b) Net change in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

### Note 5 – Parties-in-interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

The third-party administrator of the Plan provides financial, recordkeeping, and administrative services to the Plan for which all fees are paid by the Company.

Certain plan investments are held in investment funds managed by John Hancock Life Insurance Company, which is a custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### Note 6 – Tax Status

The IRS has determined and informed the Plan that it is qualified, and the Plan is tax-exempt under appropriate sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's Board of Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6 – Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

### **Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and there would be a complete distribution of the assets to the participants.
