Note 1. Description of Plan and Summary of Significant Accounting Policies

Plan Description

The following description of the Tacala, LLC 401(k) Retirement Savings Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General** - The Plan is a defined contribution plan, created on January 1, 1996, covering all non-highly compensated employees (excluding union, non-resident aliens, and residents of Puerto Rico) of the Tacala companies, Tacala, LLC, Tacala Georgia Corp., Tacala Tennessee Corp., and Tacala Austin Group (collectively, the Company) who have at least three consecutive months of service and have attained the age of twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. **Contributions** - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. For each Plan year, the Company may make a discretionary employer contribution equal to a uniform percentage of the elective contributions of each participant.
- C. **Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution periodically as such contributions are made to the Plan. Plan earnings are credited on a daily basis. Allocations are based on participant earnings or account balances, as defined in the Plan agreement.
- D. **Vesting** - All contributions by participants, as well as earnings on those contributions, are fully vested for participants in the Plan. The Company's matching contribution for participants is vested 20 percent per year and is 100 percent vested after five years of credited service.
- E. **Participant Loans** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding balance of loans during the one-year period ending on the date before the new loan is made, or the greater of one-half of the present value of the participant's vested interest account. The loans are secured by a portion of the participant's vested account equal to the loan amount and bear interest at a rate commensurate with local prevailing rates as determined annually by the Plan Sponsor. Principal and interest is paid ratably through payroll deductions.

- G. **Payment of Benefits** - Upon retirement (early and normal), death or total and permanent disability, a participant (or beneficiary) may elect to receive the entire amount of his/her account in one lump sum payment. If employment is terminated for reasons other than retirement, death, or disability, participants may elect to receive a distribution of their vested account balance. The Plan also allows for withdrawal of funds for in-service and hardship distributions if certain conditions are satisfied. Upon termination, vested account balances that do not exceed \$5,000 will be automatically distributed to the participant.
- H. **Administration** – The Standard Insurance Company has been appointed custodian of the Plan. All funds in the Plan are held in trust by the custodian. Certain administrative expenses for custodian fees and record-keeping fees are paid directly by the Plan.
- I. **Forfeited Accounts** - If any portion of a participant’s account is forfeited during a plan year, it will be used to reduce future Employer contributions payable under the Plan. Forfeited non-vested accounts were \$5,437 and \$7,900 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to offset employer contributions in the amount of \$7,900 and \$9,039, respectively.

**Basis of Accounting**

The Plan's policy is to prepare its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Revenues are recognized in the period in which they are earned. Expenses are recognized in the period in which they are incurred.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Sponsor, Tacala, LLC, determines the Plan’s valuation policies. See Note 7 for more information concerning fair value measurement.

Basis of Accounting - Continued

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in fair value of investments is the difference between the proceeds received or aggregate fair value of investments determined at the end of the year and the aggregate fair value of investments determined at the beginning of the year or cost if acquired during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various pooled separate accounts and mutual funds as investment options which invest in any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Market risks include global events which could impact the value of investments.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Note 2. Plan Amendments

On March 21, 2024, the Plan was amended, effective January 1, 2024, to conform the employer's operation of the Plan in accordance with the IRS EPCRS Self-Correction Program. The amendment updated employee eligibility requirements.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100% vested in their accounts.

Note 4. Party-In-Interest Transactions

The investments of the Plan are shares of pooled separate accounts and stable value fund managed by the custodian; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services rendered by The Standard Insurance Company that have been included in administrative expenses in the accompanying financial statements amounted to \$58,593 and \$47,649 during December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee received compensation from the Plan for these services.

Note 5. Information Prepared and Certified by Custodian (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard Insurance Company, the Custodian, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

Note 6. Tax Status

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan. Further, the Plan has been amended since receiving the determination letter for the prototype adopted by the Plan. The Plan Administrator believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Generally Accepted Accounting Principles (GAAP) requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Fair Value of Assets and Liabilities

The Plan accounts for fair value measurements in accordance with FASB ASC 820. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued daily at the quoted net asset value (“NAV”) of shares held by the plan at year end, NAV equals fair value.

*Guaranteed investment contract:* Valued at net asset value as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The objective of the Standard Stable Asset Fund is to provide liquidity and safety of principal, along with a competitive, guaranteed rate of return. The fund's strategy is to invest the deposits of plan participants as part of its general account assets, which include its fixed income securities portfolio and its commercial mortgage loan portfolio. A participant's return is determined by a declared interest rate, which is accrued daily and compounded quarterly.

Note 8. Concentration of Investments

Note 9. ERISA Bond Requirement

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024 and 2023, the Plan's sponsor maintained bond coverage in the amount of \$2,000,000.

Note 10. Prohibited Transactions

During the year ended December 31, 2023, the Plan Sponsor inadvertently failed to deposit \$14,913 of participant contributions within the timeframe required by the DOL. The DOL considers late deposits to be nonexempt prohibited transactions. The Company took corrective actions with regards to Plan Year 2023 late remittances and remitted lost earnings during the year ended December 31, 2024.

Note 11. Subsequent Events

The Plan's management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to update minimum required rollover amount, catch-up contribution requirements and limits, distribution language, implement a Qualified Disaster Relief Distribution, and allow long-term, part-time employees with two consecutive years to be eligible.

Signed October 6, 2025, and effective October 12, 2025, the Plan was amended to update the recognition of service with other employers to include 7Brew, with respect to employees hired on or after July 24, 2025.
