Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Parker Automotive Group Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Note 1 – Description of the Plan

The following description of the Parker Automotive Group Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- a. **General** – The Plan is a defined contribution plan qualifying as a salary reduction plan as defined in Section 401(k) of the Internal Revenue Code (IRC). It covers all employees of Parker Automotive Group (the Company) over the age of 18 who have completed one eligible year of service and have been credited with at least 1,000 hours of service in that year. The Plan also allows discretionary nonelective employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **Contributions** – Each year participants may contribute up to 90% of pretax annual compensation as defined by the Plan and by the Internal Revenue Service (IRS) limitations. Contribution limits were \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants ages 50 and over were eligible to contribute an additional \$7,500 as catch-up contributions during the years ended December 31, 2024 and 2023. Participants may change their deferral percentage at any time. The Plan also allows participants to make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Company matching contributions are allocated to participants based on the first 3% of pay contributed to the Plan by each employee.

The Company made discretionary profit-sharing contributions totaling \$1,461,269 and \$1,716,400 for the years ended December 31, 2024 and 2023, respectively. The contributions are included as receivables on the statements of net assets available for benefits.

- c. **Participant accounts** – Participants self-direct the investment of their account balance. Each participant's account is credited with the participant's deferral contributions and allocations of (a) the Company's matching contributions, (b) the Company's discretionary contributions, and (c) plan earnings or losses. Each account is also charged with an allocation of the administrative expenses of selected funds. Employer contributions are allocated based on the employee's authorized deferral and the Plan's matching limit described above. Earnings allocations are based on participant investment selections and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. **Vesting** – Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon. Vesting in employer matching and discretionary contributions is based on years of service. A participant is 100% vested after five years of credited service according to the following schedule:

- e. **Payment of benefits** – Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account or to receive the vested interest on an installment basis. Vested interests of less than \$5,000 will be distributed in a lump sum.
- f. **Forfeited accounts** – Forfeitures occur when a participant separates from service before becoming 100% vested in matching or discretionary contributions. The Plan allows forfeitures to be used to reduce administrative fees or as a supplement to future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$81,606 and \$128,708, respectively. For the years ended December 31, 2024 and 2023, \$130,087 and \$92,765 of forfeitures were used to reduce administrative fees, respectively.
- g. **Administrative expenses** – Fees charged for investment supervision, professional fees, management services, and participant distributions are paid directly by the Plan and recorded as deductions to net assets available for benefits. All other plan administrative expenses are paid by the Company.
- h. **Notes receivable from participants** – Participants may borrow up to the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan, to be repaid in level installments every payroll period via payroll deduction. The loans are secured by the participant’s account balance and bear interest at the rate of 1.00% over the prime interest rate in effect when the loan is made. New participant loans were issued at interest rates of between 8.75%-9.50% during 2024 and 8.50%-9.50% during 2023, depending on when the loan was issued. Participants should refer to the Plan’s loan policy agreement for a more complete description of the Plan’s provisions. Loans go into default if payments are not received for four consecutive months, and the remaining balance is considered a deemed distribution.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America as applied to employee benefit plans and in accordance with the plan agreement.
- b. **Investment valuation and income recognition** – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- c. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.
- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.
- f. **Subsequent events** – Subsequent events were evaluated through August 1, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 3 – Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 – Mutual funds are valued at the net asset value of shares held by the Plan at year end.

Level 2 – The Plan had no investments that are classified as Level 2 for either year ended December 31, 2024 or 2023.

Level 3 – The fair value of real estate is based on an appraisal from a certified real estate appraiser as of the end of the year. The value of this asset is subject to ordinary risks in the real estate market. As of December 31, 2024 and 2023, the value of the property at Snake River Road in Asotin, Washington, was appraised at \$578,000. There were no purchases or sales of Level 3 real estate investment. There was appreciation in fair value of \$-0- during the years ended December 31, 2024 and 2023.

The cash surrender values (CSV) of life insurance are provided by the insurance carrier at year end. The values approximate the fair value of the individual policies which are not actively traded on any exchange, are not observable, and are considered within Level 3 of the valuation hierarchy. The fair value determined by the insurance carrier is based on the cash surrender value of each policy when the Plan is the beneficiary. There was \$6,042 and \$5,160 of appreciation in cash surrender values during the years ended December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by Capital Bank and Trust Company, the Plan's trustee, not be subjected to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedule.

The following information has been certified by Capital Bank and Trust Company as complete and accurate:

- (a) Mutual funds as indicated on the statements of net assets available for benefits;
- (b) Net appreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- (c) Supplemental schedule – assets held for investment.

Note 5 – Compliance Test Correction

The Plan failed the Average Deferral Percentage tests during the years ended December 31, 2024 and 2023. This test compares the average deferral percentage of the higher paid group to the lower paid group. If the average of the two groups differs more than 2%, refunds of excess contributions must be issued. The Plan issued refunds to correct the test both years.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions, and there would be a complete distribution of the assets to the participants.

Notes to Financial Statements

Note 7 – Related-party and Party-in-interest Transactions

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Real estate is being held by the Plan for a single participant, James Parker, a shareholder of the plan sponsor. These transactions qualify as related-party transactions.

Break-Thru Benefits, LLC, provides certain accounting and participant account maintenance to the Plan. Certain plan assets are managed by American Funds. Northwestern Mutual provides life insurance coverage to certain participants in the Plan. Break-Thru Benefits, LLC, is the Plan's third-party administrator, American Funds is the Plan's investment custodian, and Northwestern Mutual provides cash surrender values of life insurance policies held by the plan; therefore, these transactions qualify as party-in-interest transactions.

Note 8 – Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the IRC and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable determination letter from the IRS but has since been amended. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement dates. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
