Note 1 - Plan Description

The following description of Honigman LLP Medical Benefit Plan (the "Plan") provides only general information. The Plan provides medical, vision, and prescription drug benefits to Honigman LLP's (the "Firm") partners and employees and their dependents. The Plan is a self-funded plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Eligibility

The Plan covers all U.S.-based full-time nonattorney staff members, associate attorneys, managers of the Firm, and their eligible dependents. The Firm charges full-time nonattorney staff members, associate attorneys, and managers of the Firm a portion of the average cost to provide medical coverage to them and their dependents. These required contributions are made on a pretax basis via payroll withholdings. Eligible dependents are covered only upon election by the employee. The Plan also covers most full-time partners of the Firm and their dependents, for whom member contributions are not required. Employer contributions are remitted to the Plan as benefit payments are processed by the Plan's claims administrator.

For staff members and their dependents, participation in the Plan is effective on the first day of the calendar month following the individual's date of hire, provided an enrollment application is filed with the plan administrator within 30 days from the date of hire. If an employee fails to file an enrollment application within 30 days from the date of hire, he or she shall not become a participant until the enrollment application is filed at the next open enrollment period, special enrollment period, or if the employee experiences a qualified change event.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the cash basis of accounting. Under the cash basis of accounting, contributions are recognized when received rather than when earned, and claims and other expenses are recognized when paid rather than when the related obligations are incurred.

Rebates

Prescription drug rebates are recorded as an offset of prescription drug and medical claims paid. In 2024, the Plan received approximately \$987,000 in prescription drug rebates and approximately \$177,000 in medical rebates.

Use of Estimates

The preparation of financial statements in conformity with the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Notes to Cash Basis Financial Statements

December 31, 2024 and 2023

Note 3 - Benefit Obligations

Benefit obligations related to medical costs incurred but not reported and known claims payable, determined at the estimated ultimate cost of settlement as of December 31, 2024 and 2023, totaled approximately \$753,000 and \$403,000, respectively. The benefit obligations are determined using historical trend information and estimated amounts for claims payments after year end.

The excess of the above obligations over the net assets available for benefits, and any deficiency in net assets available for benefits, will be funded through employer contributions to the Plan. Funding for benefit obligations is not required under ERISA.

Note 4 - Federal Income Taxes

The Plan is a welfare benefit plan for medical benefits, as described in Section 105 of the Internal Revenue Code. The Plan is funded by a grantor trust used for participant contributions; accordingly, federal income tax on trust earnings is paid by the Firm.

Note 5 - Administration of Plan Assets

The Plan is supervised by the pension and benefits committee of the Firm.

Some administrative expenses of the Plan are paid directly by the Firm. These expenses are not significant to the Plan's net assets for the year ended December 31, 2024. The Plan's claims administrators are Caremark, Inc. and Blue Cross Blue Shield of Michigan. The claims administrators' primary function is to verify and process participant benefit claims. At December 31, 2024, the Firm had stop-loss insurance for individual claims in excess of \$250,000. There was no aggregate stop-loss insurance in 2024.

Note 6 - Plan Modification, Amendment, and Termination

Although it has not taken steps to do so, the Firm has the right under the Plan to amend, modify, and terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, the Firm will contribute the amount necessary to pay its share of the medical benefits incurred to the date of plan termination. The Firm periodically considers modifications and amendments to the Plan, but no such modifications or amendments have been formally recommended at the present time, nor is the Firm currently contemplating termination of the Plan.
