Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the financial statements of Honigman LLP Dental Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits - cash basis as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits - cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Honigman LLP Dental Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1981 to provide dental care benefits to Honigman LLP's attorneys and staff members and their families. Effective July 1, 1999, the Plan was amended to become a self-funded plan. The Plan's sponsor, Honigman LLP (the "Firm"), maintains a contract with Delta Dental Plan of Michigan for the purpose of providing claims payment services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All U.S.-based attorneys and staff members become eligible for benefits under the Plan on the first day of the month following 30 days of continuous full-time employment with the Firm, provided an enrollment application has been filed prior to that date. If an individual fails to file an enrollment application within this 30-day period, coverage will not begin until the first day of the month following the date the application is filed. There were 677 and 694 attorneys and employees and their dependents participating in the Plan as of December 31, 2024 and 2023, respectively.

Contributions

The Firm contributes such amounts to provide the Plan with assets sufficient to meet the benefits to be paid to plan participants. No participant contributions are permitted except for contributions for continuing coverage made under the provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the cash basis of accounting. Under the cash basis of accounting, contributions are recognized when received rather than when earned, and claims are recognized when paid rather than when related obligations are incurred.

Benefit Obligation

Benefit obligations represent the ultimate cost of the Plan of settling claims incurred but not reported for active participants as of December 31, 2024 and 2023, which totaled approximately \$90,000 and \$77,000, respectively. The benefit obligations are due to benefits earned being in excess of benefits paid for the current period. The benefit obligations are determined using historical trend information and estimated amounts for claims payments after year end.

The excess of the above obligations over the net assets available for benefits and any deficiency in net assets available for benefits will be funded through employer contributions to the Plan. Funding for benefit obligations is not required under ERISA.

The changes in benefit obligations for the year ended December 31, 2024 resulted from \$669,297 of benefits earned and \$656,297 of claims paid.

Funding

The Firm contributes the amounts necessary to provide assets sufficient to meet the benefits to be paid to plan participants and to service providers to cover possible future claim amounts in the event of terminating with the service provider. Other deposits of \$46,300 at December 31, 2024 and 2023 represent a prefunding to the Plan's service provider to cover future claims if the Plan were to terminate services with them. Subsequent to December 31, 2024, the Firm paid an additional prefund in the amount of \$11,600 to the Plan's service provider on behalf of the Plan.

Former participants who elect to continue coverage under COBRA are required to remit up to 102 percent of the applicable premium, calculated as allowed by Internal Revenue Code Section 4980B.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The cash basis financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the cash basis financial statements were available to be issued.

Note 3 - Tax Status

The Plan is a welfare benefit plan for medical benefits, as described in Section 105 of the Internal Revenue Code. The Plan is funded by a grantor trust used for participant contributions; accordingly, federal income tax on trust earnings is paid by the Firm.

Note 4 - Administration of Plan Assets

The Plan is supervised by the pension and benefits committee of the Firm. All administrative expenses of the Plan are paid directly by the Firm. Administrative expenses of the Plan paid by the Firm were approximately \$67,000 for the year ended December 31, 2024. The Plan's claims administrator is Delta Dental Plan of Michigan. The claims administrator's primary function is to verify and process participant benefit claims.

Note 5 - Plan Modification, Amendment, and Termination

Although it has not taken steps to do so, the Firm has the right under the Plan to modify, amend, or terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, the Firm will contribute the amount necessary to pay its share of the medical benefits incurred to the date of plan termination. The Firm periodically considers modifications and amendments to the Plan, but no such modifications or amendments have been formally recommended at the present time, nor is the Firm currently contemplating termination of the Plan.
