Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Notes to Financial Statements

Note 1. Plan Description

The following description of the Centre for Neuro Skills 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all full-time employees of Centre for Neuro Skills and affiliated companies (the Company) who have reached the age of 21 and completed one month of service. An employee is not eligible if the employee is a union employee, nonresident alien or a leased employee. Effective November 15, 2024, the exclusion applies to intern employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participating employees are allowed to make pre-tax and Roth contributions of their gross wages through payroll deductions up to 100% of wages, pursuant to Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled unless they elect to not participate in the Plan. The initial deferral rate begins at 4% of eligible compensation and increases automatically on an annual basis by 1%, up to a maximum of 10%. Effective September 2020, the Plan was amended to no longer provide safe harbor contributions. The Plan sponsor may make discretionary employer matching contributions. Effective November 15, 2024, the Plan sponsor may also make discretionary qualified nonelective contributions. For the year ended December 31, 2024, the discretionary employer match contribution was 50% of employee deferrals up to 6% of compensation, a total of \$1,329,877. Contributions are funded annually.

Forfeitures of terminated employees' non-vested account balances can be used to offset employer contributions or Plan expenses. Forfeitures used to offset Plan fees during the year ended December 31, 2024 were \$55,877. The forfeiture balance at December 31, 2024 and 2023 was \$61,660 and \$81,554, respectively.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses and expenses. Allocations are based on the participant earnings or account balances, as defined by the Plan. All amounts in participant accounts are participant-directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes to Financial Statements

Vesting:

Participants are immediately vested in their voluntary contributions. A participant is 100% vested in safe harbor contributions plus actual earnings thereon after 2 years of credited service. A participant is 100% vested in employer matching contributions and employer nonelective contributions plus actual earnings after 3 years of credited service.

Notes receivable, participants:

A participant may obtain one loan of a minimum of \$1,000 not to exceed 50% of their vested account balance. The maximum aggregate dollar amount of loans outstanding to a participant may not exceed \$50,000, as aggregated with all participant loans from other employer qualified plans. The loans are secured by 50% of the participant's vested interest in the Plan.

Benefit payments and withdrawals:

On termination of service, participants may elect to receive a lump-sum distribution equal to the vested value of their account or leave the value of the account on deposit until normal retirement age (67). Distribution of the vested value will also occur in the case of death or disability. If a participant's vested account balance is less than \$7,000, they will automatically receive payment in the form of a lump-sum. Participants with vested account balances greater than \$7,000 may elect payments in the form of either a lump-sum, installments or a combination of lump-sum and installments.

Participants may request for in-service withdrawals if a participant has reached age 59 ½ and may elect to withdraw all or a portion of the entire vested account while participant is still employed by the Company. The participant may also request for hardship withdrawals in which the participant may withdraw employee pre-tax and Roth contributions to satisfy specific and heavy financial needs in accordance with Internal Revenue Service regulations.

Amounts allocated to accounts of persons who, at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes to Financial Statements

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable, participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits:

Benefits are recorded when paid.

Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Tax status:

The Plan has been qualified under Section 401(k) of the Internal Revenue Code and, accordingly, income of the Plan is exempt from Federal and state income taxes. The Plan obtained its latest favorable determination letter in June 2020 in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 3. Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their discretionary employer contributions. Payment of such amounts will be made to participants by the Trustee, as directed by the Plan Administrator.

Note 4. Fair Value Disclosures

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common/collective trusts: The fair value of the common/collective trusts are from broker quotations from market makers, original transaction prices and recent transactions in recent or similar instruments.

Registered investment companies (mutual funds): The fair values of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Brokerage account: The account is a self-directed brokerage account which is invested in unit investment trusts. A unit investment trust holds fixed portfolio of securities, in this case the account consists of holdings in exchanged-traded funds.

Notes to Financial Statements

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Party-in-Interest Transactions

For the year ended December 31, 2023, certain Plan investments were shares of common/collective trusts and registered investment companies (mutual funds) managed by Charles Schwab Trust Company, the Plan's trustee during 2023 and during the period from January 1, 2024 through November 15, 2024. Fees paid by the Plan to all service providers amounted to \$258,180 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rule.

Charles Schwab & Co., Inc. receives revenue from registered investment companies and collective trust fund service providers for services it provides to the funds. This revenue can be used to offset certain expenses of the Plan. Any excess amount is remitted to the Plan. The Plan received \$901 in revenue-sharing income for the year ended December 31, 2024 and was used to offset expenses.

Note 7. Reconciliation of Financial Statements to Form 5500

Certain balances included on Schedule H Part I and II on the Annual Return/Report of Employee Benefits Plan (Form 5500) have been reclassified for purposes of presentation in the financial statements.
