### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Stanford Contributory Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Stanford Contributory Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of Stanford Contributory Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stanford Contributory Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

# Stanford Contributory Retirement Plan

## Notes to Financial Statements

---

### **Note 1 – The Plan and its Significant Accounting Policies**

**General** – The following description of Stanford Contributory Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a 403(b) defined contribution plan that was established in 1957 by the Board of Trustees of the Leland Stanford Junior University (the University) to provide benefits to eligible employees, as defined in the plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – The University has appointed the plan administrator to manage the operation and administration of the Plan. The Retirement Program Investment Committee (the RPIC), acting in a fiduciary capacity, has established formal investment policies for the assets associated with this Plan. The university has also contracted with Fidelity Management Trust Company (Fidelity), Teachers Insurance and Annuity Association of America and College Retirement Equity Fund (TIAA and CREF), Empower Annuity Insurance Company (FKA: The Prudential Insurance Company of America) (Empower), and Ascensus Trust Company (FKA: Newport Trust Company) (Ascensus) to act as the custodians and third-party administrators to process and maintain participant data records.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). These principles require management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** – The investments are reported at fair value and contract value. The Plan's custodians certify the contract value of the guaranteed interest accounts and the fully benefit-responsive fixed annuity contracts, and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the University and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative plan fees. Investment related expenses are included in net appreciation in fair value of investments.

**Income taxes** – The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for participants under Section 403(b).

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure in or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible, in the near term, that changes in market values, interest rates, or other factors would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Note 2 – Investments**

The valuation methodology, investment types, and fair value hierarchy are discussed below.

#### *Valuation Methodology*

To the extent available, the Plan's investments are recorded at fair value based on quoted prices in active markets. The Plan's investments that are listed on any U.S. or non-U.S. recognized exchanges are valued based on readily available market quotations. When such inputs do not exist, fair value measurements are based on the best available information and usually require a degree of judgment.

### *Investment Types*

**Registered investment companies and money market funds (includes self-directed brokerage accounts)** – Valued at the daily closing price as reported by the fund. The registered investment companies and money market fund, held by the Plan, are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds, held by the Plan, are deemed to be actively traded.

**Pooled separate accounts** – Units held in pooled separate accounts (PSA) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information.

**Fixed annuity contracts** – Valued at contract value which is based on the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals. The annuity contracts are valued using discounted cash flow or theoretical transfer (exit value), which is equal to contract value. Fair value is determined and reported to the Plan by TIAA and CREF. Investments in the contracts are intended to be held until maturity; early liquidation could result in a termination charge.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### *Fair Value Hierarchy*

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The plan administrator determines the fair value measurement policies and procedures in accordance with RPIC's Investment Policy Statement. The policies and procedures are reassessed at least annually. At that time, the unobservable inputs used in the fair value measurements are evaluated based on current market conditions and other third-party information.

#### Note 3 – Related-Party Transactions

Certain plan investments are managed by the custodians, or affiliates of the custodians of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### Note 4 – Participation And Benefits

**Eligibility** – Employees of the University, except for students, are eligible to participate in the tax-deferred feature of the Plan immediately. Employees of the university, except for students, part-time employees scheduled to work less than 20 hours a week or less than 1,000 hours over a 12-month period, temporary and casual employees, are eligible to participate in the Plan upon completing one year of service.

**Participant contributions** – Participants may elect to have the University contribute their eligible pre-tax or after-tax compensation to the Plan up to the amount allowable under the plan document and current income tax regulations. Participants may elect to have the University contribute their eligible Roth contributions utilizing after-tax contributions. The Plan permits the automatic enrollment of eligible employees in the Plan with a contribution of 4% of eligible compensation, unless the employee affirmatively elects otherwise. Participants who have the University contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

**Employer contributions** – The University is allowed to make basic and matching contributions, as defined in the plan document. In 2024 and 2023, the University made a basic contribution of 1% to 5% of each eligible participant’s basic compensation, depending on years of eligible service, as defined in the plan document. The University also made a matching contribution of 1.5% to 5% of each eligible participant’s compensation, depending on the participant’s elected deferral, as defined in the plan document. Additionally, the University made a temp/casual (TC) contribution to participants who were credited during the plan year with 1,000 hours of service as a temporary or casual employee. Depending on the participant’s years of eligible service, the TC contribution is 1% to 3% of the participant’s TC compensation.

**Vesting** – Participants are immediately vested in their accounts.

**Participant accounts** – Each participant’s account is credited with the participant’s contribution, plan earnings or losses, and an allocation of the university’s contribution, if any. Allocation of the University’s contribution is based on participant contributions or eligible employee compensation, as defined in the Plan.

**Payment of benefits** – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, receive their total benefits in a lump sum amount or in the form of an annuity equal to the value of the participant’s interest in their account. The Plan allows for the lump sum distribution of participant account balances that do not exceed \$1,000 at the discretion of the plan administrator.

**Notes receivable from participants** – The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their account balance with Fidelity. The notes receivable are secured by the participant’s balance. Such notes receivable bear interest at the prime rate plus 1% at the time of the request and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of a principal residence in which case the maximum repayment period may be 15 years. Outstanding notes receivable at December 31, 2024, carry interest rates ranging from 4.25% to 9.50% maturing November 2039.

Participants may borrow directly from TIAA and CREF (loan proceeds are not made from plan assets), subject to certain limitations. Applicants receiving a loan from TIAA and CREF are required to pledge 110% of the loan amount in a TIAA and CREF account of the Plan for the period of time the loan is outstanding.

#### Note 5 – Certified Information

#### **Note 6 – Plan Termination or Modification**

The University intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Trustees and subject to the provisions of ERISA.

#### **Note 7 – Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued and determined there were no subsequent events.
