

NOTE 1 - PLAN DESCRIPTION

The following description of the Laundry and Dry Cleaning Workers Local No. 52 Health and Welfare Trust (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for more complete information.

The Plan, a multiemployer defined benefit health and welfare plan, that was established in 1959 for the purpose of providing medical, dental, vision, prescription, life and accidental death, and dismemberment benefits to certain employees (and dependents) employed by employers signatory to a collectively bargaining agreement with Workers United – Western States Regional Joint Board requiring contributions to the Laundry and Dry Cleaning Workers Local No. 52 Health and Welfare Trust. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the participating employers and union representatives.

The Plan provides health and welfare benefits including medical, dental, vision, prescription drug, life and accidental, and dismemberment benefits to certain employees (and dependents). All dental, vision, prescription drug, disability and certain medical claims are self-funded by the Plan. All life and certain medical benefits are insured with premiums paid by the Plan.

The Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-funded medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Under the terms of the contract individual participant claims incurred in excess of \$275,000, and/or in excess of \$275,000 in the aggregate, are reimbursed to the Plan.

For new employees hired before October 3, 2013, initial eligibility is received on the first day of the month following three consecutive monthly contributions provided at least one contribution has been made on their behalf. For an employee hired on or after October 4, 2013, initial eligibility is received on the first day of the month following the employee's sixtieth day of employment provided at least one contribution has been made on their behalf.

Special eligibility rules apply to participants returning to the industry.

Under the terms of a master collective bargaining agreement, the Plan received monthly contributions per eligible participant ranging from \$535 to \$612.

Certain collective bargaining agreements call for participant contributions to share the monthly cost of benefits and participant self-pay contribution for dependent covered benefits.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Plan Termination

This Plan shall continue in effect so long as there exists between any of the employers and the union a collective bargaining agreement providing for contributions to the Plan or after the expiration thereof so long as any of the employers continue to make contributions to the Plan in accordance with the terms of such expired agreement. Thereafter, this Plan shall terminate, and the Board of Trustees shall allocate all assets of the Plan in a manner consistent with the provisions of the ERISA. Under no circumstances shall any portion of the Plan, directly or indirectly, revert or accrue to the benefit of any employer or any union. Upon termination of the Plan, the trustees shall continue as trustees for the purpose of dissolution, with full powers as herein provided, and may execute any and all necessary documents.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Presentation

The financial statements of the Fund are prepared in accordance with generally accepted accounting principles.

Use of Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein, IBNR, eligibility credits, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Employer Contributions and Contributions Receivable

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a monthly contribution rate per covered employee and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. Management of the Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023 there was no allowance taken.

The Plan has an employer payroll audit system in place in which the employers are randomly audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits, but due to the uncertainty of collections, no estimates of the contributions will be accrued.

Payment of Benefits

Claims and insurance premiums are recorded when paid.

Investments

If available, quoted market prices are used to value investments. Many factors are considered in arriving at that fair value. In general, however, U.S. Government Bonds and Certificates of Deposits are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Purchases and sales of securities are recorded on a trade-date basis. Investment in mutual funds are valued at quoted market prices, which represents the net asset value. Interest income is recorded on the accrual basis.

FASB Accounting Standards Codification (ASC) 820, which defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). ASC 820 emphasizes that fair value is a market-based measurement that should be determined based on the assumptions market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, ASC 820 establishes a fair value hierarchy that distinguishes between (1) market participant assumptions developed based on market data obtained from sources independent of the Plan (observable inputs) and (2) the Plan's own assumptions about market participant assumptions developed based on the best information available in the circumstances (unobservable inputs). Valuation techniques used to measure fair value shall maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels, as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide information on an ongoing basis.

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. If the asset or liability has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets which are not active;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 inputs are unobservable inputs for the asset or liability. Unobservable inputs are used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at the measurement date. Unobservable inputs reflect the Plan's own assumptions that market participants would use in pricing the asset or liability (including assumptions about risk). Unobservable inputs are developed based on the best information available in the circumstances, which might include the Plan's own data. However, market participant cannot be ignored and, accordingly, the Plan's own data used to develop unobservable inputs are adjusted if information is reasonably available without undue cost and effort that indicates that market participants would use different assumptions.

Investments (Continued)

The methods of valuation described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

The plan does not have any Level 3 investments and there were no significant transfers between Level 1 and Level 2 investments during the year ended December 31, 2024.

The fair value hierarchy of ASC 820 gives the highest priority to Level 1 and the lowest priority to Level 3 inputs.

The mutual fund is valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is open-end mutual fund that is registered with the SEC. The fund is required to publish their daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

NOTE 3 – BENEFIT OBLIGATIONS

Plan obligations for claims incurred but not reported at December 31, 2024 and 2023 are estimated based on an analysis of claims paid subsequent to the Plan year end. These amounts are recorded as amounts currently payable on the statements of benefit obligations.

As a result of eligibility provisions of the Plan, hours worked by participants through December 31, 2024 and 2023, produced eligibility through February 2025 and 2024, respectively. Accordingly, the accumulated eligibility credits at December 31, 2024 and 2023 was calculated by adding the total claims and premiums incurred and paid in the first two subsequent months after year end. The liability is recorded as other obligations for current benefit coverage at estimated amounts on the statements of benefit obligations.

NOTE 4 - INCOME TAXES

The Internal Revenue Service issued a favorable determination pursuant to Internal Revenue Code Section 501 (c) (9), and accordingly, the trust's net investment income is exempt from income taxes. The Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. Generally Accepted Accounting Principles requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income examination for years prior to 2022.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 6 - SIGNIFICANT TRANSACTIONS WITH PERSONS KNOWN TO BE PARTIES IN INTEREST

The Fund has contracted for administrative services with Benefit Programs Administration. The administrative fees paid to Benefit Program Administration for the year ended December 31, 2024 and 2023 was \$368,888 and \$323,008, respectively.

The fund also contracts with investment managers, consultants, attorneys, and auditors who are all known to be parties in interest.

NOTE 7 - SIGNIFICANT CONCENTRATIONS OF CREDIT RISK

The Fund's cash and cash activities are with US Bank. The accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

NOTE 8 - SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosures through September 25, 2025, the date the financial statements were available to be issued.


