## REPORT OF INDEPENDENT AUDITOR

To the Participants and Plan Administrator of

## **Basis for Opinion**

I am required to be independent of Outdoor Dimensions, LLC Profit Sharing Plan and Trust and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audit. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Outdoor Dimensions, LLC Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, I:

My audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedule of Schedule of Assets Held for Investment at December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, I compared such information to the related certified investment information.

In forming my opinion on the supplemental schedules, I evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1           SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Accounting Method** - The accounts of the plan are maintained and the accompanying financial statements have been prepared, on the modified cash basis. Investment income is recognized when received, and disbursements are recognized when made. Additionally, mutual fund investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the plan in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation, Transactions and Income Recognition -**

*General* - Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement and Disclosures*, and Accounting Standards Update (ASU) 2010-6, *Improving Disclosures about Fair Value Measurements*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable input be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

**NOTE 1      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)**

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods for each of the Plan's investment classes are presented below.

*Inputs and Valuation Methods -*

*Mutual funds* - The fair value of the mutual funds is generally based on quoted market prices in active markets (Level 1).

*Valuation Methods, Consistency* - The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition* - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date.

**Administrative Expenses** -. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Participant Loans** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Risks and Uncertainties** - The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits

**NOTE 2            DESCRIPTION OF THE PLAN**

The following description of Outdoor Dimensions 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the summary plan description for more complete information.

**General** – During the 1980’s, Outdoor Dimensions (the Sponsor) established the Outdoor Dimensions 401(k) Profit Sharing Plan and Trust. The Plan was established to provide retirement benefits for eligible employees of the Sponsor. The Plan is financed by contributions from participants and by the net earnings of the investments of the Plan. This is a defined 401(k) plan covering all eligible employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants may elect to defer a portion of their compensation, not to exceed the legal maximum, as calculated in accordance with the Internal Revenue Code. The limit for regular contributions for 2024 and 2023 was \$23,000 and \$22,500, respectively. The limit for catch-up contributions for 2024 and 2023 was \$7,500. The Plan allows for discretionary employer profit sharing contributions and discretionary matching contributions. Matching contributions are made equal to 25% of participant deferrals, not to exceed 5% of participant compensation as defined by the Plan.

**Participation and Vesting** - After completing six months of continuous employment, an employee over 21 years of age may participate in the Plan. Participants are fully vested in their contributions and matching contributions as of the first day of eligibility. Participants are 0% vested in profit sharing contributions until 2 years of service time have been met, at which time, they are 20% vested. This vesting % increases by 20% a year until 6 years of service time are met, at which time, a participant is 100% vested in profit sharing contributions.

**Investment Options** - Contributions to the Plan are invested as directed by the participant in various mutual funds. If participants do not direct the investment of their contributions, the contributions will be directed according to the provisions of the Plan.

Participants may evaluate their own investment goals and objectives and choose the mutual funds best suited to achieve those goals and objectives. Poor investment performance by the investments selected by the participants may cause their balances to be lower than the amounts contributed to the Plan.

**NOTE 2 DESCRIPTION OF THE PLAN (CONT'D)**

**Notes Receivable from Participant** - Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate (as published by the Wall Street Journal) plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability, retirement or other termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or may request a direct rollover to another qualified plan that accepts direct rollovers. The Plan allows for automatic lump-sum distribution of participant account balances that do not exceed \$5,000.

**Forfeitures** – Forfeitures will be allocated in the same Plan Year in which the forfeitures occur and can be used to offset employer contributions or pay for plan expenses. No forfeitures were used to reduce employer contributions or plan expenses for the years ended December 31, 2024 and 2023.

**Allocation Provisions** – Plan investment income from each mutual fund selected by a participant is allocated to individual participant accounts proportionally based on the beginning of the year balance of a participant's account plus annual contributions.

**NOTE 3 PRIORITIES UPON TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. Benefits would be distributed to the participants and their beneficiaries as if the Plan had not been terminated until all participants' accounts have been completely distributed to, or for the benefit of, the participants or their beneficiaries in accordance with the Plan.

**NOTE 4. TAX STATUS**

The Plan adopted the American Funds Distributors, Inc. Defined Contribution Prototype Plan and Trust, which received a favorable opinion letter from the Internal Revenue Service, dated March 31, 2014, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 5 FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan’s administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information (such as mutual funds) certified by Capital Bank & Trust Company, the custodians of the Plan, as complete and accurate, except for comparing such information certified by the custodians to information included in the Plan’s financial statements, as follows:

**NOTE 7 RELATED PARTY TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the plan sponsor and, therefore, these transactions qualify as party-in-interest transactions. No officer or employee of the Company receives compensation from the Plan.

Certain investments are managed by the investment advisors of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the investment advisors from Plan assets totaled \$15,858 and \$16,625 respectively, for the years ended December 31, 2024 and 2023, and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain administrative functions are performed by Capital Group Retirement Plan Services, the Plan's record keeper and fees are paid by plan participants. During the years ended December 31, 2024 and 2023, the record keeper received \$3,388, and \$2,581, respectively, in administrative fees from Plan assets which is included in administrative expenses on the statement of changes in net assets available for benefits.

**NOTE 8 SUBSEQUENT EVENTS**

Management has evaluated the impact of all subsequent events on the Plan through the date the financial statements were available to be issued and has determined that there were no subsequent events requiring adjustment or additional disclosure in the financial statements.
