Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Panel Specialists, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Panel Specialists, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF THE PLAN

General – The Panel Specialists, Inc. 401(k) Plan is a defined contribution retirement plan covering substantially all employees of Panel Specialists, Inc. The Plan provides for retirement, disability, death, and employment termination benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is a defined contribution plan within the meaning of Section 401(a) and Section 401(m) of the Internal Revenue Code.

Contributions – Participant contributions are made via payroll deductions. Each participant may elect to have compensation deferred up to the maximum percentage or stated amount allowable, not to exceed the limits of code section 3401(a). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. As of January 1, 2010, participants are permitted to make Roth 401(k) deferrals and the deferrals are eligible for matching contributions under the plan. The Plan requires the company to make matching contributions to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant's elective deferrals; however, it is limited to 4% of the participant's compensation, as defined in the plan document.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution, and plan earnings. Participants are responsible for certain plan fees and charges. The employer is responsible for other administrative fees such as audit fees and third-party administrator fees. Investments are participant directed through Reliance Trust Company.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings on these amounts. Vesting in the Company's contribution portion of their accounts plus earnings is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Effective January 1, 2004, Panels Specialists, Inc. modified the Plan to allow the 401(k) Safe Harbor Provision. All contributions are 100% immediately vested, participant deferrals and employer contributions.

Participant Loans – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant may only have one loan outstanding at any time, unless the second loan is for a principal residence. Loan terms range up to five years, except in the case of a loan used for purchasing a principal residence for the participant, in which case the loan term shall not exceed ten years. The vested balance in the participant's account secures the loan. Prevailing interest rates are used. Interest rates range from 3.25% to 8.50%. Principal and interest is paid ratably through payroll deductions. These loans are regarded as a party-in-interest because of the relationship between the Plan and its participants.

Payment of Benefits – Upon termination of service due to retirement, disability, or death, the participant will receive the value of the vested interest in his or her account in the form of one lump-sum payment or partial withdrawals provided that the minimum withdrawal is \$1,000. Hardship distributions are permitted up to the lesser of 100% of the participant's vested interest or the amount necessary to satisfy the participant's heavy financial need. In-service distributions are permitted for participants who have reached either age 59½ or normal retirement age.

Forfeited Amounts – For the years ended December 31, 2024 and 2023, \$-0- was forfeited.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Nature of Investments – Investments consist of assets held in mutual funds and the fixed account of Reliance Trust Company. Reliance Trust Company has been appointed to provide all administrative service necessary to support the insurance contracts issued. Reliance Trust Company is the Plan's trustee.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Income from investments is recognized in the period in which it is earned.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold during the year and on investments held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 – INVESTMENTS AT FAIR VALUE

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Gains and losses (realized and unrealized) included in changes in net assets available for benefits are reported in net appreciation/depreciation in fair value of investments.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - INVESTMENT AT CONTRACT VALUE

As of December 31, 2024 and 2023, the Plan's group annuity contract with Standard Insurance Company is a fully benefit-responsive contract. Under the terms of the contract, participant-initiated transactions for the purpose of receiving benefits allowed under the plan, such as retirement, death, hardship, loan, required minimum distribution, and allowable in-service withdrawal, are completed at contract value without conditions, limits, or restrictions.

Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals. The Plan's Standard Stable Asset D contract value is a general liability against Standard Insurance Company on the Plan's behalf. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restriction may apply. The plan sponsor may choose to may the market value adjustment directly, if applicable, so that the participants' contract values are not affected. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 5 - INVESTMENT AT CONTRACT VALUE (CONTINUED)

A realized gain of \$5,621 and an unrealized gain of \$14,457 was recognized for the year ended December 31, 2024. A realized gain of \$1,416 and an unrealized gain of \$12,404 was recognized for the year ended December 31, 2023. The investment level is considered to be Level 2.

The contract value of the investment contract at December 31, 2024 and 2023, was \$313,937 and \$390,479, respectively. The interest rate was 2.1% and 1.8% for the years ended December 31, 2024 and 2023, respectively.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any full or partial termination, participants will become 100 percent vested in their accounts and shall not thereafter be subject to forfeiture, and all unallocated amounts, including forfeitures, shall be allocated to the accounts of all participants.

NOTE 7 – TAX STATUS

No provision has been made for federal income tax. A prototype plan is used by Panel Specialists, Inc. 401(k) Plan. In its latest determination letter dated June 30, 2020, the Internal Revenue Service states that an employer using the prototype plan may rely on the letter with respect to the qualification of its plan under Code Section 401(a). The Plan has been amended; however, the Plan administrator and the sponsor believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
