The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Events Occurring After Reporting Date

The plan administrator has evaluated events and transactions that occurred between December 31, 2024 and October 9, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

2. DESCRIPTION OF PLAN

The following description of the J-U-B Engineers, Inc. ("Company") 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments. Prior to February 1, 2024, eligibility to participate in the Plan was limited to employees of the Company who were regularly scheduled to work at least 1,000 hours during the year and who had completed one month of service. Union employees, leased employees, nonresident aliens, residents of Puerto Rico, and seasonal or temporary employees were excluded from the Plan.

Effective February 1, 2024, the Plan was amended to eliminate the one-month service requirement. Additionally, effective the same date, eligibility was expanded to include seasonal and temporary employees and those employees not regularly schedule to work at least 1,000 hours during the year.

Contributions. Each year, participants may contribute elective pre-tax and/or after-tax (Roth) contributions up to the limits provided by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a wide range of registered investment companies funds and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision (pre-tax deferral rate of 4%) whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect otherwise. Participants direct the investment of their contributions; however, if an investment directive is not received by the Plan, the contributions are invested in accordance with the default investment fund established under the Plan until changed by the participant.

The Company contributed by matching each participant's contribution. For 2024 and 2023, the Company adopted a safe harbor provision, matching 100% of each participant's contributions up to 4% of eligible compensation.

2. DESCRIPTION OF PLAN (CONTINUED)

Annually, the Company's Board of Directors determines the Company's profit sharing contributions, if any, to the Plan. For 2024 and 2023, the Company contributed 2% of eligible compensation as profit sharing. Company profit sharing contributions were allocated to active employees of the Company who were employed on the last day of the plan year and had 1,000 hours of service during the plan year. Participants direct the investment of the Company's contributions. Contributions are subject to certain limitations.

Participants' Accounts. Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in all contributions plus actual earnings thereon.

Payment of Benefits. On termination of service, a participant may elect to receive a lumpsum amount equal to the vested value of his or her account.

Notes Receivable from Participants. Participants may borrow from their account a minimum of \$1,000. The maximum amount of any loan is limited to the lesser of 50% of their vested interest or \$50,000. All loans are required to be repaid within five years unless the purpose of the loan is to acquire a principal residence. All loans are secured by the participants' vested interest in the Plan and possibly additional collateral. All loans bear interest at a rate commensurate with prevailing rates determined by the Trustees.

3. ADMINISTRATIVE EXPENSES

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. In addition, certain administrative expenses are paid directly by the Company, and are not reflected in these financial statements.

4. TAX STATUS

The Plan was amended and restated January 1, 2022. The plan restatement is a pre-approved 401(k) profit sharing plan offered by Standard Retirement Services, Inc. The pre-approved plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed was in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted market prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented, and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

7. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (The Standard). The Plan's contract value is a general liability against The Standard on the Plan's behalf and there are no particular segregated or identifiable assets of The Standard ascribed to the Plan's contract. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$7,270,961 and \$6,664,983, respectively. The crediting interest rates are set by The Standard using a process similar to that used by banks or other insurance companies for similar products. Such rates are reviewed and reset quarterly. The crediting rates as of December 31, 2024 and 2023 were 3.04% and 2.78%, respectively.

Certain events limit the Plan's availability to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

7. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The Standard may terminate the contract with 30 days advance written notice to the Plan for reasonable cause, which includes the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The Plan administrator does not believe that the occurrence of any such events are probable.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. PARTICIPANT TERMINATIONS

The vested portion of participants' accounts is distributed to terminated participants in accordance with their instructions and Internal Revenue Service regulations. Effective January 1, 2015, participants are immediately vested in all contributions plus earnings thereon, resulting in no forfeitures for employees terminated after that date. At December 31, 2024 and 2023, the forfeited nonvested account totaled \$6,852 and \$116, respectively. The forfeited account will be reallocated to participant accounts or used to pay administrative expenses.

10. RELATED PARTY TRANSACTIONS

The Plan invests in a general insurance contract issued by Standard Insurance Company. Administrative and investment management services are provided to the Plan by entities related to Standard Insurance Company.

11. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN (UNAUDITED)

Reliance Trust Company, custodian of the Plan's assets, holds the Plan's investment assets and executes transactions therein. Financial information relating to the assets is included in the accompanying financial statements and supplemental schedule and was obtained from data that has been prepared and certified to as complete and accurate by Reliance Trust Company. This information, which has not been audited by independent accountants, is summarized as follows:
