We have performed audits of the financial statements of Silverton Casino, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Silverton Casino, LLC 401(k) Plan (the Plan) provides general information about the Plan's provisions. Silverton Casino, LLC (the Company and Plan Administrator) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Administrator.

General

The Plan is a multiple employer defined contribution plan for eligible employees of the Company, and adopting employers, adopted effective July 1, 1997. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Plan Committee (the Committee) is responsible for the general administration of the Plan. John Hancock Trust Company LLC and John Hancock Retirement Plan Services (collectively, John Hancock) is the trustee and recordkeeper for the Plan.

Eligibility

Employees are eligible to participate on the entry date which is defined as the earlier of the first day of each calendar month coinciding with or following the date on which the eligibility requirements are met. Employees must be 18 years of age and have 90 days of service. Eligible employees will be automatically enrolled in the Plan at a 2% deferral rate unless the employee affirmatively elects not to participate in the Plan or elects to have another deferral percentage withheld. Union employees, nonresident aliens, and leased employees are not eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 60% of their eligible compensation, subject to Internal Revenue Code (the Code) limitations. Participants may also contribute rollover amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

Employees are eligible to receive a company contribution if they are 18 years of age and have at least one year of service, defined as at least 1,000 hours of service, to participate in the Plan.

Each participating employer may contribute a discretionary matching contribution. For the year ended December 31, 2024, the Company contributed was 50% of the first 5% of compensation that a participant contributes to the Plan. All other participating employers did not make a discretionary matching contribution for the year ended December 31, 2024. All contributions are subject to certain limitations of the Code.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants who are automatically enrolled have their contributions invested in the applicable lifecycle fund based on their age until

they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, rollover contributions, and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the discretionary matching contributions is as follows: 20% after one year of credited service, 40% after two years of credited service, 60% after three years of credited service, 80% after four years of credited service, and 100% after five years of credited service. Participants also become fully vested upon retirement due to disability, death, or termination of the Plan.

Forfeitures

Non-vested account balances of terminated participants will be forfeited: for participants, who have taken a distribution from the Plan, the later of the last day of the Plan Year during which the participant reaches the first anniversary of his termination or during which the participant takes a distribution from the Plan, or for participants, who have not taken a distribution from the Plan, as of the last day of the Plan Year during which the participant reaches the fifth anniversary of his termination date.

As of December 31, 2024 and 2023, there were \$461 and \$424, respectively, of forfeitures available to pay Plan administration fees and/or reduce future discretionary matching contributions. During the year ended December 31, 2024, \$31,859 of the available forfeiture balance was used to pay Plan administration fees and none were used to reduce the discretionary matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 less the participant's highest outstanding loan balance during the preceding 12 months or 50% of their vested account balances, whichever is less. Principal and interest is paid via payroll deductions over a maximum of a five-year period, except in limited circumstances, such as a loan to purchase a participant's principal residence, which has a maximum termination of 15 years. A participant may have no more than two loans outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. A participant's loan will be deemed distributed if a scheduled payment is not made by the end of the calendar quarter following the calendar quarter in which the payment was due. When a participant's loan is deemed distributed, the outstanding balance, including any accrued interest, may be subject to federal and state taxes.

Payment of Benefits

Upon separation from service with the Company, a participant may receive the value of the vested interest in his or her account as a lump-sum or installment distribution. In-service withdrawals are

available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal. Additionally, participant balances are normally distributed to the participant or his or her beneficiary at the time of retirement, disability or death.

Distributions of vested account balances less than \$7,000, are paid as a direct rollover to an individual retirement account in the name of the plan participant. Prior to January 1, 2024 the threshold was \$5,000. These mandatory distributions apply only to participants who have separated from service and do not affirmatively elect a distribution of their accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts, less any expenses chargeable to the Plan.

2. Summary of Significant Accounting Principles

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Participant deferral contributions and related discretionary matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation and in the year in which the contributions relate to the participant's compensation.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses.

3. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - Inputs to the valuation methodology are inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust - The MetLife Stable Value Fund is a collective investment trust that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV.

4. Certified Investment Information

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest income on notes receivable from participants, interest and dividend income, and net appreciation in the fair value of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the notes to financial statements.
- All investment amounts, except for notes receivable from participants, included in the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Company, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Related Party and Party-in-Interest Transactions

The Plan issues loans to participants, which are secured by the participant's account balances. Fees paid to John Hancock for administrative services totaled \$130,551 for the year ended December 31, 2024. Fees paid to the investment advisor totaled \$41,588 for the year ended December 31, 2024.

These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Delinquent Participant Contributions

During the 2024 Plan year, the Company failed to timely remit certain employee contributions to the Plan. The Company is working on calculating and funding lost earnings. See the attached Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.

9. Subsequent Events

Plan management evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements, except as disclosed below.

Effective April 1, 2025, Exchange Hotels Management, LLC, a participating employer of the Plan, will no longer be a participating employer of the Plan and spun-off approximately \$1,087,000 of assets as of May 12, 2025. As a result, the Plan will no longer be a multiple employer plan.
