## INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee  
Indian Health Center of Santa Clara Valley 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Indian Health Center of Santa Clara Valley 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Indian Health Center of Santa Clara Valley 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Indian Health Center of Santa Clara Valley 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Indian Health Center of Santa Clara Valley 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF THE PLAN

The following description of the Indian Health Center of Santa Clara Valley 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Indian Health Center of Santa Clara Valley (the "Center", "Plan Administrator", or "Employer"), pursuant to Section 401(a) and related provisions of the Internal Revenue Code (IRC), was established on July 1, 2000, and has been restated effective December 1, 2021. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the IRC.

Effective March 27, 2020, the Plan adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Center has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Center has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Center is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Center has delegated certain responsibilities for the operation and administration of the Plan. The Center entered into a service agreement with American United Life Insurance Company ("AUL" or the "Custodian") to provide custodial and recordkeeping services to the Plan.

Eligibility

Employees covered under the Plan include all employees, except those governed by a collective bargaining agreement, leased employees, part-time employees who work less than 1,040 hours per year, temporary employees, seasonal employees and non-resident aliens. There are no age requirements needed to enter the Plan. Employees are eligible to enter the Plan following the first day of the month upon completion of 60 days of service, as defined by the Plan.

Contributions

Participants may elect to contribute through payroll deductions amounts of their annual compensation as defined by the Plan, on a pre-tax or after-tax (as Roth) basis, up to a maximum amount allowed by the IRC. The Plan allows eligible participants who have attained age 50 before the end of the Plan year to make additional catch-up contributions to the Plan. Participants are allowed to roll over contributions from other qualified employer-sponsored retirement plans. Newly eligible employees are automatically enrolled in the Plan to defer 3% of their eligible compensation, unless the participant makes a contrary election, upon meeting the eligibility requirements.

The Center provides a safe harbor matching contribution equal to a uniform percentage of salary deferrals for all eligible employees who have completed 60 days of service. The matching contribution is equal to 100% of the participants' elective deferrals up to 3% of eligible compensation plus 50% of each participant's elective deferral of the next 2% but not to exceed 5% of eligible compensation.

The Plan allows for an additional discretionary Employer matching contribution. There were no discretionary Employer matching contributions to the Plan during the year ended December 31, 2024. Additionally, the Plan allows for non-elective discretionary profit sharing contributions. In order to share in the non-elective discretionary profit sharing contributions, participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year. There were no discretionary profit sharing contributions to the Plan during the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, the Employer's safe harbor matching contributions, discretionary matching and nonelective profit sharing contributions, an allocation or deduction of Plan earnings or losses, and charged with certain administrative expenses, as applicable. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchases and sales. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer discretionary matching contributions and the Center's safe harbor matching contributions plus actual earnings thereon. A participant is 100% vested in their employer non-elective discretionary profit sharing contributions after one year of credited service.

Forfeited accounts

The Plan provides that nonvested account balances of terminated employees (forfeited accounts) can be used to pay the Plan's administrative expenses or reduce employer contributions. Unallocated funds resulting from forfeited accounts totaled \$1,660 and \$0, respectively, as of December 31, 2024 and 2023. There were no forfeitures used to pay administrative expenses or reduce Employer contributions during the year ended December 31, 2024.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the prior twelve-month period. All notes receivable (or "loans") must be repaid within 5 years unless the loan is for the purchase of a principal residence for which the loan term may exceed 5 years. The loans are secured by the remaining vested balance in the participant's account and accrue interest at a rate equal to prime plus 1%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. All loans become immediately payable in the event of default, death, disability, or termination of employment. Outstanding notes receivable at December 31, 2024, carry interest rates between 4.25% and 9.00%, with maturities through April 2030.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship (as defined), disability, or death. If a participant's account balance is equal to or less than \$5,000, the balance will be distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. If the account balance is greater than \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, a partial withdrawal, installments over a period not longer than life expectancy or postpone payment to a later date and remain in the Plan, as described in the Plan documents.

In addition, participants are permitted to request a distribution from their vested accounts at any time after having attained age 59.5. Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described in the plan documents.

Administrative expenses

Administrative expenses are generally paid by the Center, but may, at the discretion of the plan administrator, be paid by the Plan. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. Such expenses include but are not limited to costs to process distributions, and loans. The Plan is not required to reimburse the Center for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract (the "contract"), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). Contract value is the amount participants would receive under the terms of the contract (Note 5).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the gains and losses on investments purchased, and sold, during the year.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Center, which is the pay date. Employer contributions are recorded in the year they are earned. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan, as of the last day of the Plan year.

Notes receivable from participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded when it is earned. If a participant ceases to make loan repayments and the plan administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses paid by the Plan are recorded when incurred and accruals are recorded when due.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. The Custodian (Note 1), determined to be a qualified institution, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefit for the year ended December 31, 2024;
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) ("supplemental schedule") as of December 31, 2024.

Accordingly, as requested by the Plan Administrator, the Plan's independent auditor performed no auditing procedures with respect to the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

- *Level 1* - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- *Level 2* - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; or
- *Level 3* - inputs to the valuation methodology are unobservable and significant to the fair value measurement of the assets or liabilities.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

*Separate Accounts*- Separate accounts held by the Plan are in the form of accumulation units. The value of the accumulation unit is determined at the close of each business day and is directly related to the net asset value of the shares of underlying investments adjusted for any dividends or distributions received and the daily equivalent of any fee charged pursuant to the contract. The value of each accumulation unit is published each business day by AUL. Each investment account is invested exclusively in shares of a specific mutual fund or other investment entities as directed by the contract holder and/or the participant. Separate accounts are included as Level 2 investments in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. As of December 31, 2024 and 2023, there were no restrictions on redemption or unfunded commitments for any of the major types of assets.

5. GUARANTEED ANNUITY CONTRACT WITH AUL

The AUL Stable Value Account ("account") is a fully benefit-responsive guaranteed interest account under a guaranteed annuity contract with AUL. Contributions are deposited into a non-unitized separate account. The contract provides a guaranteed effective interest rate of not less than 0%. The effective crediting rate for the period ended December 31, 2024 was 1.70%. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value account represents accumulated cash contributions made under the contract, plus interest credited to the contracts, less participant withdrawals and transfers and is held commingled with the general assets of AUL. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value.

The AUL Stable Value Account totaled \$2,610,185 and \$2,597,239 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due from the account is dependent on AUL's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. There are no unfunded commitments.

Certain events limit the ability of the Plan to transact at contract value with the AUL. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with AUL or with participants are probable at this time.

The account does not permit the respective issuer to terminate the account prior to the scheduled maturity dates, and as long as the Plan holds assets with AUL, the Plan is required to keep the account as an investment option in the Plan.

6. TAX STATUS

The Plan previously adopted the Non-Standardized Pre-Approved Profit Sharing Money Purchase with CODA Plan document (the "plan document"). The Internal Revenue Service has informed CBIZ Benefits & Insurance Services, Inc., a third party administrator, by a letter dated June 30, 2020, that its plan document is designed in accordance with applicable sections of the IRC, and is available for use by employers for the benefit of their employees. Plan management believes the Plan is designed and operating as a qualified plan, therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be party-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Some fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Center. The Plan is not required to repay expenses paid by the Center on its behalf.

Certain Plan investments are managed by the Custodian. Transactions in these funds are considered party-in-interest transactions under ERISA. Such transactions are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (continued)

The Plan is subject to revenue sharing. AUL has contractual arrangements with the investment management companies that provide mutual funds or collective trusts that underlie the investment options offered by AUL in the Plans group annuity contract. Pursuant to these arrangements, AUL receives revenue sharing payments from the investment management companies as compensation for providing Plan participant recordkeeping, communication, marketing, distribution, and other services to the investment management companies. The revenue sharing amounts consist of a portion of the expense ratio of the underlying fund and can take the form of 12b-1 fees, sub transfer agency fees, shareholder servicing fees, or other types of fees.

AUL earns interest on the aggregate cash balance held by AUL in its omnibus bank account with respect to contributions received but not allocated or benefits and other disbursements paid but not cashed or cleared by its bank. Such interest will be at money market rates applicable to very short-term investments and will be retained by AUL as compensation for the services provided to the Plan and its participants.
