Opinion

Notes to Financial Statements

1. DESCRIPTION OF PLAN

The following brief description of the Teter, Inc. Employee Stock Ownership Plan (the “Plan” or “ESOP”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – Teter, Inc., a California “S” Corporation (the “Company”), established the Plan effective January 1, 2022. The Plan operates, in relevant part, as a leveraged employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has an independent third-party trustee (the Trustee) who also serves as the custodian that holds the stock for the participants and the unallocated shares. The Plan is administered by the Plan Committee appointed by the Board of Directors of the Company. The Company is responsible for making contributions to the Plan.

On December 23, 2022, the Plan acquired all 1,000,000 outstanding shares of the Company’s common stock for \$15,500,000. The purchase was financed through a \$4,000,000 internal loan funded by the Company and a \$11,500,000 seller-financed note guaranteed by the Company. Subsequently, the Company assumed the seller-financed note and issued \$11,500,000 in replacement notes. The internal and external loans were consolidated into a single agreement (the “Refinanced Internal ESOP Note”), secured by the shares under a pledge agreement.

Eligibility – Employees of the Company are generally eligible and become a participant as of the initial entry date (i.e., January 1 of each Plan year) after attaining the age of 21 and completing one year of service (at least 1,000 hours during a Plan year) as defined in the Plan document. Participants who are members of a labor union, non-resident aliens, or leased employees do not meet these requirements and are generally not eligible for an allocation of Company contributions for such a year.

Contributions – The Company may make contributions in Company common stock to the Plan as the Company’s Board of Directors may, from time to time, deem advisable. The Company is obligated to make contributions to the Plan which, when aggregated with the Plan’s dividend and interest earnings, if any, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its note payable. The Company may not make a contribution to the Plan for any Plan year to the extent the contribution will exceed the Participants’ maximum permissible amount. Employee contributions are not permitted. Contributions are subject to certain Internal Revenue Service (IRS) limits.

Notes to Financial Statements

Payment of Benefits – Distributions from the Plan will be made for retirement, disability, death, or otherwise terminated employment with the Company. Distributions for retirement, disability, or death are made or commence within one year after the close of the Plan year following separation of service in the form of stock and/or cash. For account balances less than \$1,000, the Plan shall distribute the participant's balance in a single lump sum and/or installments as soon as administratively practicable. Effective January 1, 2024, for account balances that exceed \$1,000, but are equal to or less than \$7,000, and the participant does not elect to receive a distribution, the Plan will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator as soon as administratively practicable following the end of the plan year in which the participant incurred the separation from service. If a participant's vested balance exceeds \$7,000, distribution of benefits will be made in installment payments over a period generally not to exceed five years. Distributions for other separations from service will commence by the end of the fifth plan year following the plan year in which employment is terminated and are made in five annual installments.

Participants have the right to elect to receive the balance credited to their ESOP stock account in the form of Company stock, subject to the requirement that the Company common stock must immediately be sold to the Company or back to the Trust at a price equal to its fair market value. The amount to be distributed is based upon the immediately preceding valuation as of December 31 of the immediately preceding year.

Voting Rights – Each participant is entitled to direct the Trustee as to how to vote the shares allocated to his or her account with respect to certain extraordinary transactions (such as merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or any similar transactions that are specified in regulations interpreting Section 409(e)(3) of the IRC. Participants are notified prior to the time such rights are to be exercised). The Trustee shall vote for the shares of Company common stock which are not allocated to any participant, and the shares with respect to which no direction is received from the participant, in the manner determined by the Board of Directors of the Company.

Participant Accounts – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Dividends on the Company's common stock and all other income, losses, and expenses earned or incurred on Plan investments are allocated pro rata among the accounts of the participants in proportion to their account balances. The Company did not declare any dividends during the years ended December 31, 2024 and 2023.

Vesting – Vesting in the Company's contributions is based on years of service. A participant is 20% vested after two years of service, increasing 20% each year thereafter. A participant is fully vested at the earliest of six years of service, retirement, disability, or death.

Put Option – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to its participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to the participant's account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who are eligible and elect to diversify may a) receive a cash distribution, which may be rolled over to an individual retirement account to continue the deferral of taxation, or b) transfer such diversified amount to another qualified plan of the Company that allows employee-directed investments with at least three investment options as further described in the Plan. Participants eligible to diversify are required to make their election after year-end based on the number of shares of Company stock held in the participant's account at year-end.

Forfeitures – Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants for the years ended December 31, 2024 and 2023, were approximately \$21,000 and \$5,000, respectively. There were no unallocated forfeited accounts as of December 31, 2024 and 2023.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations – The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investments – The common shares of the Company are reported at fair value as of December 31, 2024 and 2023. The fair value of the common shares is determined annually, or more frequently if deemed necessary, by independent appraisal.

Benefit Payments – Benefits are recorded when paid.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset and liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. NOTE PAYABLE

In December 2022, the Plan entered into a \$15,500,000 term loan agreement with the Company. The proceeds of the loan were used to purchase 1,000,000 shares of Company common stock. Unallocated shares are used as collateral for the loan. Shares are released from collateral and allocated to participants as principal payments are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments divided by the total of the current year payments, plus all future years' principal and interest payments. A cash contribution of \$2,280,000 was made towards the note during the year

ended December 31, 2024; accordingly, 107,172 shares were released during the year then ended.

The agreement provides for the loan to be repaid over 18 years with a final payment due in December 2042. The scheduled annual payment consists of principal of \$1,700,000 and interest charged at a fixed rate of 4.34%. The carrying value of the note payable as of December 31, 2024, and 2023 was \$11,095,000 and \$12,795,000, respectively.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock and has a note payable to the Company. These transactions qualify as related-party and party-in-interest transactions. The Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

7. RISKS AND UNCERTANTIES

The Plan's investments consist of the Company's common stock, which are exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participation of all participants will end, and the accounts of each participant shall become 100% vested. Participant accounts will be distributed in accordance with the provisions of the Plan.

9. TAX STATUS

The Plan has received a determination letter from the IRS dated April 25, 2024, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
