Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of **Duffy Kruspodin, LLP 401(k) Profit Sharing Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to the Financial Statements

1. **DESCRIPTION OF THE PLAN**

The following description of the Duffy Kruspodin, LLP 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was formed on January 1, 2000. The Plan is a 401(k) Profit Sharing Plan covering all full-time employees of Duffy Kruspodin, LLP (the “Company” or the “Employer”) who have completed three months of service and are twenty one years of age or older. Employees who are covered by a collective bargaining agreement or who are non-resident aliens are not eligible. Eligible employees begin participating in the Plan on the first day of the month coinciding with, or next following, the date the employee meets the eligibility requirements. The Plan is designed to qualify under sections 401(a) and 401(k) of the Internal Revenue Code (the “Code”) as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrative Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan has arranged for Fidelity Management Trust Company (“Trustee”) to serve as trustee, and to provide record keeping services for the Plan.

Contributions

Each year, participants may contribute any amount of pretax annual compensation as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service (“IRS”). The Plan also allows for Roth elective deferrals by participants. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Unless opted out, eligible participants are automatically enrolled to a contribute at 4%. Participants direct the investment of their contributions into various investment options offered by the Plan. For each Plan year, the Company may elect to match a uniform percentage as determined each year by the employer. In addition, a profit sharing contribution may be contributed at the option of the Company. During the year ended December 31, 2024, the Company provided employer matching contributions of **\$140,518** to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching contribution, (b) Plan earnings, and (c) an allocation of the Plan’s administrative expenses. Allocations are based on participant earnings or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investments listed in the accompanying supplemental schedule of assets. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants may change their investment options on a daily basis.

Vesting

Participants are vested immediately in employee contributions, rollover contributions, and actual earnings thereon. Vesting in the Company's employer matching and profit sharing contributions is based on years of continuous service as follows:

1	25%
2	50%
3	75%
4	100%

Participants also become 100% vested in employer matching and profit sharing contributions upon death, disability as defined by the Plan, or normal retirement age 65.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Participant loans are secured by the participant's vested balance and bear an interest rate based on the prime interest rate plus 1%. The interest rates on outstanding notes receivable as of December 31, 2024 ranged from 4.25% to 9.50%, and maturities ranged from 2025 to 2028.

Benefit Payments

Participants may receive the vested portion of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Under certain circumstances, including financial hardship, participants may withdraw the vested portion of their Plan account. The plan administrator determines financial hardship. Benefit payments are made in a lump sum distribution or rollover contributions to another plan. The Plan provides for involuntary distribution methods if a terminated participant's account balance is \$5,000 or less.

Forfeitures

As of December 31, 2024 and 2023, the forfeited non-vested amounts were **\$4,963** and **\$6,081**, respectively. These amounts can be used to reduce future employer contributions or pay Plan expenses. During the year ended December 31, 2024 **and 2023**, the employer used **\$7,546** of forfeitures to pay Plan expenses or offset the employer contributions.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Revenue Recognition

Investments in mutual funds are stated at unit value, which is based on the aggregate fair value of the account in relation to the total number of units outstanding. Because the unit values are readily available, mutual funds are included with the fair value leveling. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Investments in corporate stocks and interest-bearing cash are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value for the money market account is valued by discounting the related cash flow based on current yield of similar investments with comparable duration. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. Net appreciation/ (depreciation) for each year includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Unit Values

Individual participant accounts for mutual funds are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Contributions Receivable and Allowance for Credit Losses

Employee and employer contributions which are withheld through payroll deductions and have not been credited to the participant accounts as of the end of the fiscal year are recorded as contributions receivable. An allowance for credit losses is deemed unnecessary and is not provided as of December 31, 2024 and 2023.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced, and a benefit payment is recorded. Principal and interest are paid to the Plan through payroll deductions. Notes receivable from participants are exempt party-in-interest transactions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Insurance Premiums

The Plan pays insurance premiums directly to the carrier on behalf of one of its participants.

Administrative Expenses

The plan sponsor pays the costs of administering the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

3. **TAX STATUS**

The Plan is set up as a volume submitter plan, which the Internal Revenue Service has advised qualifies under Section 401(k) of the Internal Revenue Code and is, therefore, exempt from federal income tax.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly Fidelity Management Trust Company, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments and notes receivable from participants:

- Cash
- Investments - at fair value
- Notes receivable from participants
- Interest and dividend income
- Interest income on notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

5. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value methods used by the Plan may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. PARTY-IN-INTEREST TRANSACTIONS

Plan contributions and investments are held and managed by Fidelity Management Trust Company, the Plan's trustee, which invests cash received, interest and dividend income, and makes distributions to participants. Therefore, these transactions are considered exempt party-in-interest transactions. The Trustee also administers the payment of interest and principal on the notes receivable from participants, which is reimbursed to the Trustee through contributions as determined by the Company. Notes receivable from participants are also considered to be party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date of the independent auditor's report, which is the date the financial statements were available to be issued. No events have occurred subsequent to December 31, 2024 requiring recording or disclosure in these financial statements.
