### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of The Loomis Communities 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of The Loomis Communities 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established on January 1, 2009. Loomis Communities, Inc. (the “Employer”) is the Plan’s administrator. The Plan covers all employees of The Loomis House, Inc., Loomis Communities, Inc. and Loomis Senior Living, Inc. (d/b/a Loomis Lakeside at Reeds Landing) (the “Participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant directed.

#### **Participant Contributions**

Participants may contribute Roth and tax deferred contributions up to 100% of their eligible compensation, as defined by the Plan, subject to dollar limits imposed by Federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”).

#### **Employer Contributions**

##### ***Discretionary Matching Contributions***

Each year, the Employer, at its discretion, may make a matching contribution. For the year ended December 31, 2024, the Employer discretionary matching contribution was 50% of the first 6% of an employee’s eligible compensation with a year-end true-up.

##### ***Discretionary Contributions***

Each year, the Employer may make a discretionary contribution to the Plan, subject to certain limitations. A participant must complete one year of service (defined as 1,000 hours of service) and be employed by the Employer on the last day of the Plan year to be eligible for the discretionary contribution. Allocations are made among eligible participants based on the participant’s eligible compensation to total eligible compensation of all participants. For the Plan year ended December 31, 2024, the Employer did not make a discretionary contribution.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Employer’s contribution, (b) Plan earnings, and (c) reduced by direct loan fees and benefit disbursement processing fees and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

***Participant Contributions***

Participants are immediately vested in their deferral and rollover contributions plus earnings thereon.

***Employer Matching and Discretionary Contributions***

Participants' vested interests are based on years of continuous service. Participants begin vesting after two years of credited service and are 100% vested after six years of credited service or due to death, disability or reaching early retirement age, as defined by the Plan.

***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance. The Plan may use the forfeitures to pay Plan expenses or to reduce future Employer contributions. The unused forfeiture balance at December 31, 2024 and 2023 was \$720 and \$1,857, respectively. During 2024, \$7,188 was used for administrative expenses.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their elective deferral and rollover contribution accounts plus earnings thereon. Terms range up to five years (or longer for the purchase of a principal residence). Participants may only have one note outstanding at a time. Loans bear interest at prime rate plus 1%. A loan is secured by the vested balance in the Participant's account. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Participants may take an in-service withdrawal from any of their vested accounts upon reaching the age of 59½. At the discretion of the Plan administrator, in the event of extreme financial hardship and if the participant has exhausted all other assets, as defined in the Plan document, a participant may withdraw up to the amount of financial hardship, subject to applicable penalties. Participants are entitled to their vested account upon death, disability, retirement or termination of employment, payable in a lump-sum amount equal to the value of his or her accounts.

***Plan Administration***

The Employer is the Plan administrator and has the authority to appoint person(s) to carry out the operations of the Plan. The Employer, at its discretion, pays operating expenses incurred in the administration of the Plan.

***Note 2 - Summary of Significant Accounting Policies***

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Investments, Investment Valuation and Income Recognition***

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

***Payment of Benefits***

Benefits are recorded when paid.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the contributions are withheld from compensation.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

***Subsequent Events***

The Employer has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

***Note 3 - Information Certified by Trustee and Custodian***

Plan investments are held by the Plan's custodian, Charles Schwab Trust Bank. Charles Schwab Trust Bank has certified as complete and accurate the fair value of investments and all investment transactions, including interest and dividend income and net appreciation in fair value of investments and notes receivable from participants as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

***Note 4 - Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Mutual Funds (Continued)***

The mutual fund investments at fair value held by the Plan as of December 31, 2024 and 2023 are \$6,674,591 and \$5,736,407, respectively. Based on the fair value hierarchy, the mutual funds are all considered Level I as of December 31, 2024 and 2023.

***Note 5 - Group Annuity Contract with Standard Insurance Company***

The Plan has a fully benefit-responsive group annuity contract with Standard. Standard maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Standard. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributed to the group annuity contracts. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rates for the years ended December 31, 2024 and 2023 were 3.04% and 2.78%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

At December 31, 2024 and 2023, the group annuity contract at contract value amounted to \$385,979 and \$403,765, respectively.

***Note 6 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### **Note 8 - Tax Status**

The Internal Revenue Service ("IRS") has determined that the prototype The Standard Retirement Services, Inc. plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed the custodian of such in a letter dated June 30, 2020. The Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9 - Related-Party Transactions and Party-In-Interest Transactions**

The Plan issues loans to participants which are secured by the balances in the participants' accounts, which constitute party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid to the custodian totaled \$54,497 for the year ended December 31, 2024. Notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

### **Note 10 - Excess Contributions**

Contributions received from participants for 2024 and 2023 are net of excess contributions of \$6,797 and \$5,188, respectively, made subsequent to year end to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. The 2023 excess contributions were returned by March 15, 2024 along with the filing of Form 5330. The 2024 excess contributions were returned by March 15, 2025 along with the filing of Form 5330.
