We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit** section of our report, our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Notes to Financial Statements

#### Note 1 - Description of Plan

The following description of the Suit-Kote Corporation (the "Company") Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a qualified defined-contribution profit sharing trust under Section 401(a) of the Internal Revenue Code with a Section 401(k) salary deferral arrangement. The Plan covers all non-union employees of the Company who have completed two months of service and are age eighteen or older. All assets acquired under the Plan are the result of employee and employer contributions thereto and all income and other additions thereto are administered, distributed, forfeited or otherwise governed by the provisions of the Plan and the Employee Retirement Income Security Act of 1974 (ERISA).

Plan provisions - The Plan has implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act) and the SECURE 2.0 Act of 2022, laws which, among others, extend the age for required minimum distributions to seventy-three. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions - Participants are allowed to make pre-tax or Roth elective salary deferral contributions up to the maximum amount allowed by the Internal Revenue Code. Participants are allowed to make rollover contributions to the Plan.

The Company may elect to make discretionary matching or profit-sharing contributions. The amount and timing of such payments is at the option of the Company. A portion of annual, discretionary contributions, if any, is specifically allocated to those employees who work on projects covered by prevailing rate schedules. Discretionary profit-sharing contributions including amounts specifically allocated to employees who work on projects covered by prevailing wage schedules (Davis Bacon) amounted to \$1,959,183 and \$1,918,558 for the years ended December 31, 2024 and 2023, respectively, of which \$921,499 and \$916,702 remained receivable as of December 31, 2024 and 2023, respectively.

Participant accounts - Each participant's account is credited with the participant's elective deferral contribution, the Company's discretionary matching and/or profit-sharing contribution as well as a share of plan earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants can access their account information online where they have the ability to change their elective deferrals and investment options as well as request distributions.

Vesting - Participants are immediately vested in their prevailing wage contribution and any elective salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their account balance is based on years of continuous service. A participant is 50% vested after one year of credited service and 100% vested after two years of credited service.

Forfeitures - Upon termination, any unvested account balance is retained in the Plan and may be used to reduce future employer profit sharing contributions or to pay administrative expenses. Forfeited unallocated funds available to reduce future employer contributions or to pay administrative expenses totaled approximately \$2,000 and \$5,000 as of December 31, 2024 and 2023, respectively. The Company used approximately \$9,000 of forfeitures to reduce employer profit sharing contributions for the year ended December 31, 2024.

The Plan earns credits related to administrative expenses. Unused credits are held in unallocated accounts of approximately \$7,000 and \$21,000 as of December 31, 2024 and 2023, respectively, and are available to reduce future administrative expenses at the plan sponsor's discretion. The Plan used unallocated administrative expense credits of approximately \$15,000 and \$12,000 to pay certain administrative expenses for the years ended December 31, 2024 and 2023, respectively.

The Plan has other unallocated accounts of approximately \$14,000 and \$10,000 as of December 31, 2024 and 2023, respectively, related to unclaimed distributions.

Investment options - Participants may direct contributions to the Plan in any of the investment options offered by the Plan. Participants may change their investment options through online media with the Plan's investment custodian.

Payment of benefits - On termination of service due to retirement, disability or death, a participant and/or beneficiary will be entitled to their vested account balance to be paid out as soon as practicable following their termination of service. Upon attainment of age 59½, a participant may elect to receive a pre-retirement distribution while remaining in the service of the Company. Hardship distributions are available provided the participant has a financial need resulting from specified circumstances in accordance with the plan document. On termination of employment for reasons other than those listed above, the participant will be entitled to receive only the vested value of their account balance.

Plan termination - Although the Company has not expressed any intent to do so, it has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their account balances.

#### Note 2 - Summary of accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment valuation and income recognition - Certain investments held by the Plan are stated at fair value (see Note 6) with the exception of investments held in collective investment trusts, a pooled separate account and a stable value fund which are valued at net asset value (NAV) as a practical expedient as reported by the trust fund manager (see below). All investment values have been determined and certified by Empower Trust Company, LLC and Empower Annuity Insurance Company, the Trustees of the Plan; (see Note 4). The change in the difference between the fair value and the cost of investments is included in net appreciation in investments in the accompanying statements of changes in net assets available for benefits. Net appreciation also includes realized gains or losses from the sale of investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Collective investment trusts invest primarily in equities, bonds and mutual funds, which are mainly publicly traded securities. The pooled separate account invests primarily in equities of foreign companies. The stable value fund invests in various contracts and short-term investments. Collective investment trusts, the pooled separate account and the stable value fund are valued at NAV per share, which serves as a practical expedient to estimate their fair value. The practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount significantly different from the reported NAV. The NAV of each collective investment trust and stable value fund is not publicly quoted in the active markets. Each collective investment, pooled separate account and trust can be redeemed at NAV as of the measurement date and can be redeemed on a daily basis. There were no unfunded commitments or redemption restrictions on these investments as of December 31, 2024 and 2023. Investments measured at NAV used as a practical expedient are not required to be classified in the fair value hierarchy.

Payment of benefits - Benefits are recorded when paid.

Administrative costs - Administrative costs, including maintaining participants' accounts, legal costs, and accounting costs, are the obligation of the Plan; however, the Company may pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments are paid directly out of the Plan's assets (see Note 5)

Subsequent events - In August 2025, the shareholders of the Company signed a stock purchase agreement to sell 100% of the outstanding stock of the Company to Colas Inc. The closing of the transaction remains pending as of October 8, 2025. Management has evaluated subsequent events through October 8, 2025, the date that the financial statements were available for issue.

### Note 3 - Tax Status

The Company has adopted the Empower Retirement, LLC Defined Contribution Pre-Approved Plan, Base Plan Document #02. The Internal Revenue Service has ruled that the prototype plan on which the Plan is based is designed in accordance with Section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, management of the Company and the plan administrator are not aware of any matters that would disqualify the Plan. Accordingly, the Plan has been accounted for as a tax-exempt plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and interest for the years ended December 31, 2024 or 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2021.

### Note 4 - Information certified by the Plan's Trustees

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in investments, interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, the Trustees of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to this information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

### Note 5 - Related party transactions

Certain plan investments are funds managed by Empower Trust Company, LLC and Empower Annuity Insurance Company, the Plan's Trustees, and their affiliate Putnam Investments. Fees paid for these services qualify as party-in-interest transactions and are included in net appreciation in investments in the accompanying statements of changes in net

assets available for benefits. In addition, the Plan has contracted with Empower Life & Annuity Insurance Company of NY, an affiliate of Empower Trust Company, LLC, to provide recordkeeping and third-party administrative services, LPL Financial to provide investment advisory services and Dannible & McKee, LLP to provide independent auditing services for the Plan. Fees paid for these administrative services may be paid by the Plan. Total fees for these administrative services amounted to approximately \$354,000 and \$304,000 for the years ended December 31, 2024 and 2023, respectively, and are presented net of participant revenue credits of approximately \$148,000 and \$130,000 for the years ended December 31, 2024 and 2023, respectively. These administrative fees qualify as party-in-interest transactions.

#### Note 6 - Fair value measurements

Authoritative guidance on fair value measurements, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the Plan's assets measured at fair value.

*Registered Investment Companies (i.e., Mutual Funds)* - Valued at the quoted closing price reported on the active market on which the individual security is traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in valuation methodology used as of December 31, 2024 and 2023.
