INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Trustees and Participants of
The National Education Association and
Affiliate Retiree Health Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The National Education Association and Affiliate Retiree Health Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).


Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements


Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



Other Matters - Supplemental Schedules Required by ERISA

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of The National Education Association and Affiliate Retiree Health Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document for more complete information.

General - The Plan is a welfare benefit plan established as of March 1, 2000, for the exclusive purpose of providing retiree health benefits to post termination retired employees of the National Education Association (NEA) and its eligible participating state affiliates authorized by the NEA Executive Committee. As of March 1, 2000, Arizona Education Association participates in the Plan with NEA. To implement the provisions of this Plan, a Trust has been established to receive, invest, and distribute contributions and earnings thereon and to purchase group insurance and/or accumulate assets for self-funding benefits under this Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - Each participating employer selects a health program or programs (medical, hospital, surgical, and major medical) to provide to its retirees or to those employees who will retire. Several of the benefit contracts contain an opportunity for the Plan to receive rebates. The medical benefit payments included in the statements of changes in net assets available for benefits are expressed net of those rebates. Total rebates for the years ended December 31, 2024 and 2023 were \$2,512,737 and \$1,253,083, respectively. Upon termination of employment at retirement, each employee is eligible for retiree health coverage elected by his or her employer. Such coverage is the coverage that the employer is then providing to its active employees or a group of active employees which is the same group of employees of which the retiree was a part of on the day the retiree terminated employment. Employees are eligible to participate in the Plan upon retirement, which varies in accordance with the applicable bargaining agreement.

Contributions and Funding Policy - The amount of contribution for each employer shall be determined by the Plan Administrator to be actuarially sufficient to provide benefits to all eligible employees and participants and to administer the Plan and Trust for each year. In accordance with the applicable collective bargaining agreements, certain employees may be required to contribute toward their health coverage when they retire, as follows:

National Education Association Staff Organization (NEASO) and International Union of Operating Engineers (IUOE)

- Employees hired before January 1, 2005, who retire with less than 15 years of service.
- Employees hired on or after January 1, 2005, who retire with less than 20 years of service.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Association of Field Service Employees (AFSE)

- Employees hired on or after June 1, 2005, who retire with less than 20 years of service.

Non-Bargained Employees (NEAMAC/EXEC)

- Employees hired before June 1, 2006, who retire with less than 15 years of service.
- Employees hired on or after June 1, 2006, who retire with less than 20 years of service.

Symetra Insurance Company provides stop-loss insurance on an individual basis after paid claims exceed \$275,000. Stop-loss reimbursements are presented net against medical claims expense in the statements of changes in net assets available for benefits. Stop-loss reimbursements totaled \$39,069 and \$160,990 for the years ended December 31, 2024 and 2023, respectively.

NEA negotiated a Retiree Reimbursement Account (RRA) benefit into bargaining unit contracts to replace the post-retirement health care benefit for new employees. The Plan is only open to employees of the NEA as of the date specified in their respective contract. Effective August 1, 2014, NEA negotiated with AFSE the RRA, followed by IUOE effective February 1, 2015, and Management and NEASO effective June 1, 2015. The “existing plan” (before the addition of the RRA) is closed to new employees of the NEA. The RRA will provide eligible retirees reimbursement for health expenses in lieu of the traditional health plan benefits. The Trustees agreed to include the RRA as a separate benefit structure under this Plan. Contributions paid to the Plan will be held in the Trust in a separate account. Currently, all expenses of administration are payable by NEA and not from the Plan. Any forfeitures will be used to offset expenses that would otherwise be payable by the NEA, including contributions and administrative expenses. The Plan has updated the Plan Document, Summary Plan Description, Trust Document, and the official amendment. As of December 31, 2024 and 2023, the benefit obligation specifically related to the RRA is \$4,680,627 and \$3,782,699, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Cash and Cash Equivalents - Cash and cash equivalents include amounts available for immediate withdrawal from bank accounts and amounts held as short-term investments with maturities of three months or less at the date of acquisition. Also, cash equivalents consist of both interest-bearing and non-interest-bearing cash accounts. Cash and cash equivalents are recorded at cost, which approximates fair value.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Dividends are recognized on the ex-dividend date. Net appreciation in fair value includes gains and losses on investments brought and sold as well as held during the year.

Benefits - Benefits paid on behalf of participants are recorded upon distribution.

Administrative Expenses - The Plan pays its own administrative expenses.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) claims, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. INFORMATION CERTIFIED AND PROVIDED BY VANGUARD FIDUCIARY TRUST COMPANY

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules that were prepared by, or derived from, information provided by Vanguard Fiduciary Trust Company (Vanguard) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Vanguard that information provided to the Plan Administrator by Vanguard related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following investments at December 31, 2024 and 2023:

Vanguard also certified to the completeness and accuracy of \$11,942,680 and \$8,938,023 of dividends, and \$8,429,506 and \$26,074,988 of net appreciation in the fair value of the Plan's mutual funds for the years ended December 31, 2024 and 2023, respectively.



NOTE 4. POSTRETIREMENT BENEFIT OBLIGATIONS

The amount reported for postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future by current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Obligations currently payable for claims incurred but not reported (IBNR) are estimated by the actuary based on actual claims experience and are a component of the postretirement benefit obligation. For the years ended December 31, 2024 and 2023, IBNR was estimated to be \$970,000 and \$1,230,000, respectively.

NOTE 4. POSTRETIREMENT BENEFIT OBLIGATIONS (CONTINUED)

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligation.

The actuarial valuation included certain changes in assumptions as of December 31, 2024. The discount rate increased from 5.25% as of December 31, 2023 to 5.75% as of December 31, 2024. As required by ASC 965, the discount rate is determined by matching the plan's projected cash flows to a yield curve based on highly rated corporate bonds to determine the present value. A single discount rate that results in the same present value is selected. Gallagher's Above-Median yield curve was used, and the resulting rate was rounded to the nearest twenty-five basis points as has been done in prior years. The change in discount rate decreased the liability. The starting per capita costs were updated to reflect claim experience from calendar years 2020-2023. This update increased the liability. The pre-Medicare, post-Medicare, and prescription drug trend tables were updated based upon emerging marketplace conditions. This update increased the liability.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, was approximately \$41,000,000 and \$25,000,000, respectively. As the Plan was established in March 2000, there has not been sufficient time to significantly accumulate net assets. Annual funding of the Plan is in accordance with actuarially determined amounts. It is expected that the deficiency will be funded through future contributions and earnings.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$41,231,231 and \$40,086,123, respectively.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include other significant observable inputs including:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing market price for the reporting period.



NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Limited partnership: Valued at NAV of the underlying holdings. Fund managers estimate fair value by utilizing prices and other relevant information generated by market transactions, characteristics of the holdings, and other sources. Redemptions can be restricted during the initial years of the investment until all capital calls are completed. The Plan's total capital commitments to private equity funds were \$13,000,000 at December 31, 2024 and 2023. Of these amounts, \$11,765,000 and \$12,935,000 remained unfunded at December 31, 2024 and 2023, respectively, and are not recorded on the statements of net assets available for benefits. Due to the nature of these investments, they are not readily marketable.

Common collective trust: Valued at NAV of the underlying holdings. The objective of the fund is total return through investment in a diversified pool of private investment vehicles that invest in commercial real estate properties. In pursuing total return, the Fund seeks both capital appreciation and current income. The Fund reports as a direct filing entity (DFE) and can be redeemed daily. Redemptions can be restricted during the initial years of the investment until all capital calls are completed. The Plan's total capital commitments to private real estate funds were \$10,000,000 and \$0- at December 31, 2024 and 2023, respectively. All of the commitment was funded in 2024. Due to the nature of these investments, they are not readily marketable.

NOTE 6. RELATED PARTY TRANSACTIONS/PARTIES-IN-INTEREST

The National Education Association makes contributions to the Plan and provides certain accounting and administrative services to the Plan for which no fees are charged.

Vanguard Fiduciary Trust Company (Vanguard) is the custodian of certain Plan assets and, therefore, is a party-in-interest. Fees paid to Vanguard for the years ended December 31, 2024 and 2023 were \$382,182 and \$184,451, respectively. Bank of America is a custodian of certain Plan assets and, therefore, a party-in-interest. As disclosed in Note 2, the Plan pays certain other administrative, investment, and professional fees to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 7. PLAN TERMINATION

The Plan's Sponsor has the right under the Plan to modify the benefits provided to active employees. The Plan may be terminated only by joint agreement between industry and union, subject to the provisions set forth in ERISA. As of December 31, 2024, the Plan Administrator has expressed no such intent.



NOTE 8. TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Plan's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated June 5, 2000, and the Plan Sponsor believes that the Trust qualifies and is operated in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. COMMITMENTS

Benefit payments under the Plan are processed by United Healthcare (UHC) under a self-funded administrative service agreement. Under this agreement, UHC requires the Plan to maintain a benefits demand deposit bank account with Bank of America, N.A., from which UHC can draw funds to pay claims, expenses, and other fees. The Plan is required to fund this account to a minimum amount, as stipulated by UHC on a weekly basis. As of December 31, 2024 and 2023, the minimum funding amount was \$299,000 and \$260,000, respectively.

NOTE 10. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan maintains its cash accounts with banks, which at times exceed the \$250,000 insured by the Federal Deposit Insurance Corporation (FDIC). The Plan has not experienced any losses in such accounts and the Plan believes it is not exposed to any significant credit risk on cash.



NOTE 10. RISK AND UNCERTAINTIES (CONTINUED)

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 11. MEDICARE PART D

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the Act) provides for a prescription drug benefit under Medicare Part D as well as federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D. The Plan has determined that the benefits provided by its Plan are actuarially equivalent to the Medicare Part D Standard Benefit. The federal subsidy was considered as a reduction of the Plan's postretirement benefit obligation as of and for the years ended December 31, 2024 and 2023. The gross benefits paid to retirees for the policy year ended June 30, 2024, is estimated to be approximately \$11,300,825; the subsidy revenue recognized was \$533,000 which is an estimate and is presented net against medical claims expense in the statements of changes in net assets available for benefits. The gross benefits paid to retirees for the policy year ended June 30, 2023 was \$11,527,000; the subsidy received was \$581,399.
