1. DESCRIPTION OF PLAN:

The following description of the Charles F. Kettering Foundation Deferred Compensation Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of plan provisions.

General

The Plan is a defined contribution 403(b) plan covering all eligible employees of the Charles F. Kettering Foundation (the Employer). An employee becomes a participant in the elective deferral portion of the Plan on their first day of employment. Employees who have attained age 21 and have completed one year of service, as defined by the Plan, are eligible for Employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 5% of eligible compensation, as defined, to the Plan, subject to certain limitations established by law. Employees are automatically enrolled in the Plan at 5% of eligible compensation upon obtaining age 30 and three years of service, unless the employee has elected to decline participation or has elected another percentage and their contributions invested in a designated balanced fund until changed by the participant. Participants are also permitted to deposit into the Plan distributions from other qualified plans. Participants who have attained age 50 can make catch-up contributions.

The Plan provides for a discretionary Employer contribution. For the years ended December 31, 2024 and 2023, the discretionary Employer contribution was 10% of eligible compensation and 3% of eligible compensation in excess of the Social Security Taxable Wage Base under Section 230 of the Social Security Act in effect at the beginning of the Plan year.

Participant accounts

Each participant's account is credited with participant contributions, Employer contributions, and an allocation of plan earnings. Allocations of plan earnings are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan's investments are participant directed.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Payment of benefits

Normal retirement age is age 65. Upon termination of service, death, disability, retirement, or reaching age 59 ½, distributions may be made to the participant or beneficiary in a single lump sum payment, partial payments, installment payments or a single life annuity contract.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit distributions are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,217 and \$2,110 respectively. These accounts will be used to reduce future Employer contributions.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENT INFORMATION:

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF), qualified institutions.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Registered investment companies:* Certain registered investment company investments are in open-ended investments that are not traded on an active market and are valued at the net asset value (NAV), which is based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The investment objectives of the investments include the preservation of capital, or to attain certain growth, income or balance performance levels based on different tolerance levels of risk. There are no unfunded commitments related to the registered investment companies' accounts and units are redeemable at net asset value on a daily basis. To reduce market timing and excessive trading, currently CREF locks out trading for 90 days if a purchase, sale and repurchase with that account is made within a 60-day period with the exception of the CREF Money Market Account. The remaining registered investment company investments have no restrictions.

Certain registered investment company investments are in mutual funds which are traded on an active market and valued at quoted daily prices. Accordingly, these registered investment companies are shown in Level 1.

- *Unallocated insurance contract:* The unallocated insurance contract that is not considered fully benefit-responsive is valued at fair value, which equals contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. The valuation of the investment contract considers prices from prior transactions; therefore, additional disclosure of quantitative unobservable inputs is not necessary.
- *Pooled separate account:* The pooled separate account is held in an investment contract with TIAA-CREF and is invested primarily in real estate. The principal is not guaranteed. The pooled separate account is valued at the NAV, which is based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Transfers are limited to one per calendar quarter.

5. PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by TIAA-CREF, a qualified institution. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As of December 31, 2024 and 2023, the Plan revenue account totaled \$20,056 and \$19,609, respectively. There were no revenue credits or amounts used to pay expenses during the years ended December 31, 2024 or 2023, respectively. The Plan Sponsor pays directly any other fees related to the Plan's operations.

6. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. INCOME TAX STATUS:

The Plan adopted a volume submitter 403(b) plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
