**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the First National Bank Alaska Profit Sharing and 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan began on January 1, 1999 and was restated in its entirety effective September 1, 2022. The Plan restatement had no impact to the financial statements. The Plan was amended in 2024 with no material impact to the financial statements. The Plan is a defined contribution plan that covers substantially all employees of First National Bank Alaska (the Bank) who are 18 years old or older. There are no excluded employees for purposes of making salary deferrals to the Plan and for receiving matching contributions. Excluded employees are not entitled to receive employer discretionary profit sharing contributions under the Plan. Excluded employees are employees who are employed solely as directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: For salary deferral contributions and matching contributions, the participant's entry date to the Plan is the first pay period following the date that the minimum age requirement is met. The entry date for discretionary profit sharing contributions is the first day of the Plan year during which the eligibility requirements are satisfied. The Plan provides for automatic enrollment and automatic escalation of pre-tax contributions of participants who do not elect to opt out of participation. Automatically enrolled participants have their deferral rate set at 3.5% of eligible compensation and their contributions invested in a designated target date fund until changed by the participants. The deferral rates of all eligible active participants are increased by 1% each year, up to a maximum deferral rate of 15%, until changed by the participants. Participants may make salary deferral contributions to the Plan up to the lower of 50% of compensation or the maximum allowed by law, which was \$23,000 in 2024 and \$22,500 in 2023. Participants are also permitted to make contributions to the Plan on an after-tax basis. Participants over age 50 were permitted to make catch-up contributions up to a maximum amount of \$7,500 in 2024 and 2023. The catch-up contributions are allowed in addition to the maximum deferral amounts. The Bank made matching contributions of 100% on the first 6% of a participant's compensation. To be eligible for the employer's matching contributions, the participant must complete at least one hour of service during the year. Eligible participants may also contribute amounts representing distributions from other qualified plans. Additional profit sharing amounts may be contributed at the option of the Bank's board of directors. To be eligible for the profit sharing contribution, the participant must have completed one year of service and be employed at the end of the year. The profit sharing contribution at December 31, 2024 and 2023 was \$0. The Plan offers thirty-four mutual fund options and one fixed annuity option for participants to direct contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Bank's matching contribution and (b) Plan earnings. Participant account balances are also adjusted annually for a pro-rata share of the Bank's discretionary contribution, if any, determined by the percentage, which the participant's annual compensation bears to the total annual compensation for all participants eligible to share. Allocations of Plan earnings are based on each participant's earnings with the fund that the participant elects. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a distribution in installments or as a lump sum pursuant to the election of the participant. Upon termination of a participant's employment for any reason other than disability, retirement, or death, the participant becomes entitled to a distribution that may be paid to the participant in installments or as a lump sum equal to the value of the participant's vested interest in his or her account. A terminating participant can elect to keep his or her fund in the account, but may not make any future contributions. Upon attaining the age of 59 1/2, participants are eligible to receive in-service distributions of all vested balances.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Bank's contribution portion of their accounts plus actual earnings thereon is based on years of credited service as follows:

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested 401(k) account balance, whichever is less. The loans are secured by the balance in the participant's account and the interest rate is 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan is originated. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans are to be repaid within five years unless they are used to purchase a participant's principal residence, in which case loans are to be repaid within thirty years.

Expenses: Investment management fees are paid from the Plan participants' accounts.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$109,603 and \$109,093, respectively. In 2024, employer contributions were reduced by \$94,155 from forfeited nonvested accounts. Forfeitures may be used to pay Plan expenses as well as reduce nonelective contributions or matching contributions. These accounts are used to offset the employer match.

Excess Contributions: Excess contributions represent amounts withheld from participants in excess of Internal Revenue Code (IRC) limitations that were refunded to participants. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan. No excess contributions were made during the Plan years ended December 31, 2024 or 2023.

Hardship Withdrawals: Under certain conditions, participants, while still employed by the Bank, are permitted to withdraw, in a single sum, the employee contribution portion of their account balance. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, domestic abuse, or to prevent eviction or foreclosure from the participant's principal residence.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Income Recognition: Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis.

Investment Valuation: Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See note 4 for discussion on the contract value investment and note 5 for discussion of fair value measurements.

Net Appreciation (Depreciation) in Fair Value of Investments: Net appreciation (depreciation) in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Subsequent Events: The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contribution and earnings thereon.

**NOTE 4 – INVESTMENT IN INSURANCE FUND**

As of December 31, 2024 and 2023, the Plan holds a fully-benefit responsive group annuity contract with Empower Annuity Insurance Company of America. The Empower Select Guaranteed Fund is a group annuity contract and is a general account product of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate and prevailing market conditions. The interest crediting rate is reset quarterly. As described in Note 2, contract value is the relevant measurement attribute for this fund.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include premature termination of the contracts by the Plan, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Empower Annuity Insurance Company of America or otherwise. The average yield earned by the Plan of 2.36% for 2024 and 2.18% for 2023 is derived by averaging the Plan's quarterly interest rates.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The certifying entities were Empower Trust Company, LLC (the trustee of the Plan) and Empower Annuity Insurance Company of America for the years ended December 31, 2024 and 2023.

**NOTE 7 - INCOME TAX STATUS**

The Internal Revenue Service has issued an opinion letter effective November 14, 2022 indicating that the non-standardized pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the last opinion letter. The plan administrator believes that the Plan is currently designed and being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment fund options, which in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonable that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Bank. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan. Parties in interest include Gallagher Benefit Services, Empower Trust Company, LLC, and Empower Annuity Insurance Company of America. Total fees paid to the parties in interest were \$166,648 and \$146,421 in 2024 and 2023, respectively.
