INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Preferred Management Corporation Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Preferred Management Corporation Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan became effective on January 1, 2013. It is a defined contribution plan covering all employees of Preferred Management Corporation (the Company) and thirteen (2024) and twelve (2023) other divisions of home health and hospital employers that have adopted the Plan's provisions. Employees who are at least twenty-one years of age and have attained at least three months of service with the Company are eligible to participate. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2022, the Plan was restated to comply with recent legislative and regulatory changes using a preapproved plan document sponsored by Minnesota Life Insurance Company (Minnesota Life), who received a favorable tax status from the IRS dated June 30, 2020.

Employee Contributions

Under the terms of the Plan, participants are permitted to contribute up to 100% of their annual compensation to the Plan on a pre-tax and after tax basis. Participants can also make a separate election to defer up to 100% of any bonus. Contributions may not exceed dollar limits set by law. Transfers from qualified plans are allowed under provisions of the Plan.

The Plan allows for participants to rollover contributions into the Plan from another qualified plan or individual retirement account. Such rollovers are included in the accompanying statements of changes in net assets available for benefits.

Employer Contributions

The Company may make a discretionary matching contribution equal to a uniform percentage of each tier of the salary deferrals. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 10% of the first 5% of base compensation that a non-highly compensated participant contributed to the Plan. Additional amounts may be contributed at the discretion of the Company to highly compensated employees. No such additional discretionary contributions were made for the year then ended. For the years ended December 31, the Company made matching contributions of \$87,832 (2024) and \$84,419 (2023).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions on the participant's behalf, and an allocation of Plan earnings. Allocations are based on participant account balances, as defined by the Plan document.

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, and the earnings thereon. Vesting in the Company's matching contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. In addition, a participant becomes 100% vested in the Company's contributions in the event of a participant's death or disability or upon termination of the Plan. In the event of a participant's death, disability, or attainment of normal retirement age (65) while employed with the Company, the participant is automatically 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. Loan terms are up to five years or thirty years if used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account. Interest rates are determined by the trustee and Plan administrator at the time the loan is processed.

Payment of Benefits

Upon termination of service, a participant will receive a lump-sum payment equal to the value of his or her account, provided the account does not have a value greater than \$1,000 and an election has not been made to directly rollover the balance to an eligible individual retirement account (IRA). Participants with account values of at least \$1,000, but less than \$7,000, may receive a lump-sum payment, elect to rollover the balance to another plan or IRA, or if no other option is selected, the balance will be rolled over to an IRA on behalf of the participant. If a participant's account value is \$7,000 or more, the participant may elect a single lump-sum payment, installments over a period of not more than the participant's assumed life expectancy, or partial withdrawals, as defined by the Plan document. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined by the Plan document.

Forfeitures

If, at the time of termination of employment, the participant is not 100% vested in employer contributions, the non-vested portion of the participant's account (forfeitures) shall be placed in a separate account and will be used to offset employer matching contributions or pay plan expenses. Forfeitures will be applied for the Plan year in which the forfeiture occurs. Prior to applying forfeitures to reduce employer matching contributions, forfeitures may be used to pay plan expenses. For the years ended December 31, forfeitures used to reduce employer contributions and pay plan expenses were \$3,393 (2024) and \$5,013 (2023). At December 31, unallocated forfeitures were \$3,068 (2024) and \$535 (2023).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Pooled Separate Accounts

Pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

Fully Benefit-Responsive Guaranteed Fund

The fully benefit-responsive guaranteed fund (the Fund) is reported at contract value. The Fund is valued at contract value as reported to the Plan by Minnesota Life. Contract value represents contributions made under the Fund, plus earnings, less participant withdrawals and administrative expenses (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid by the trustee.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Minnesota Life, the trustee of the Plan for the year ended December 31, 2023 and Standard Insurance Company (The Standard), the trustee for the year ended December 31, 2024, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan accounts for fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures* (ASC 820). ASC 820 defines fair values, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Under ASC 820, assets and liabilities are grouped in three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

- Level 1 – Valuation is based upon quoted prices for identical instruments traded in active markets.
- Level 2 – Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 – Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobserved assumptions reflect the Plan’s own estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models, and similar techniques.

Under ASC 820, the Plan bases fair values on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements for assets and liabilities where there exists limited or no observable market data and, therefore, are based primarily upon the Plan’s estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future values.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts: Valued at the net asset value (NAV) of units held by the Plan at year end, as determined by The Standard. The estimate of fair value of pooled separate accounts are based on the fair value of the underlying mutual funds owned by the pooled separate accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

As described in ASC 962, *Plan Accounting-Defined Contribution Pension Plans*, as updated by ASU 2015-12, fully benefit-responsive investment contracts held by a defined contribution plan are required to be reported at contract value. The Plan has a fully benefit-responsive investment group annuity contract (the Contract) with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Contract is included in the financial statements at contract value as reported to the Plan by Minnesota Life. Contract value represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Contract's issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan administrator does not believe there are any events that would limit the Plan's ability to transact at contract value with Minnesota Life. The Plan administrator also does not believe there are events and circumstances that would permit Minnesota Life to terminate the Contract and settle at an amount different from Contract value. The contract value of the Contract at December 31 was \$480,198 (2024) and \$451,382 (2023).

NOTE 6 - PLAN TERMINATION

Although they have expressed no intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

On March 31, 2014, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, was acceptable for use by employers for the benefit of their employees under Section 401 of the IRC. Although the Plan has not received a determination letter specific to the Plan itself, effective April 1, 2022, the Plan was restated to comply with recent legislative and regulatory changes using a preapproved plan document sponsored by Minnesota Life who received a favorable tax status from the IRS dated June 30, 2020. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 8 - RELATED-PARTY TRANSACTIONS

The Plan pays for certain Plan expenses while the Company absorbs certain administrative expenses, such as accounting fees, on behalf of the Plan.

In 2022, Minnesota Life and The Standard entered into a reinsurance agreement and other related other related agreements that transferred administrative, payment, and investment responsibilities with respect to certain retirement products from Minnesota Life to The Standard, on a coinsurance basis in the case of general account liabilities and on a modified coinsurance basis in the case of separate account liabilities. Minnesota Life remains the issuer of the products that are reinsured and administered by The Standard.

The Standard manages certain Plan investments. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental Schedule H, Line 4i-Schedule of Assets (Held at End of Year).

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date at which the financial statements were available to be issued, and determined that no events have occurred that required disclosure.
