1. DESCRIPTION OF PLAN

The following description of the Cohen Milstein Sellers & Toll Profit Sharing and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

During 2024 the plan administrator amended the Plan to remove the two years of service requirement to receive employer discretionary contributions. In addition, the employer discretionary contributions allocation formula was changed to a uniform percentage of compensation (pro rata allocation) instead of the social security integration formula.

The Plan is a defined contribution plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) established for the benefit of all employees electing to participate in the Plan. The Plan has no service requirement for eligibility to make elective deferrals and also has no age requirement. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). A complete description of the Plan is contained in the Plan Document and Adoption Agreement, which governs the operation of the Plan.

Contributions

Each year, participants may contribute the maximum allowed by law of their pretax compensation. Participants can also make Roth and after-tax contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Cohen Milstein Sellers & Toll (the Firm) may decide to make discretionary contributions.

Participants are immediately 100% vested in their contributions plus actual earnings thereon.

Participant Accounts

The Plan's investment manager attributes contributions to participant accounts based upon the investment allocation elected by each participant. The investment options available to participants include mutual funds, common collective trusts, and an insurance company general account.

Benefit Payments

Distribution of a participant's vested account balance to the participant or the participant's beneficiary may commence upon the earlier of retirement, attainment of age 65, death, disability, or separation from service. Participants can receive distributions in a lump sum or in installments.

Withdrawals

A participant experiencing serious financial hardship may, with sufficient evidence, withdraw the portion of their account attributable to salary deferrals and rollover contributions. The amount of the withdrawal may not be greater than the immediate financial need.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their account balance. Participants may only have two loans outstanding at a time and all loans must be repaid within five years, except loans used to purchase a primary residence. The loans are secured by 50% of the participant's account balance and bear interest at the prime rate plus 1%.

Plan Termination

While the Firm has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants are 100% vested in their accounts. Also, upon such termination, the commitment of the Firm to make contributions shall terminate.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and the disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Shares of mutual funds are valued at the net asset value of shares, determined by quoted market price, held by the Plan at year end. Units of the common collective trust investments are valued based on net asset value per share provided by the manager of the fund. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued when earned.

Administrative Expenses

Administrative expenses are paid by the Plan.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Related fees are charged directly to the borrowing account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Benefits

Benefits are recorded when paid.

Reclassifications

Certain 2023 amounts have been reclassified for comparative purposes.

3. CERTIFIED FINANCIAL INFORMATION

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 2024 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, Inc., the trustee of the Plan, has certified that the following information related to investments included in the accompanying financial statements and supplementary schedule of assets is complete and accurate.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

The fair value of the shares of mutual funds owned by the Plan is based on quoted market price values on the last business day of the plan year.

The fair value of the common collective trust fund is based on the net asset value (NAV) on the last business day of the plan year provided by the entity holding the trust funds. The NAV of the common collective trusts is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of underlying assets in the trusts, less the liabilities. These investments can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits, or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation (depreciation) in fair value of investments.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

5. FULLY BENEFIT - RESPONSIVE CONTRACTS

Lincoln Stable Value Account

The Plan entered into a fixed annuity account (Fixed Account) with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in the Fixed Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fixed Account is subject to some restrictions and is fully benefit-responsive. The contract is reported at contract value which approximates fair value. Upon contract discontinuance, money may be withdrawn from the Stable Value Account subject to a market value adjustment (MVA) or according to a withdrawal schedule. Participant withdrawals can be taken without an MVA for hardship needs, death, retirement, or separation from service.

6. RELATED PARTY TRANSACTIONS

Certain plan investments are managed by Vanguard. Vanguard Fiduciary Trust Company, Inc., is the custodian of the Plan and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (the Code). The plan administrator timely adopted the restated prototype plan. The plan administrator believes that the Plan is currently being operated in accordance with the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe the Plan has any uncertain tax positions. The Plan's Form 5500, *Annual Return/Report of Employee Benefit Plan*, is open for inspection by the taxing authorities, generally for three years after filing.
