Notes to Financial Statements

(1) Description of the Plan

The following description of The Toledo Electrical Welfare Fund (the "Plan") provides only general information. Participants should refer to the summary plan description for a complete description of the Plan's provisions.

General - The Plan is a multiemployer collectively bargained defined benefit health and welfare plan. The Plan was established under the provisions of Agreement and Declaration of Trust between Local No. 8, International Brotherhood of Electrical Workers ("Local No. 8") and the Toledo Electrical Contractors Association, Inc. dated January 1, 1953 and amended at various times thereafter. The Plan operates as a trust to provide health and other benefits to eligible participants and beneficiaries, and is administered by a board of trustees comprised of union and employee trustees. The Plan is administered by a Board of Trustees, comprised of union officials and management of certain employers covering eligible employees. The Trustees have overall responsibility for the operation and administration of the Plan, including the appropriateness of the Plan's investment elections and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions - Contributions by employers are made pursuant to terms and conditions of collective bargaining agreements with Local No. 8, and are based on negotiated rates per hour worked for each worker classification. Participating employees with less than a specified number of hours worked and retirees and surviving spouses are allowed to make contributions to maintain eligibility for certain benefits.

Benefits - The Plan provides health and welfare benefits for eligible members of the collective bargaining unit and certain other employees which are payable in accordance with the terms of a Plan of Benefits and amended from time to time as follows:

Eligible to individuals only:

- Death Benefits
- Accidental death and dismemberment
- Weekly income during non-occupational disability

Eligible to individuals and their dependents:

- Medical
- Prescription Drugs
- Supplemental Benefit Program
- Dental
- Vision
- Hearing
- Employee Retention Program ("ERP")
- Education Reimbursement
- Vacation
- Early Retiree Assistance Program ("ERAP")

Eligibility is based upon a minimum number of hours worked for contributing employers; no participant whether active or retired, has any vested rights or benefits in the Plan.

Supplemental Benefit Program - A defined contribution benefit funded by contributions from the employers and is intended to cover medical benefits not otherwise covered by the traditional plan. Eligible expenses will be reimbursed up to the amount of the individual's account balance.

Notes to Financial Statements

(1) Description of the Plan (Continued)

Benefits (Continued) - Employee Retention Program - This benefit is intended to provide participants with supplemental unemployment benefits in the event of sustained unemployment. Credits are earned based on hours worked per month, and then "spent" to receive benefits.

Early Retiree Assistance Program - This benefit is intended to provide early or normal retirees a 25% subsidy discount on the standard unreduced medical self-pay rates including out of pocket dental premiums. This benefit is available to all early or normal retirees under the Plan on or after March 1, 2025.

Vacation - This benefit is intended to provide participants with vacation benefits in the event of that they maximized the amount of credits that may be accumulated under the ERP. Credits are earned based on hours worked per month, and then "spent" to receive benefits.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Adoption of New Accounting Standard - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that are subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported ("IBNR"), eligibility credits, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plan's custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

(2) Summary of Significant Accounting Policies (Continued)

Contributions - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on an agreed upon hourly rate and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection, including subsequent period collections. As of December 31, 2024 and 2023, the Plan did not record any credit losses for employers' contributions receivable.

The Board of Trustees has established a program to review participating employer records in order to determine compliance with contribution provisions of the collective bargaining agreement. As a result of this program, previously unreported contributions are identified related to current and prior fiscal years. However, due to the collection efforts required by the Plan, including litigation, the ultimate realization of any additional contribution receivable cannot be reasonably estimated until the collection process is completed. Accordingly, the Plan primarily recognizes these previously unreported contributions in the fiscal year in which the settlement proceeds are received.

Estimated Future Benefits Based on Participants' Accumulated Eligibility - Future benefits based on participants' accumulated eligibility are estimated by applying the average cost of benefits per eligible participant using a cost increase trend factor and represents an estimate of the liability of the Plan for future benefits based on participants' accumulated eligibility at the end of the fiscal year. Actual results could differ from the estimated amounts.

Other Plan Benefits - Plan obligations at December 31st for health claims incurred by active and retired participants but not reported at that date, and for accumulated eligibility of participants are estimated by the Plan's actuary based on the latest actuarial valuation as of December 31, 2024, in accordance with accepted actuarial principles. Such estimated amounts are reported at present value, based on a 5.75% (2024) and 5.00% (2023) discount rate. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

Stop-Loss Insurance Coverage - The Plan has a stop-loss insurance arrangement to limit exposure for self-insured benefits (individual participant claims over a specific dollar threshold, as well as its aggregate exposure for all claims). Premiums paid as well as the reimbursements from the insurance carrier are presented in the benefits paid section of the statement of changes in net assets available for benefits.

Leases - Leases are categorized at their inception as either operating or financing leases. Operating right-of-use assets and liabilities are recognized at the lease commencement date based on the present value of the lease payments over the lease term. Leased assets represent the Plan's right to use an underlying asset for the lease term, and lease liabilities represent the Plan's obligation to make lease payments arising from the lease. The lease term may include options to extend or terminate the lease when it is reasonably certain that the Plan will exercise that option. Lease expense for lease payments is recognized on a straight-line basis over the lease term. The Plan uses a risk-free discount rate when the rate implicit in the lease contract is not readily determinable.

Payments of Benefits - Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement.

(2) Summary of Significant Accounting Policies (Continued)

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related ERISA plans. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plan.

Certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

(3) Benefit Obligations

Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2024.

Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

(A) The actuarial assumptions changed for the December 31, 2024 valuation as follows: The discount rate was changed from 5.00% used last year to 5.25% used this year. Medical, drug, dental and self-payment trend rates were changed to reflect our best projection for future medical inflation. The actuarial assumptions changed for the December 31, 2023 valuation as follows: The assumed mortality rates for females were changed from 110% of the PRI-2012 Blue Collar Mortality Table and remained at 105% of PRI-2012 Blue Collar Mortality Table for males. This change was made in order to better reflect anticipated improvements in mortality rates for each future year due to medical advances and lifestyle changes. The discount rate was changed from 5.25% used last year to 5.00% used this year. Medical, drug, dental and self-payment trend rates were changed to reflect our best projection for future medical inflation.

(B) Effective March 1, 2025, the fund implemented an Early Retiree Assistance Plan (ERAP) for members who retired on or after June 1, 2024 that provides an additional retiree subsidy of 25% of the base self-pay methodology.

The above figures were prepared by the Plan's actuary, and are based upon their actuarial valuation as of December 31, 2024 and 2023. The actuarial assumptions and techniques are related primarily to participant data, and to reasonable expectations, represent an estimate of anticipated experience under the Plan. Actual results may differ from these assumptions.

The Plan's deficiency of net assets compared to benefit obligations relates primarily to the postretirement benefit obligations, the funding of which is not covered by net assets generated cumulatively through those dates by the contribution rate provided by the current bargaining agreement. It is expected that those future benefits will be funded through a combination of future contributions, increases in the collectively bargained contribution rates, and modifications in eligibility rules and benefit schedules as available.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported above. If the assumed rates increased by 1% in each year, it would increase the obligations as of December 31, 2024 and 2023 by \$124,567,776 and \$111,452,410, respectively.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

(4) Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest Bearing Cash Accounts: Valued using amortized cost, which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: Valued by summing the product of each investment year's market value factor as of the Plan year-end by the particular contract's balance within the investment year and dividing the result by the contract's total investment year balance to arrive at a composite market value factor for the contract. The contract-specific composite market value factor is then multiplied by the contract value to determine the estimated fair value. Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Plan's investment committee evaluates a variety of factors including review of historical earnings trends of the contract, economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, while others are substantiated utilizing available market data.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(5) Related Party and Party-In-Interest Transactions

The Plan shares an office with Local No. 8, International Brotherhood of Electrical Workers ("I.B.E.W.") Retirement Plan and Trust (the "Retirement Plan"). The plans are related by virtue of common plan co-sponsors. The Plan and the Retirement Plan share certain common costs (payroll, rent, office costs, etc.) allocated based upon a written Multiple Plan Sharing agreement entered into by the Trustees' of each Plan pursuant to U.S. Department of Labor guidelines and based on the Board of Trustees estimates of effort expended or estimates of a pro-rata share of actual costs incurred. N.W.O. Electrical Administrators, Inc. is a related entity that administers these common costs. The total amount of administrative expenses allocated to the Plan for the years ended December 31, 2024 and 2023 was \$1,254,622 and \$1,130,366, respectively. As of December 31, 2024 and 2023, the Plan had amounts due to N.W.O. Electrical Administrators, Inc. of \$45,756 and \$23,996, respectively.

(6) Reciprocity Agreements

The Plan has entered into reciprocity agreements with certain welfare funds administered by various local unions through the IBEW/NECA Electronic Reciprocal Transfer System ("ERTS"). In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions.

For the years ended December 31, 2024 and 2023, the Plan remitted reciprocal payments of \$1,047,502 and \$944,730, respectively, and received reciprocal payments of \$2,615,981 and \$1,517,081, respectively in accordance with these agreements with the participating local unions. Reciprocal payments received are included in the employer's contributions in the statement of changes in net assets available for benefits. No allowance for credit losses as of December 31, 2024 or 2023, was necessary for reciprocal payments due to the Plan. Payments made to other plans for reciprocal contributions collected on behalf of those plans are recorded as a reduction to the reciprocal contributions payable account and are not included in the statement of changes in net assets available for benefits as they do not represent an expense of the Plan.

(7) Tax Status

The Plan obtained its latest determination letter on September 30, 1955, in which the Internal Revenue Service (the "IRS") states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

(9) Significant Participating Employer

During the years ended December 31, 2024 and 2023, the Plan had the following employer which individually represented 10% or more of total contributions:

In the event this participating employer was to suspend contributions, the Plan would retain the risk of meeting current plan obligations until the appropriate adjustments were made.

(10) Risks and Uncertainties

Investment Risk – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Actuarial Assumptions – The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates in the near term would be material to the financial statements.

Concentrations of Credit Risk – Cash consists of monies held in interest-bearing transaction accounts. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. At December 31, 2024 and 2023, the Plan's cash exceeded federally insured limits by approximately \$12,998,000 and \$16,679,000, respectively.


