Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pure's Food Specialties 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1. Plan Description

The following description of the Pure's Food Specialties LLC (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees, established by the Company effective April 15, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is defined as any employee of the Company who is 18 years of age. An employee becomes eligible to participate in the Plan after 30 days of service. The Plan Committee is responsible for the oversight of the Plan. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors performance.

Contributions: Each year, a participant may contribute up to the Internal Revenue Service (IRS) maximum provided these contributions will not cause the Plan to exceed discrimination limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may contribute matching contributions equal to a percentage of the participant's elective deferrals. The matching contribution is discretionary. The Company did not make a matching contribution in 2024. Contributions are subject to certain limitations. The Plan had an auto enrollment provision for participants at 3% of compensation, with no annual escalation, however, The Plan was amended in October 2022 to remove auto enrollment for participants effective January 1, 2023.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contributions, if any, and (b) Plan earnings and charged with certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The discretionary match is subject to a three-year cliff vesting schedule, in which participants are 100% vested after three years of credited service.

Investment options: Upon enrollment in the Plan, a participant may direct their accounts into a variety of investment choices as more fully described in the Plan's literature. Participants have the option to transfer monies between investments and change the allocation of their investment options daily.

Payment of benefits: On termination of service due to death, disability, retirement or termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, installments over a period of not more than the assumed life expectancy, or a partial withdrawal. Prior to termination of service, participants may also elect to receive a distribution upon attainment of age 59½ or a safe harbor hardship withdrawal distribution, as defined in the Plan.

Forfeited accounts: According to the Plan's provisions, forfeited nonvested accounts may be used to pay administrative expenses or to reduce Company contributions. The Plan had no forfeited nonvested account balances at December 31, 2024 and 2023. There were no forfeitures used during 2024.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and any related matching contributions from the employer are recorded in the year in which participant compensation is earned.

Excess participant contributions: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Certain other expenses of maintaining the Plan are paid directly by the Company. All expenses paid by the Company are excluded from these financial statements.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Units of collective investment trusts: The collective investment trusts are valued based on the net asset value (NAV) per units of the collective investment trust funds. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Insurance company pooled separate accounts: The fair value of the investments in the insurance company's pooled separate accounts is determined by the insurance company and represents the NAV per share based on the fair value of the underlying investments comprising the pooled separate accounts less its liabilities. The NAV is used as a practical expedient to estimating fair value. The practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6. Related-Party and Party-in-Interest Transactions

Certain plan investments are pooled separate accounts managed by Principal, custodian and recordkeeper of the Plan, and collective investment trust funds managed by Principal Global Investors Trust Company (Principal Global). Principal and Principal Global are affiliated companies. These transactions qualify as party-in-interest transactions. Fees paid to the affiliated companies from the Plan amounted to approximately \$81,000 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which they receive no compensation from the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the net assets of the Plan would be allocated to the Participants on the basis of their individual account balances.

Note 8. Income Tax Status

The Plan has adopted a preapproved defined contribution plan sponsored by Hessel & Associates, LLC. The pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service as to the preapproved defined contribution plan's qualified status. The preapproved defined contribution plan opinion letter has been relied upon by the Plan. The Plan has been amended since the preapproved defined contribution plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
