Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Redwood Empire Electrical Workers Health and Welfare Trust Fund (the “Plan”) is a multiemployer welfare benefit plan established on January 1, 1965 for the purpose of providing health care benefits to eligible participants covered by the collective bargaining agreements between the International Brotherhood of Electrical Workers Local 551 (the “Union”) and employer associations and individual employers signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are recorded on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Benefits

Participants are initially eligible for coverage on the first day of the second month following the month the participants have accumulated at least 500 hours. Retired employees, who meet the eligibility criteria to receive retiree coverage, are eligible for benefits on the first day of the month following the termination of their eligibility as an active employee in the Plan.

The Plan provides future benefits through the reserve bank of hours program to those active participants who have accumulated in the current or prior years, credit amounts (expressed in hours) in excess of the hours required, 125 hours, for current insurance coverage. Participants may accumulate excess hours to a maximum, 750 (to provide up to 6 months of future eligibility, at 125 hours per month). When a participant’s reserve hour bank is less than 125 hours they lose eligibility, however, they may self-pay the difference between the number of hours in their reserve account and 125 hours.

D. Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by an actuary and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used at December 31, 2024 were: (a) Interest Rate: 5.5% per annum in 2024, (b) Mortality - Nondisabled: 95% of the RP-2014 Blue Collar table (as projected back to 2006 with MP-2014 then forward to 2018 with MP-2018); Disabled Mortality: 105% of the RP-2014 Disabled table (as projected back to 2006 with MP-2014 then forward to 2018 with MP-2018); Disability: 50% of the Unisex 1977SSA study #75 table (mixed as 80% male / 20% female); (c) Retirement Age: 100% assumed to retire at age 80, and (d) other assumptions and methods for retirement rates, mix of type of retiree coverage, trend rates and per capita cost assumption.

Changes in actuarial assumptions are as follows: the mortality was changed from RP-2000 Mortality Table projected to 2023 to the mortality tables noted above, the discount rate was lowered from 6.00% to 5.50%, the health trend rate was lowered from 5.00% to 4.00%, the future retiree participation rate was lowered from 90% to 70%, the future retiree spouse coverage rate was lowered from 70% to 55%, and the demographic rates were updated.

The health care cost trend rate and retiree contribution trend rate have a significant effect on the postretirement benefit obligations. A 1% increase in the health care cost trend rate would increase the net postretirement benefit obligation as of December 31, 2024 and 2023 by \$5,068,500 and \$3,941,860, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

E. Contributions

Employer contributions, including HRA contributions, as reported are contributions made at a fixed rate per hour worked during the year. Participant contributions are from retirees for continued coverage. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

F. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

G. Tax-Exempt Status

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. Therefore, no provision for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Plan Termination

Upon the termination of the Plan, any and all monies remaining in the Plan, after payment of all expenses of the Plan, shall be allocated to the extent that they shall be sufficient for the purpose of paying health and welfare benefits as determined by the Board of Trustees.

I. Risks and Uncertainties

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates and participant demographics which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investments. Due to the level of risk associated with certain investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

J. Concentration of Credit Risk

During 2024, the Plan had bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 3 - RELATED PARTY TRANSACTIONS

The Plan shares common expenses including salaries, benefits, facilities, professional fees and general administrative expenses with the Redwood Empire Electrical Workers Individually Allocated Pension Plan (the "Pension Trust"), a related party. The Plan pays facilities, salaries, and benefit

expenses and is reimbursed by the Pension Trust 25% of these costs, based on an allocation method periodically approved by the Board of Trustees. Certain professional fees and various general administrative expenses are split evenly between the Plan and the Pension Trust.

The Plan and the Pension Trust entered into a lease agreement for office space with the IBEW Local 551 Building Corporation (the "Corporation") commencing August 1, 2021 and ending July 31, 2022 for \$1,620 per month. Effective August 1, 2022, the lease is month to month. The Plan paid \$14,580 in rent to the Corporation during the years ended December 31, 2024 and 2023.

During the years ended December 31, 2024 and 2023, the Plan paid \$2,160 and \$4,584, respectively, to two trustees as lost wage reimbursements to attend the board meetings.

NOTE 5 - INVESTMENT VALUATION AND INCOME RECOGNITION

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Level 1 investments consist of mutual funds and a short-term investment fund, recorded at fair value based on quoted market prices. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - MULTIEMPLOYER PENSION PLAN

The Plan contributes to one multiemployer defined benefit pension plan under the terms of participation agreement that covers its union-represented employees. Contributions to this multiemployer plan is based on employee hours worked and rates from contractual agreements. The risks of participating in this multiemployer plan is different from single-employer plans in the following respects:

- Assets contributed to a multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to a multiemployer plan, the unfunded obligation of the multiemployer plan may be borne by the remaining participating employers.
- If the Plan chooses to stop participating in any of its multiemployer plans, the Plan may be required to pay those multiemployer defined benefit pension plans an amount based on the underfunded status of the multiemployer plans, referred to as a withdrawal liability.
