## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Briad Affiliated Companies 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## Notes to Financial Statements

---

### *(1) Description of the Plan*

The following description of the Briad Affiliated Companies 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all employees of the following related companies (collectively the "Companies") who have attained three months of service and are age twenty-one or older:

Briad Management Services, LLC  
Briad Construction Services, L.L.C.  
Briad Hospitality Management, L.L.C.  
Briad Wenco, L.L.C.  
Briad Wenchest, LLC  
Briad Wenswick, LLC

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Companies may make a discretionary match as a uniform percentage of Matched Employee Contributions by Employer and/or Participant group. Amounts deferred over 5% are not matched. For the year ended December 31, 2024, there were no employer discretionary contributions.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, Company matching contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Elections** - Participant contributions and the Companies matching contributions are allocated to the various investment options offered by the Plan as the participant directs.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of the Companies' matching contribution portion plus actual earnings thereon is based on years of continuous service. Participants earn a year of service for vesting if they are credited with 1,000 hours of service during a plan year. A participant is fully vested after five years of credited service.

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$1,000 and a maximum amount equal to 50% of a participant's vested account balance, but not more than \$50,000, reduced by the participant's highest loan balance, if any, during the preceding 12 months. The interest rate on the note is based on a prime lending rate, plus 1.5%, as charged by the current commercial bank of the employer as of the date of the loan. This rate is fixed for the life of the note. Notes are secured by the participant's account. Principal and interest are paid ratably through monthly payroll deductions.

#### *(1) Description of the Plan (Continued)*

**Payment of Benefits** - Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as described in the Plan provisions. Additionally, the Plan allows for withdrawals of vested amounts prior to termination provided certain criteria are met.

**Forfeitures** - Upon termination of employment, participants forfeit their unvested balances. Forfeited balances of terminated employees' nonvested accounts can be used to reduce future matching contributions of the Companies or to pay administrative expenses of the Plan, as determined by the Companies at their sole discretion. There were no allocated forfeitures at December 31, 2024 or 2023.

#### *(2) Summary of Significant Accounting Policies*

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.

**Adoption of New Accounting Standard** - The Plan previously adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that are subject to the guidance in ASC 326 are employers' contributions receivable and notes receivable from participants. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

**Use of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the guaranteed income fund which is a fully benefit-responsive investment contract reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *(2) Summary of Significant Accounting Policies (Continued)*

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. For the year ended December 31, 2024, the Plan recorded \$114,535 of certain deemed distributions of participant loans.

**Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. Total administrative expenses was \$113,576 which included \$25,444 to Empower for management fees for the year ended December 31, 2024.

**Subsequent Events** - The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

### *(3) Information Certified and Provided by Empower Trust Company LLC (Unaudited)*

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodian and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that information provided to the plan administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Notes 4, 5, and the supplemental schedule which appears throughout the financial statements and supplemental schedule related to the following assets:

Empower Trust Company, LLC certified to the completeness and accuracy of \$817,459 of net appreciation in fair value of investments and \$586,027 of interest and dividends, and interest income on notes receivable from participants of \$16,910 for the year ended December 31, 2024.

### *(4) Fair Value Measurements*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodology used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

#### *(5) Group Annuity Contract with Prudential Insurance Company*

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company ("PRIAC") Guaranteed Income Fund (the "Fund") totaling \$1,334,437 and \$1,713,164 as of December 31, 2024 and 2023, respectively. The Fund maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50%. The crediting rate is reviewed on a bi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Fund, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

***(6) Related-Party and Party-in-Interest Transactions***

Certain Plan investments are managed by the Empower Trust Company ("Empower"). Empower is the trustee and custodian of the plan assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Empower also provides certain administrative services to the Plan pursuant to a contractual agreement between the Company and Empower. The contractual agreement provides for administrative expense reimbursements from certain revenue sharing transactions. During the year ended December 31, 2024, the Plan received \$25,994 of administrative expense reimbursements.

***(7) Excess Contributions Payable***

The Plan failed to pass the Actual Deferral Percentage (ADP) test in the 2024 and 2023 plan years, as certain participants exceeded the contribution limits of Internal Revenue Code Section 415. Excess contributions amounting to \$79,885 and \$35,654 at December 31, 2024 and 2023, respectively, are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits and as a reduction of participant contributions for the years then ended.

***(8) Plan Termination***

Although they have not expressed any intent to do so, the Companies have the right under the Plan agreement, subject to the provisions of ERISA, to discontinue their contributions, amend or modify the Plan at any time. In the event of the plan termination, all participants will become 100 percent vested in their employer's contributions.

***(9) Tax Status***

The IRS has determined and informed the Plan by a letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although, the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***(10) Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
