Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SSFM International, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the SSFM International, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan covering substantially all employees of SSFM International, Inc. (Company). The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) **Participation** - Employees become eligible upon attaining age 21 and completing the earlier of 6 months of service with a minimum of 83 hours of service in each month or completion of one year of service, with one thousand hours or more of service during the year.
- (3) **Contributions** - Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, not to exceed the maximum amount allowable for federal income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective March 1, 2024, the Plan has an auto-enrollment provision (3% salary deferral) whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

The Company may make discretionary contributions to all eligible employees whether or not they made elective contributions during the plan year. To be eligible for the discretionary contributions, participants must be employed by the Company at the end of the plan year and must have worked at least 1,000 hours during the plan year unless terminated due to death, disability, or normal retirement. The Company approved \$1,250,000 and \$1,000,000 in discretionary contributions in 2024 and 2023, respectively.

- (4) **Participant accounts** - Each participant's account is credited with the participant's contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (5) **Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant becomes fully vested after completing six years of service or in the event of death or disability.

- (6) **Notes receivable from participants** - Participants may borrow from their fund accounts up to a maximum not to exceed the lesser of \$50,000 (reduced by the highest outstanding loan balance during the one-year period prior to the date of the loan) or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest. The rate of interest shall be comparable to the prevailing interest rate being charged on the date of the loan by area institutional lenders for similar loans. Principal and interest must be fully paid through payroll deductions within five years unless the notes are used for the purchase of the participants' primary residence. Notes receivable from participants as of December 31, 2024 bear interest rates of 4.50% to 10.14% and mature from August 2025 to November 2029.
- (7) **Payment of benefits** - Upon termination of service due to death, permanent disability, retirement, or other termination of employment with the Company, the participant is entitled to a lump-sum distribution. In addition, hardship distributions are permitted if certain criteria are met.
- (8) **Forfeited accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$121,077 and \$93,287, respectively. These accounts will be used first to pay plan expenses. Any remaining forfeitures are added to the Company contributions. During 2024 and 2023, non-vested forfeited accounts of \$93,287 and \$35,175 were added to employer contributions.
- (9) **Plan termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in Company contributions.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

- (1) **Basis of accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (U.S. GAAP).
- (2) **Use of estimates** - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES (Continued)

- (3) **Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.
- (4) **Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan agreement.
- (5) **Excess contributions payable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The excess contributions as of December 31, 2023 were distributed by the Plan to the applicable participants in March 2024 and May 2024.
- (6) **Payment of benefits** - Benefits are recorded when paid.
- (7) **Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the payment of benefits are charged directly to the participant's accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.
- (8) **Subsequent events** - Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

NOTE C - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (John Hancock), a qualified institution.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: These investments are valued using the net asset value (NAV) of units held by the Plan at year end as provided by John Hancock. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that John Hancock will sell the investments for amounts different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Pooled separate accounts held by the Plan totaled \$34,818,368 and \$29,334,418, at December 31, 2024 and 2023, respectively. Pooled separate accounts represent investments at fair value as presented on the accompanying statements of net assets available for benefits.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

John Hancock is the custodian of the Plan assets, SI Group Certified Pension Consultants (SI Group) provides third party administrative services, and Wilshire Associates Inc. (Wilshire) provides investment advisory services. These transactions qualify as party-in-interest transactions. Administrative fees paid to John Hancock for the years ended December 31, 2024 and 2023 amounted to \$121,558 and \$77,503, respectively. Administrative fees paid to SI Group amounted to \$1,200 for each of the years ended December 31, 2024 and 2023. Investment advisory fees paid to Wilshire amounted to \$16,408 and \$9,426 for the years ended December 31, 2024 and 2023, respectively. The Company also provides certain administrative services for the Plan for which it receives no compensation.

NOTE F - TAX STATUS

Effective January 1, 2022, the Plan was restated on a Carlsmith Ball LLP Non-Standardized Pre-Approved Profit Sharing Plan With CODA. Carlsmith Ball LLP received a favorable opinion letter from the IRS dated June 30, 2020, specifying the form of the plan is acceptable under Internal Revenue Code (IRC) Section 401. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
